I represent the New Prague Utilities Commission (the "Municipal"), which is authorized, on behalf of the Municipal and Minnesota Valley Electric Cooperative (the "Cooperative") (collectively, the "Parties") to make this joint filing.

# Summary of the Joint Request

This filing constitutes the Parties' joint request under Minn. Stat. § 216B.39, subd. 3, that the MPUC modify the Parties' service territory boundaries. This joint request concerns the transfer of certain areas located within the city limits and within the electric service territory assigned to the Cooperative (the "Affected Areas"), as further described below.

# **Legal Authorities**

By statute, "the commission may on its own or at the request of an electric utility make changes in the boundaries of the assigned service areas, but only after notice and hearing . . . " Minn. Stat. § 216B.39, subd. 3. In addition, "no electric utility shall render or extend electric service at retail within the assigned service area of another electric utility unless the electric utility consents thereto in writing . . . " Minn. Stat. § 216B.40

(2018). In the present case, the Parties seek to adjust the service territory boundaries to permanently transfer the Affected Areas to the Municipal's assigned service territory. The Parties have agreed upon appropriate compensation. The Parties request that the Commission update its official records as to electric service territory boundaries.

# **Underlying Information**

1. <u>Exhibit A: Affected Areas.</u> Attached as Exhibit A is a map that depicts the boundaries of the Affected Areas. The Affected Areas are depicted in light blue, with the existing service territory of the Municipal in pink. All Affected Areas are within the city limits (designated as the red border on the map). The Affected Areas involve approximately 700 acres and 750 customers (711 residential and 39 commercial).

The Parties do not have a separate legal description prepared of the Affected Areas, but are willing to provide whatever information is helpful and reasonably requested by MnGeo to facilitate the adjustment in the official maps. Specifically, the Parties have a Shape file of the map attached as Exhibit A.

By written agreement of the Parties, the Municipal provided construction service to one senior living development within the Affected Areas (1100 1st Street SE, New Prague, Minnesota, and with a legal description of Lot 3, Block 2, Prague Estates 1st Addition) and is currently serving this customer.

# **Customer Notice**

The Parties engaged in extensive technical discussions, spanning multiple years, to minimize any disruption to customers, to avoid unnecessary duplication of facilities, and to ensure a smooth transition of electric service.

The Parties mutually determined the optimal transition time of late October or early November of 2018. The Parties have communicated extensively with the customers in the Affected Areas. A sample of the pertinent correspondence is attached as <a href="Exhibit B.">Exhibit B.</a>. In addition, multiple updates were provided in newsletters and a dedicated public meeting was held to answer questions and to assure understanding of rates and programs.

The Parties acknowledge that the Commission wishes to direct separate notice to customers as to the pending proceeding before the Commission. Attached as <u>Exhibit</u> <u>C</u> is a proposed notice to be sent to all customers in the Affected Areas.

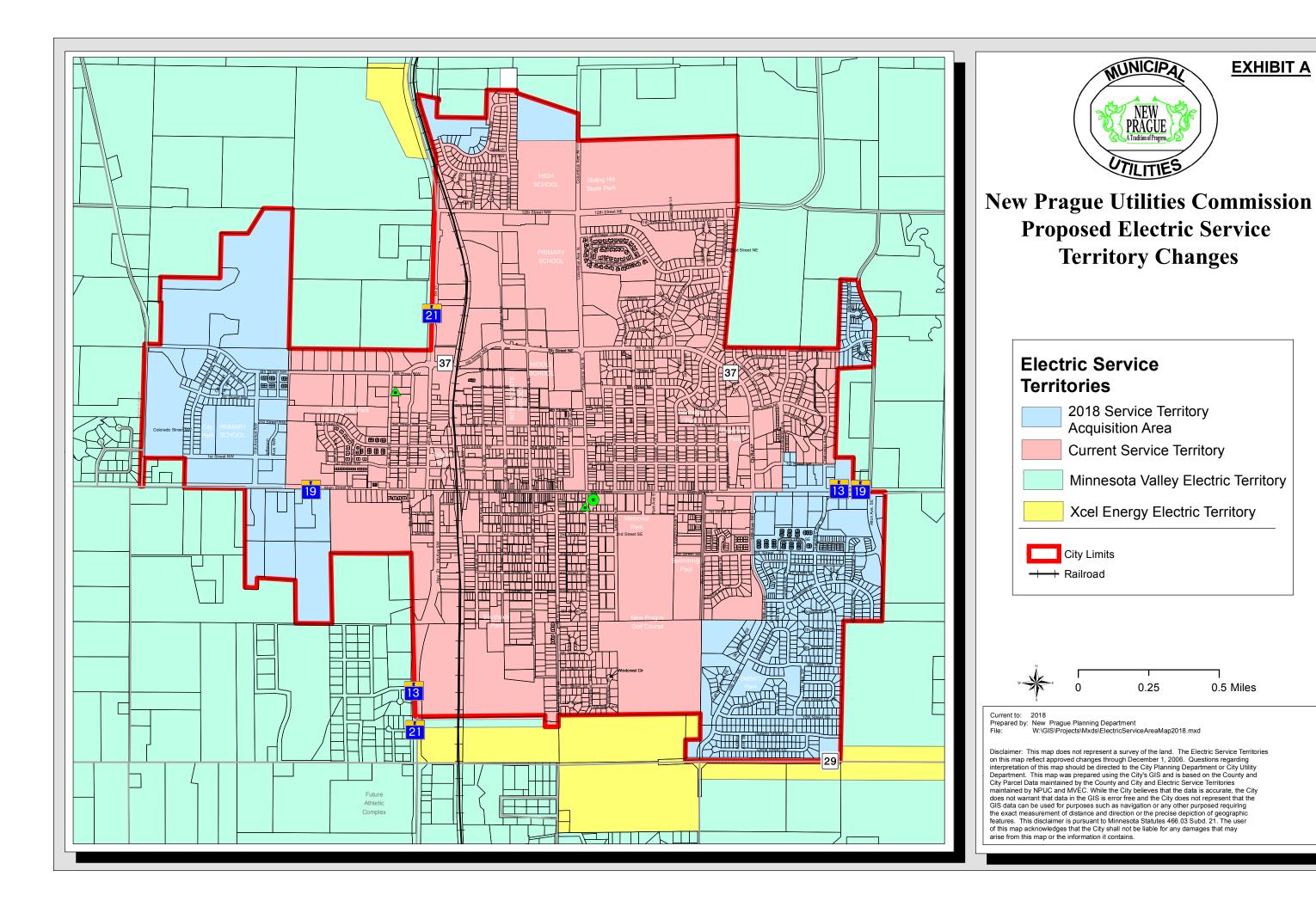

Dear Resident,

This year, New Prague Utilities Commission (NPUC) will be expanding its service territory to include customers within the city limits, acquiring approximately 750 Minnesota Valley Electric Cooperative electricity customers. The properties to be transferred are highlighted in blue on the attached map.

Customers being transferred to NPUC can expect the same excellent service they have received in the past, and the same (if not lower) billing rates. Those transferred will also be able to retain their same energy saving programs with off-peak heating and cooling. The NPUC works hard in providing highly-reliable service, including 19 megawatts of local generation for emergency and storm related conditions, virtually eliminating extended outages due to weather or regional transmission outages.

The NPUC has been working cooperatively with MVEC over the past two years to reach a fair agreement that compensates MVEC for its investment in utility infrastructure, while ensuring all city homes and businesses can have a common electric platform. Once finalized, this agreement must be approved by both the NPUC and MVEC Board. Residents will be notified with a letter when existing MVEC customers are officially converted to the NPUC distribution system, which will occur sometime this year.

We respect the quality of service MVEC has provided to its customers in the past and pledge to meet and continue with those same services going forward. We appreciate the neighborly approach MVEC has taken in working with us on drafting an agreement that is beneficial and fair to all.

# Utility Service Territory Expansion Frequently Asked Questions

# Q: Why does NPUC want to acquire the MVEC service territory?

A: New Prague's electric utilities were designed to serve the growing areas of our city and provide backup generation for all residents and businesses. A coordinated electric utility service to serve these needs will be more cost-effective and reduce overall cost to New Prague residents in the future. In addition, New Prague already provides water and sewer utility services to these customers, so adding electric service would put them on the same utility platform as all other city residents and businesses.

# Q: How many MVEC customers will be impacted?

A: Approximately 750 residential and commercial customers

# Q: Where are these MVEC customers located?

A: They are located in growing areas of the city, primarily in the southeast and western parts of the city. Please see the attached service territory map – the impacted areas are in blue.

# Q: Why would MVEC agree to give up customers?

A: Under Minnesota state law, municipal utilities have the right to grow with their cities. In return, they must work with the current electric cooperative or investor-owned utility to fairly compensate the utility for the service territory and electric utility infrastructure that is in place.

# O: If I'm an existing MVEC customer, will this cause my rates to go up?

A: No. We anticipate a slight decrease in rates for the customers moving to NPUC. It is NPUC's goal to offer the same energy saving programs at similar rates that are available to current MVEC customers. NPUC customers are also able to receive rebates on energy-efficient appliances, heating and cooling equipment, and LED lighting.

# Q: What other changes will existing MVEC customers experience?

A: Customers should expect the same quality service they received in the past to continue with NPUC. New customers will receive reliable local service from crews that exclusively serve New Prague residents, the convenience of having local offices, and one unified bill that covers all city services. NPUC's 19 megawatts of local generation is also highly reliable under emergency and storm situations, virtually eliminating extended outages due to weather or regional transmission outages.

# Q: How will this be funded?

A: We expect to fund the service territory acquisition through current and anticipated financial reserves.

# Q: What is the process to complete the service territory acquisition?

A: NPUC and MVEC have prepared a ten-year service territory agreement that lays out the terms of the transfer. Impacted customers will be receiving additional information in the mail from the NPUC relating to the proposed transfer of service. In addition, the NPUC will be holding an open house at a later date to answer any questions residents have related to the transfer.

Once customers have been informed of the proposed transfer, the NPUC and the Board of MVEC must vote to approve the transfer. We anticipate these votes will take place in the near future. If approved, the parties will work together to complete the transfer as quickly as possible.

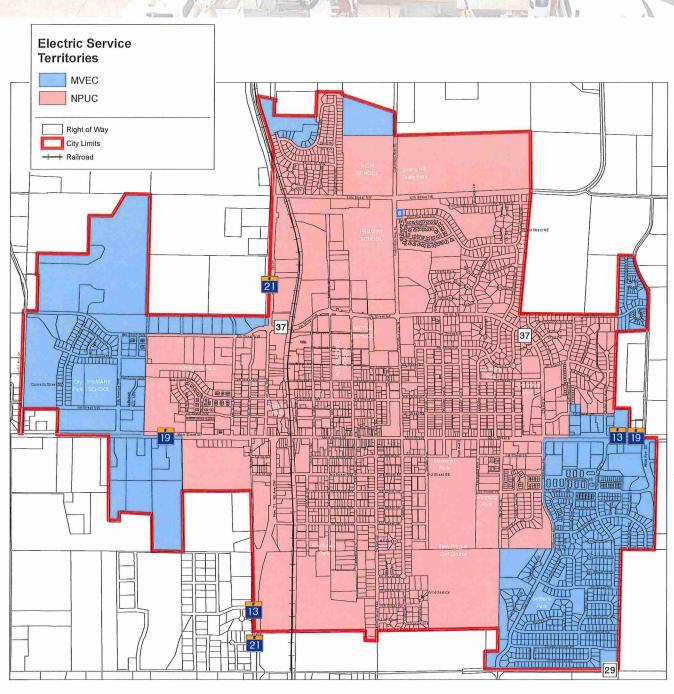
We anticipate this process and the construction required will take approximately six to eight months after the transfer is approved to convert existing MVEC customers to the NPUC distribution system.

## Dear MVEC member-owners,

This letter is to inform you of a potential future change in your electric provider. New Prague Utilities Commission (NPUC) is interested in purchasing the service area (members and equipment) of Minnesota Valley Electric Cooperative (MVEC) that is within the New Prague City limits. This would impact around 750 current members by making NPUC your new provider of electric service.

As an MVEC member, you deserve to know about these discussions and the potential transaction. To date, the purchase has not been approved by either MVEC or NPUC. Both utilities continue to work on an agreement, which could be finalized yet this spring.

It's important for you to know that MVEC's Board of Directors did not propose selling our service area to NPUC. According to state law, municipal utilities can acquire another utility's service area, within its city limits, upon payment of appropriate compensation.

MVEC and NPUC have worked amicably to determine a purchase price that would be financially reasonable to both parties. This would result in NPUC paying MVEC for its current infrastructure and additional monies over the next ten years to compensate the cooperative for lost revenues, from both current and future members.

Both utilities are currently working through the fine details in order to reach an agreement. More detailed information will be provided once the deal is finalized. At this time, we wanted to inform you about how this will impact your electric service.

- 1. After the acquisition is finalized, your electricity will be provided by NPUC.
- 2. Your electric rates will change to NPUC's electric rates and your monthly bill will come directly from NPUC.
- 3. You will contact NPUC for billing questions, outage reporting, and program offerings.

Although NPUC plans to offer similar programs, the following MVEC specific programs/services will no longer be available:

- 1. Energy Wise programs providing a reduced rate or billing discount
  - a. Cooling (air source/ground source or central air conditioning)
  - b. Electric Water Heating
  - c. Electric resistive heating (garage heater, baseboard, plenum, boiler, etc.)
  - d. WiFi Thermostats
  - e. Electric vehicles
  - f. Business onsite generator programs
- 2. Beat the Peak Energy Challenge
- 3. Operation Round Up
- 4. SmartHub online and app services (viewing data usage, making free online payments)
- 5. Co-op Connections Card
- 6. While Capital Credits will be paid to past members over time, accumulation of Capital Credit earnings will end
- 7. High school Scholarship and Youth Tour program eligibility

Again, we want to be clear that MVEC's Board of Directors did not propose selling our service area to NPUC. According to state law, municipal utilities can acquire another utility's service area, within its city limits, upon payment of appropriate compensation. Given this, the cooperative's goal is to make any transition as smooth as possible for our member-owners.

The NPUC fully understands the great service MVEC has provided to its customers in the past and pledges to meet and continue with the same high standards going forward. NPUC will continue to work hard to make this transition as smooth as possible for its new customers in the coming months. Please look for a detailed mailed letter from the NPUC for more information on the transition within the next few days.
