RESPONSIVE COMMENTS OF THE MINNESOTA DEPARTMENT OF COMMERCE

DOCKET NOS. P407/AM-14-603 & P405/AM-14-604

I. BACKGROUND

On July 16, 2014 Citizens and Frontier filed tariff pages to introduce Frontier Emergency Connect Service. In the filing, Citizens stated that "[t]his service is not included in the list of services defined as "price regulated" in Minn. Stat. 237.761, nor does it provide access to the local telephone network, therefore, it is being tariffed under flexibly priced services."

On August 12, 2014, the Department filed comments objecting to the classification of the new service as a flexibly priced service, and asked the Commission to determine the appropriate classification based on the statutes governing the classification and definition of a price regulated service.

On August 13, 2014, Citizens and Frontier filed joint reply comments² (Reply) to the Department's objections (Reply).

II. INTERPRETATION OF THE STATUTORY DEFINITION AND LIST OF PRICE-REGULATED SERVICES

Frontier argues that Frontier Emergency Connect Service does not meet the three conditions in Minn. Stat. 237.761, subd. 2. Further, because Minn. Stat. 237.761, subd. 2 have three conditions which are conjoined by an "and," it is necessary for all three conditions to be met in order for the Commission to classify Frontier Emergency Connect Service as a price regulated service.³

With respect to "Specific price-regulated services," as listed in the Minn. Stat. 237.761, subd. 3, Frontier argues that number (8), "911 emergency services" does not apply to Frontier Emergency Connect Service because "Frontier understands this item to relate to the trunking, routing, database, and other services provided to the entities operating the 911 network."

The Department disagrees with Frontier. A deeper analysis of Minn. Stat. 237.761, subd. 2, and whether Frontier Emergency Connect Service is a price regulated service by meeting the three statutory conditions is not necessary given that Minn. Stat. 237.761, subd. 3, (8) specifically lists "911 emergency services" as price regulated services. Frontier states that Frontier Emergency Connect service provides only two capabilities to customers: calling 911 and calling Frontier's call center. Access to 911 emergency services is the primary functionality of the service. While it is true that Frontier could have chosen to not provide this offering, which may suggest that the service could be classified as flexibly priced, the statue seems clears. The statute does not include any restrictions as interpreted by Frontier, that the price regulated service listed in Minn. Stat. 237.761, subd. 3, (8) means only trunking, routing, databases, and other services provided to the entities operating the 911 network. "911 emergency services" to retail customers are critical to customer safety and are appropriately recognized as being price regulated services.

Finally, Frontier states that if you follow the Department's logic, any bundled service that provides access to 911 would by definition be a price-regulated service. Such bundled services are currently classified as flexibly priced. Whether or not all of Frontier's services, particularly bundled service that included access to 911 calling, are appropriately classified is not something the Department has attempted to do in the proceeding. The only decision before the Commission is whether Frontier Emergency Connect service is considered "911 emergency services" under the statute.

III. COMMISSION ALTERNATIVES

- A. Find that Emergency Connect Service is a price regulated service.
- B. Find that Emergency Connect Service is a flexibly priced service.
- C. Take other action that the Commission deems appropriate.
