MOTION TO ALLOW SUPPLEMENTAL WRITTEN COMMENTS OR IN THE ALTERNATIVE MOTION TO STRIKE

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission (Commission) this Motion to allow supplemental written comments, or in the alternative, a Motion to strike the March 27, 2025 Reply Comments of SunShare. Pursuant to Minn. R. 7829.0410, any opposition to this Motion must be filed and served on the service list in this docket within 14 days of this Motion filing, meaning any opposition must be filed on or before April 16, 2025.

The Company understands that motions to strike are not common in Commission proceedings, and that the Commission from time to time accepts late-filed documents. But given the situation here, the Company believes that this Motion is justified. As we discuss in this Motion, SunShare's late-filed Reply Comments are akin to a new Complaint that is significantly expanded from the initial Complaint, containing numerous new allegations and several new requests for relief.

Xcel Energy is respectfully requesting an opportunity to respond to SunShare's Reply Comments in writing by filing Supplemental Comments ahead of the Commission conducting a hearing on the substance of the January 23, 2025 Amended Notice. In the event this requested relief is not granted, the Company requests the Commission to strike SunShare's late-filed Reply Comments, which it is authorized to do pursuant to Minn. R. 7829.0420.

A. Background

SunShare filed a short, just over two-page Complaint in this proceeding on December 31, 2024. On January 23, 2025, the Commission issued an Amended Notice of Comment Period, with Initial comments due February 10, 2025 and the Reply comments due February 20, 2025.

Xcel Energy filed detailed Initial Comments on February 10, 2025, pointing out that the Complaint did not allege any specific violation of state law or the Minnesota Distributed Energy Resources Interconnection Process (MN DIP). No Reply Comments were filed on or before the February 20, 2025 Reply Comments deadline.

On March 27, 2025, SunShare late-filed extensive Reply Comments with attachments totaling 90 pages. Instead of responding to Xcel Energy's Initial Comments, SunShare's Reply Comments are akin to a new Complaint that is significantly expanded from the initial Complaint, containing numerous new allegations and several new requests for relief. The Commission did not grant permission to SunShare to file a new or amended complaint. With no further procedure established by the Commission, the timing of SunShare's filing denies Xcel Energy the ability to respond to what are nearly all new arguments.

B. Xcel Energy Request

This Motion respectfully requests the Commission to provide Xcel Energy an opportunity to respond to SunShare's Reply Comments in writing by filing Supplemental Comments ahead of the Commission conducting a hearing on the substance of the January 23, 2025 Amended Notice. Similar to the standard timeframe to comment on new complaints, the Company requests that it be given 28 days from Commission action on this Motion to file Supplemental Comments.

In the event that this requested relief is not granted, the Company requests that the Commission strike SunShare's late-filed Reply Comments that were filed 35 days after the due date. Pursuant to Minn. R. 7829.0420, the Commission is authorized to grant this Motion to exclude a filing from the record. This Rule states in part as follows:

7829.0420 UNTIMELY FILINGS.

Subpart 1. When filings may be excluded.

On its own motion or at the request of any party or participant, the commission may exclude a filing from the record:

A. when the filing was not made within a time period established by rule, notice, or commission order; and

B. upon a commission determination that the value of the document to the commission's deliberative process is outweighed by prejudice to a party, participant, or the public interest caused by the untimeliness.

Documents in the agencies' electronic filing system excluded under this part shall remain in the agencies' electronic filing system, but shall be marked as "excluded from record by commission order" in search results.

Subp. 2. Required statement.

A person filing a document outside a time period established by rule, notice, order, or statute shall clearly mark the document as "late filed" and include a statement explaining why the filing was untimely and why it should not be excluded by the commission.

Without leave given by the Commission for an extension of time, SunShare late-filed its Reply Comments on March 27, 2025. Additionally, SunShare did not include on its filing the required marking under Minn. R. 7829.0420, Subp. 2, that its filing was "late filed." Setting aside these procedural errors, SunShare's filing circumvents due process considerations that must allow the Company the opportunity to respond in writing to significantly expanded claims.

C. SunShare's Reply is Essentially a New Complaint

SunShare's initial Complaint included only these allegations: Xcel Energy has not made sufficient efforts to implement the Settlement Agreement because it delayed and modified the process by sending eight SunShare projects to the Midcontinent Independent System Operator (MISO) transmission study screening, although this was not disclosed in the settlement negotiations, SunShare was not aware of the MISO process, and no previous SunShare projects had needed MISO transmission review.

The only relief requested was that Xcel Energy issue conditional interconnection agreements and that the Department of Commerce reserve capacity in the 2024 or 2025 program year for these projects in the Low- and Moderate Income (LMI) Accessible Community Solar Garden Program.

SunShare's Reply Comments, however, include, and predominantly allege, many new violations of state law, Commission Orders, or the MN DIP process that were not specified or included in the Complaint. For example, the Reply Comments allege the following:

• The MISO Affected System Impact Study (ASIS) Agreement that was not approved by the Commission later became the MISO Distributed Energy Resources Affected System Study (DER AFS) process and therefore the

- Commission's prior Order regarding the MISO ASIS Agreement should also apply to the MISO DER AFS,
- The Company violated MN DIP timelines and communicated inconsistently about MISO payment deadlines,
- The Amendment to the Transmission SIS Agreement violates the MN DIP and was not approved by the Commission, and
- MISO instructed the Commission and utilities to harmonize the DER AFS process with the MN DIP and Xcel Energy did not take any action on this.

In addition, SunShare's Reply Comments are seeking relief that was not included in the Complaint. SunShare is now asking that the Commission also stay Xcel Energy's implementation of MISO's DER AFS transmission studies.

In effect, SunShare's Reply Comments are akin to a significantly expanded new Complaint. Based on the comment period structure established to address SunShare's initial Complaint, there is no opportunity for Xcel Energy to respond in writing to SunShare's new allegations and arguments. We believe SunShare's approach here conflicts with the intent of the complaint procedure and circumvents due process considerations.

The purpose of providing written comments prior to a Commission hearing is that parties have an opportunity to state their positions, arguments, and understanding of facts. In addition, based on this written record, each Commissioner can give thoughtful consideration to the points raised by the parties ahead of the hearing and prepare questions for the hearing. If SunShare's approach in this case is not addressed, this could encourage parties to submit scant initial allegations in complaints and only later provide the substance of their arguments in the final round of comments, to which other parties cannot respond in writing.

We believe the requirements for excluding SunShare's entire Reply Comments are met, because the value to the Commission's deliberative process, if it were to include all these new points, would be outweighed by prejudice to a party, or the public interest caused by the untimeliness. Not striking the Reply Comments would prevent Xcel Energy from setting forth its positions in writing ahead of the Commission hearing on the many new issues raised in the Reply Comments.

CONCLUSION

Xcel Energy respectfully requests the Commission allow the Company to file Supplemental Comments and that the Company be given 28 days from the Commission action on this Motion to file these Supplemental Comments. The Company further requests that the Commission not conduct a hearing on the substance of the topics in the January 23, 2025 Amended Notice of Comment Period until after the Company has filed the Supplemental Comments. In the alternative, if this relief is not granted, then the Company requests that the Commission strike the entirety of the SunShare late-filed Reply Comments and exclude them from the record in this docket consistent with Minn. R. 7829.0420.
