Midwater BESS, LLC (Midwater BESS) respectfully submits these comments in response to the written public comments submitted by the Shell Rock Township Board and Freeborn County Board of Commissioners (the Township and County, respectively) during the public comment period ending April 21, 2025.

The Minnesota Public Utilities Commission (Commission) issued a Notice of Public Information and Scoping Meetings on February 7, 2025, and subsequently issued a Notice of Additional Public Information and Environmental Assessment (EA) Scoping Meeting and Extension of Comment Period (Notice) on March 24, 2025. Public information and EA scoping meetings were held on February 19–20 and April 7, 2025. The Notice requested comments on: (1) what potential human and environmental impacts should be studied in the EA for the Project; (2) whether any methods to minimize, mitigate, or avoid these impacts should be studied in the EA; and (3) whether any unique characteristics of the Project should be considered in the EA.

Following the Additional Public Information and EA Scoping Meeting on April 7, 2025, the Township adopted a resolution opposing the "establishment of the BESS system in Shell Rock

Township." The County adopted a similar resolution on April 15, 2025. The Shell Rock Township Resolution and the Freeborn County Resolution (together, the Resolutions) include several findings claiming the Project will cause human and environmental impacts, which have not yet been assessed and are not supported in the record of these dockets. The impact claims made in the Resolutions generally align with primary concerns raised during the public information and EA scoping meetings, and during the written comment period.

The Resolutions' claims of environmental impacts are untimely and pre-judge the potential Project impacts before the EA is prepared. The purpose of the environmental scoping meeting was to gather concerns about the Project so that the scope of the EA includes those items for future study. Midwater BESS anticipates that the concerns raised by the Township, County and the general public will be more fully developed in the record as the permitting process moves forward, and will be properly investigated and assessed by the Department of Commerce Energy, Environmental Review, and Analysis unit (DOC-EERA) during its preparation of an EA for the Project. The EA will use facts, studies and research to detail potential human and environmental impacts, as well as potential mitigating measures that can be used to address those potential impacts. Accordingly, Midwater BESS respectfully disagrees with the Resolutions opposing development of the Project and encourages the Township, County, and the public to review the EA when it is complete to determine whether their concerns are valid.

Midwater BESS remains committed to continued engagement with the Township, County, landowners, and stakeholders during the regulatory review process to try and answer their questions and address their concerns, to the extent practicable. Since filing the Joint Site Permit and Route Permit Application for the Project in November 2024, Midwater BESS has continued efforts to maintain engagement through e-mail, phone calls, and in-person meetings with numerous stakeholders including the following: Albert Lea Economic Development Agency; the City of Albert Lea, Freeborn County Zoning and Planning Administrator; Freeborn County Board of Commissioners; Freeborn County EMS Director; Freeborn County Sheriff; Glenville Fire Chief; landowners; and other interested stakeholders. A summary of the meetings with local agencies and administrative offices since submission of the Joint Application is provided below:
