Lemon Hill Solar, LLC (Lemon Hill Solar), submits these supplemental comments pursuant to the Notice of Comment Period issued by the Minnesota Public Utilities Commission (Commission or PUC) on July 9, 2025¹ regarding the completeness of Lemon Hill Solar's Application for a Site Permit (Application) for an up to 180 megawatt (MW) alternating current photovoltaic solar energy generating facility and associated facilities known as the Lemon Hill Solar Project in Haverhill and Viola Townships in Olmsted County, Minnesota (Project) in the above-captioned docket.

As mentioned in Lemon Hill Solar's reply comments,² Lemon Hill Solar is now providing documentation in response to Commission Energy Infrastructure Permitting Staff's requests related to the Phase 1 Cultural Resource Survey in **Attachment A**. Lemon Hill Solar is also providing the updated Wetland and Waterbody Delineation Report in **Attachment B**.

In accordance with Minnesota Rules, part 7829.0500, and Minnesota Statutes Chapter 13, Lemon Hill Solar has designated portions of **Attachment A** as **NONPUBLIC DATA–NOT FOR PUBLIC DISCLOSURE** because it contains sensitive cultural resource. The Minnesota State Historic Preservation Office Manual for Archaeological Projects in Minnesota provides for restricted access to sensitive cultural resource information. Given the need to include nonpublic information, Lemon Hill Solar has prepared and is electronically filing both **NONPUBLIC** and public versions of **Attachment A**.
