Notice of Otter Tail Power Company's Site Permit Application Filing with the Minnesota Public Utilities Commission MPUC Docket No. E017/GS-24-309

October 11, 2024

To: Persons Interested in the Proposed Construction of an up to 66 megawatt photovoltaic alternating current solar energy generating facility and associated facilities known as the Solway Solar Project in Beltrami County, Minnesota; the Minnesota Public Utilities Commission Energy Facilities General List; Local Officials; Tribes; and Property Owners

Otter Tail Power Company (Otter Tail), an investor-owned electric utility that provides electricity and energy services in Minnesota, North Dakota, and South Dakota, is proposing to construct and operate an up to 66 megawatt photovoltaic alternating current solar energy generating facility and associated facilities known as the Solway Solar Project in Beltrami County, Minnesota (the Solway Solar Project, or the Project).

This notice provides formal notice that, on October 11, 2024, Otter Tail filed an Application for a Site Permit (Application) with the Minnesota Public Utilities Commission (Commission) for the Project (MPUC Docket No. E017/GS-24-309) pursuant to the alternative permitting process contained in Minn. Stat. § 216E.04 and Minn. R. parts 7850.2800 to 7850.3900. This notice also provides information on the Project and the permitting process, as well as information on how to register your name with the Commission on the Project contact list to ensure that you receive future notices.

PROJECT LOCATION AND DESCRIPTION

The Project is located just north of the City of Solway in Lammers Township in Beltrami County, Minnesota. The Project is approximately 487 acres in size, 267 acres of which are currently designated to host Project components and for operation and maintenance of the Project. The Project will interconnect at the Solway Combustion Turbine Generating Station and utilize Otter Tail's existing interconnection rights, through a surplus interconnection, which will have an interconnection limitation of 50 MW. Connecting the Project at this point of interconnection will require an additional transformer and less than 500 feet of overhead transmission line. Otter Tail plans to construct the Project on a schedule that facilitates an in-service date by the end of 2026.

The Project will include: solar modules and tracking racking systems; inverters; an electrical collection system; a Project substation and interconnection facilities; gravel access roads; perimeter fencing and gates; an operations and maintenance building; weather stations; stormwater drainage basins; temporary facilities such as laydown areas, temporary site offices, parking, and improvements for storage and staging of equipment prior to installation as needed.

The accompanying map outlines the location of the Project.

PROPERTY ACQUISITION

Otter Tail owns 100 percent of the land necessary to construct the Project. Accordingly, Otter Tail's current and future plans do not include the use of eminent domain. If additional property rights are required for the Project, Otter Tail will seek to negotiate an agreement with each affected landowner.

SITE PERMIT PROCESS

A Site Permit from the Commission is required before the Project can be constructed. The Power Plant Siting Act (Minn. Stat. ch. 216E) and Minn. R. parts 7850.1000 to 7850.5600 establish the requirements for submitting and processing a Site Permit application. The statutes and rules also establish notice requirements for various stages of the process. The Application will be considered by the Commission under the alternative permitting process in Minn. Stat. § 216E.04 and Minn. R. parts 7850.2800 to 7850.3900. The Commission has up to six months from the time the application is accepted as complete to process and make a decision on the Site Permit according to Minn. Stat. § 216E.04, subd. 7, and Minn. R. 7850.3900, subp. 1. The Commission may extend this time limit for up to three months for just cause or upon agreement of the applicant.

Within 60 days after the Commission accepts the application as complete, the Commission and the Department of Commerce, Energy Environmental Review and Analysis (EERA) unit will hold a public information and scoping meeting to provide information and seek comments from the public. At this meeting, members of the public may comment on the scope of the environmental assessment and/or propose additional issues for consideration in the environmental assessment that the EERA will prepare. Once the public meeting is scheduled, notice of the meeting will be provided to persons whose names are on the Project contact list and will be published in a legal newspaper of general circulation in the Project area.

After the environmental assessment has been completed, EERA will make the document available for public review and a public hearing will be held on the Application. Any person may speak at the public hearing, present documentary evidence, ask questions of Otter Tail's representatives and EERA staff and submit comments.

Further details regarding upcoming meetings and comment periods on the application will be provided by Otter Tail, EERA, and/or the Commission in the future.

CERTIFICATE OF NEED

A Certificate of Need is not required from the Commission for the Project. The Project is exempt from Certificate of Need requirements under Minn. Stat. § 216B.2422, subd. 5, and Minn. Stat. § 216B.243, subd. 9. Otter Tail will submit a separate filing to the Commission in early November providing additional detail regarding the application of these exemptions.





Otter Tail Power Company (Otter Tail), an investor-owned electric utility that provides electricity and energy services in Minnesota, North Dakota, and South Dakota, is proposing to construct and operate an up to 66 megawatt photovoltaic alternating current solar energy generating facility and associated facilities known as the Solway Solar Project in Beltrami County, Minnesota (the Solway Solar Project, or the Project).

This notice provides formal notice that, on October 11, 2024, Otter Tail filed an Application for a Site Permit (Application) with the Minnesota Public Utilities Commission (Commission) for the Project (MPUC Docket No. E017/GS-24-309) pursuant to the alternative permitting process contained in Minn. Stat. § 216E.04 and Minn. R. parts 7850.2800 to 7850.3900. This notice also provides information on the Project and the permitting process, as well as information on how to register your name with the Commission on the Project contact list to ensure that you receive future notices.

PROJECT LOCATION AND DESCRIPTION

The Project is located just north of the City of Solway in Lammers Township in Beltrami County, Minnesota. The Project is approximately 487 acres in size, 267 acres of which are currently designated to host Project components and for operation and maintenance of the Project. The Project will interconnect at the Solway Combustion Turbine Generating Station and utilize Otter Tail's a xite Solway combasin his line deferrance station and units of the rails existing interconnection rights, through a surplus interconnection, which will have an interconnection limitation of 50 MW. Connecting the Project at this point of interconnection will require an additional transformer and less than 500 feet of overhead transmission line. Otter Tail plans to construct the Projection will require an additional transformer and less than 500 feet of overhead transmission line. Otter Tail plans to construct the Projection of the state of the s ect on a schedule that facilitates an in-service date by the end of 2026.

The Project will include: solar modules and tracking racking systems; inverters; an electrical collection system; a Project substation and interconnection facilities; gravel access roads; perimeter fencing and gates; an operations and maintenance building; weather stations; stormwater drainage basins; temporary facilities such as laydown areas, temporary site offices, parking, and improvements for storage and staging of equipment prior to installation

PROPERTY ACQUISITION

Otter Tail owns 100 percent of the land necessary to construct the Project. Accordingly, Otter Tail's current and future plans do not include the use of eminent domain. If additional property rights are required for the Project, Otter Tail will seek to negotiate an agreement with each affected landowner.

SITE PERMIT PROCESS

SITE PEHMIT PROCESS

A Site Permit from the Commission is required before the Project can be constructed. The Power Plant Siting Act (Minn. Stat. ch. 216E) and Minn. R. parts 7850.1000 to 7850.5600 establish the requirements for submitting and processing a Site Permit application. The statutes and rules also establish notice requirements for various stages of the process. The Application will be considered by the Commission under the alternative permitting process in Minn. Stat. § 216E.04 and Minn. R. parts 7850.2800 to 7850.3900. The Commission has up to six months from the time the application is accepted as complete to process and make a decision on the Site Permit according to Minn. Stat. § 216E.04, subd. 7, and Minn. R. 7850.3900, subp. 1. The Commission may extend this time limit for up to three months for just cause or upon agreement of the applicant.

Within 60 days after the Commission accepts the application as complete, the Commission and the Department of Commerce, Energy Environmental Review and Analysis (EERA) unit will hold a public information and scoping meeting to provide information and seek comments from the public. At this meeting, members of the public may comment on the scope of the environmental assessment and/or propose additional issues for consideration in the environmental assessment that the EERA will prepare. Once the public meeting is scheduled, notice of the meeting will be provided to persons whose names are on the Project contact list and will be published in a legal newspaper of general circulation in the Project area.

After the environmental assessment has been completed, EERA will make the document available for public review and a public hearing will be held on the Application. Any person may speak at the public hearing, present docu-mentary evidence, ask questions of Otter Tail's representatives and EERA staff and submit comments.


