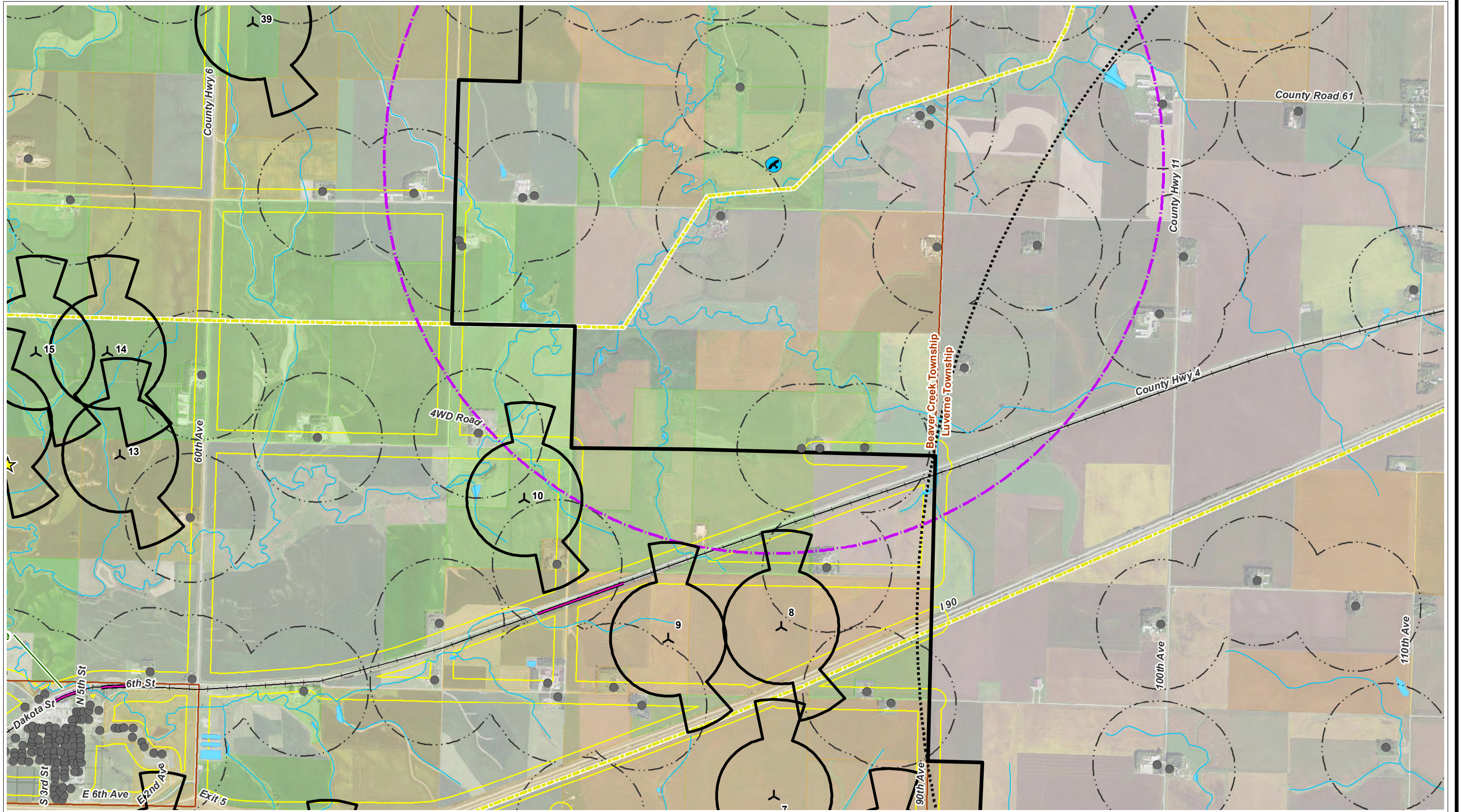

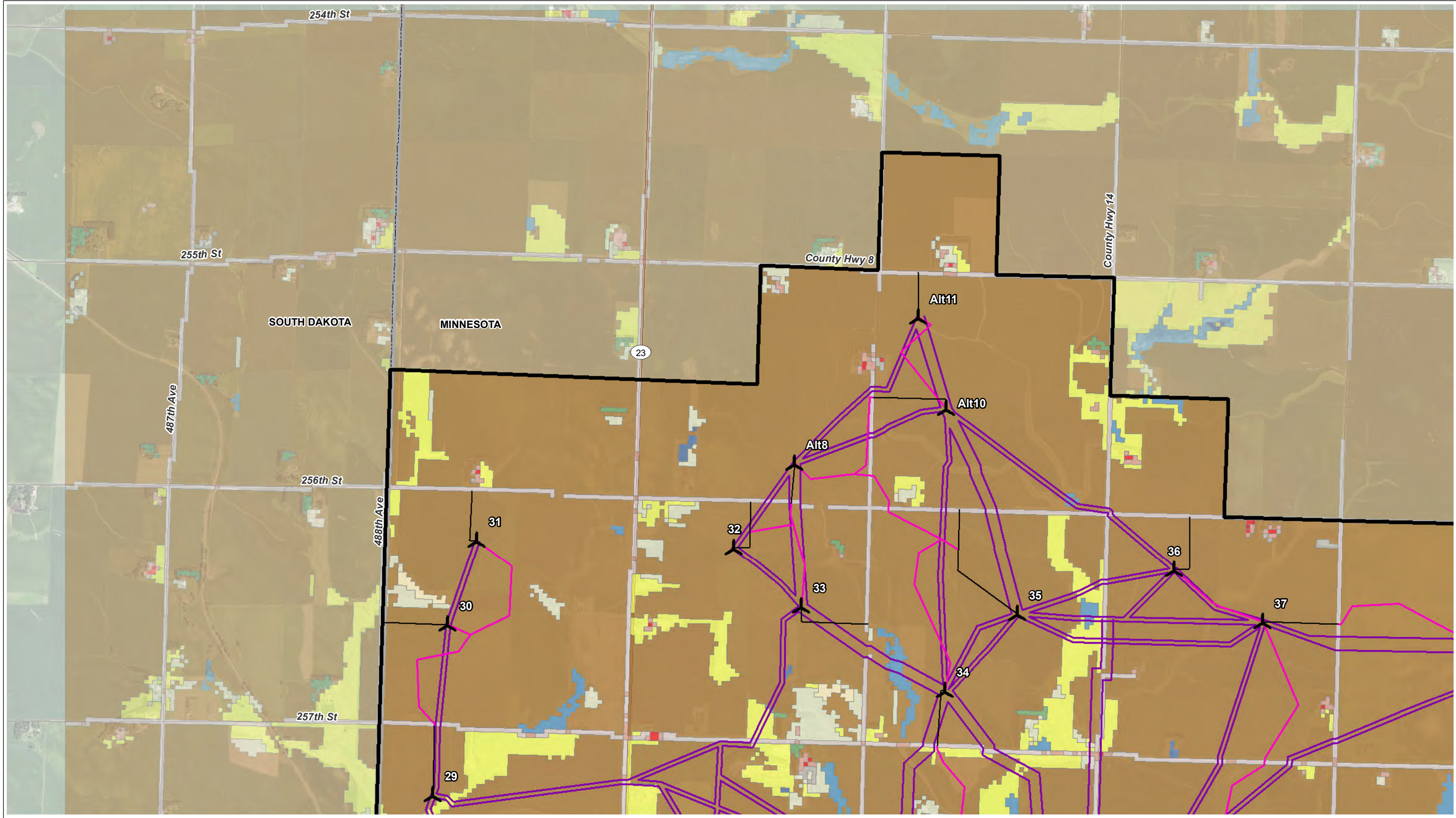


MAP 6 - LAND COVER

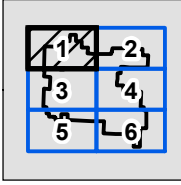
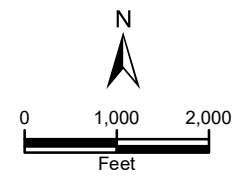


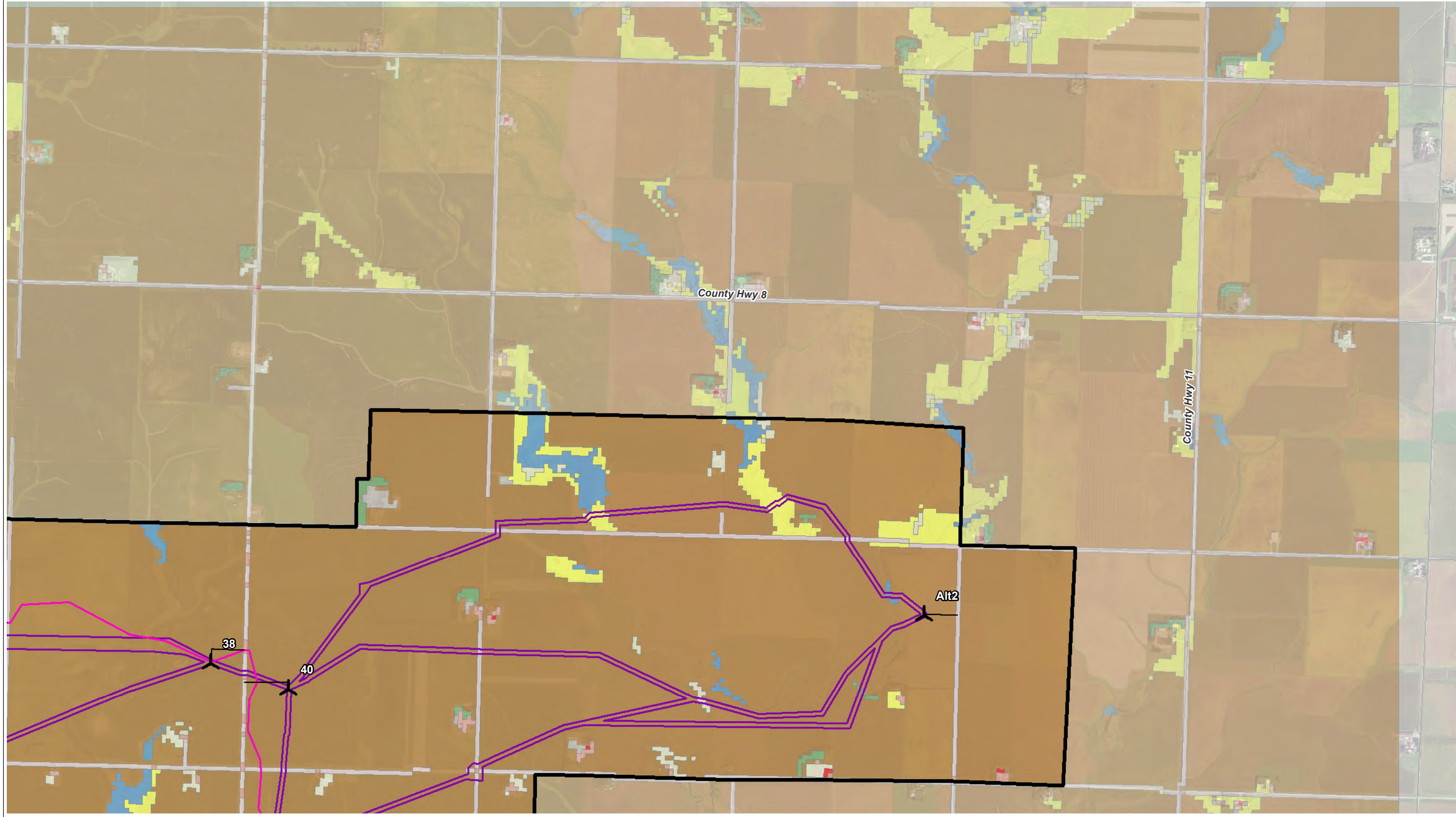


MAP 6 - LAND COVER - PAGE 1 OF 6

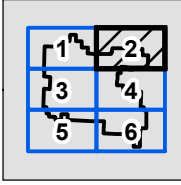
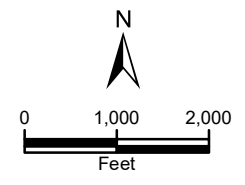


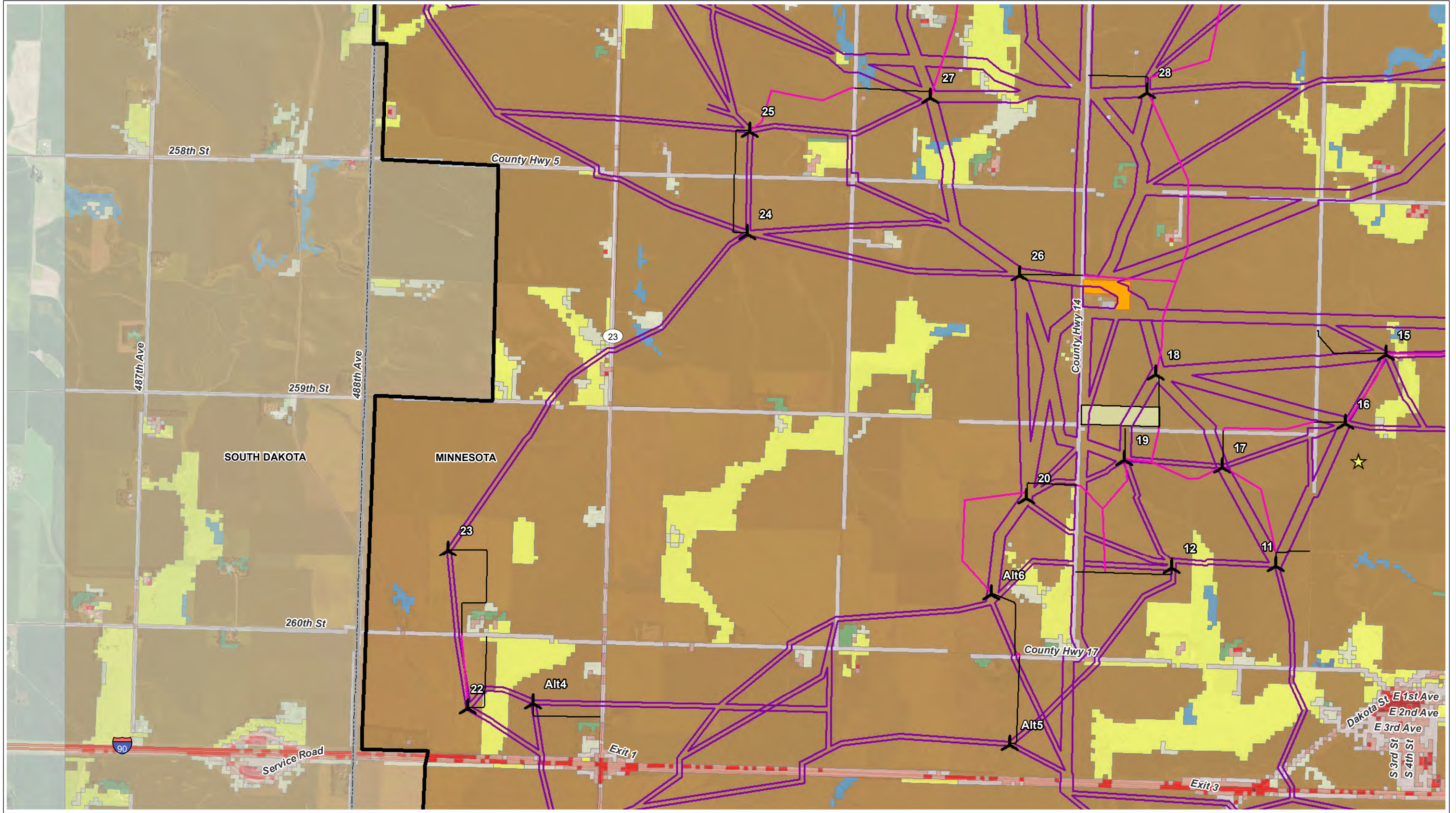


MAP 6 - LAND COVER - PAGE 2 OF 6

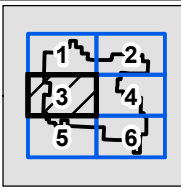
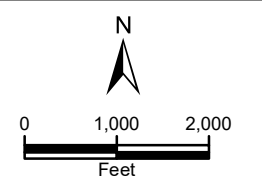


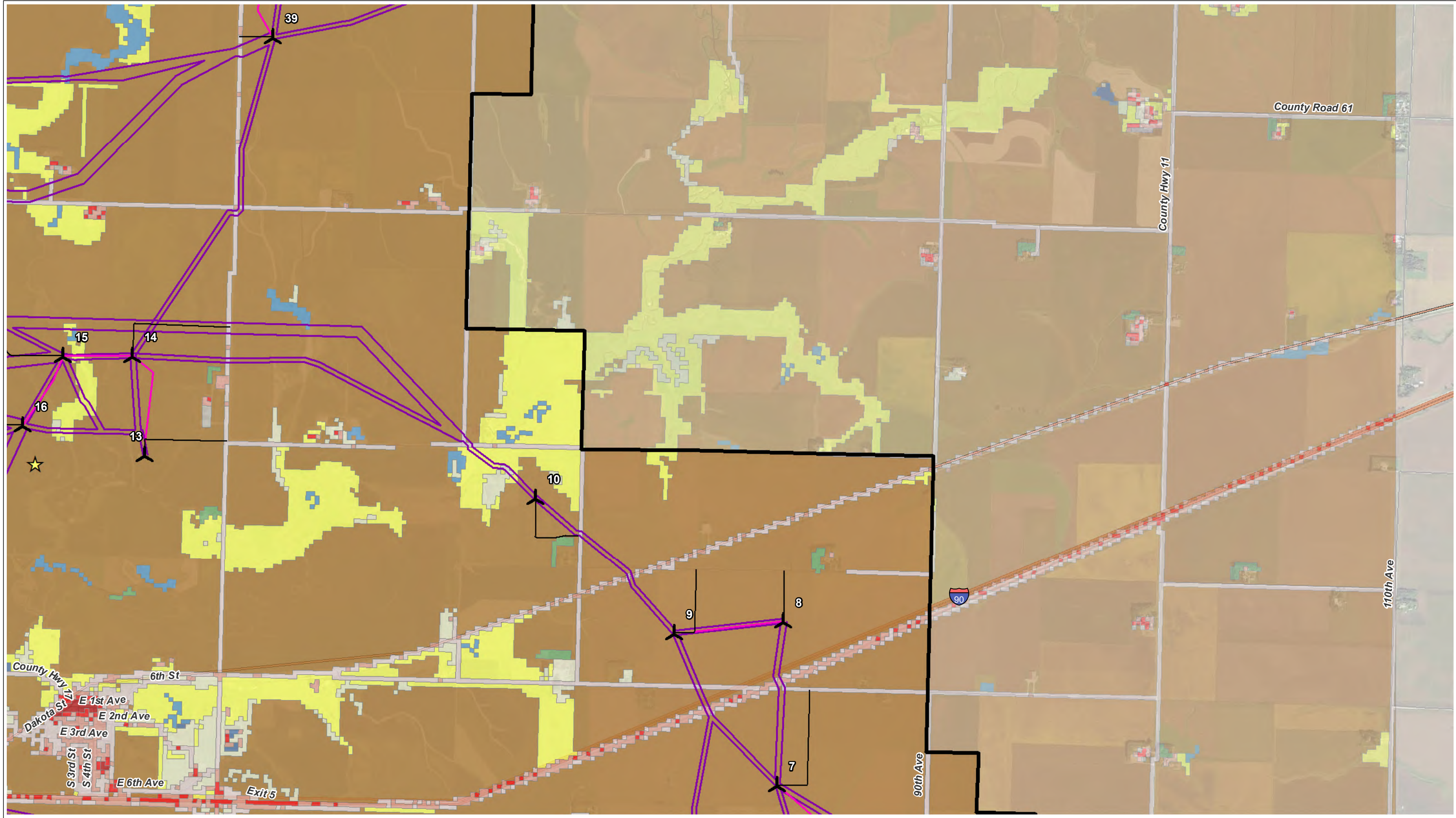


MAP 6 - LAND COVER - PAGE 3 OF 6

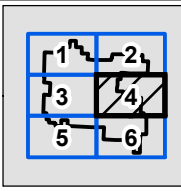
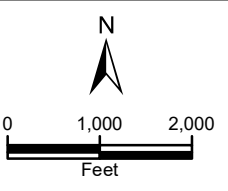


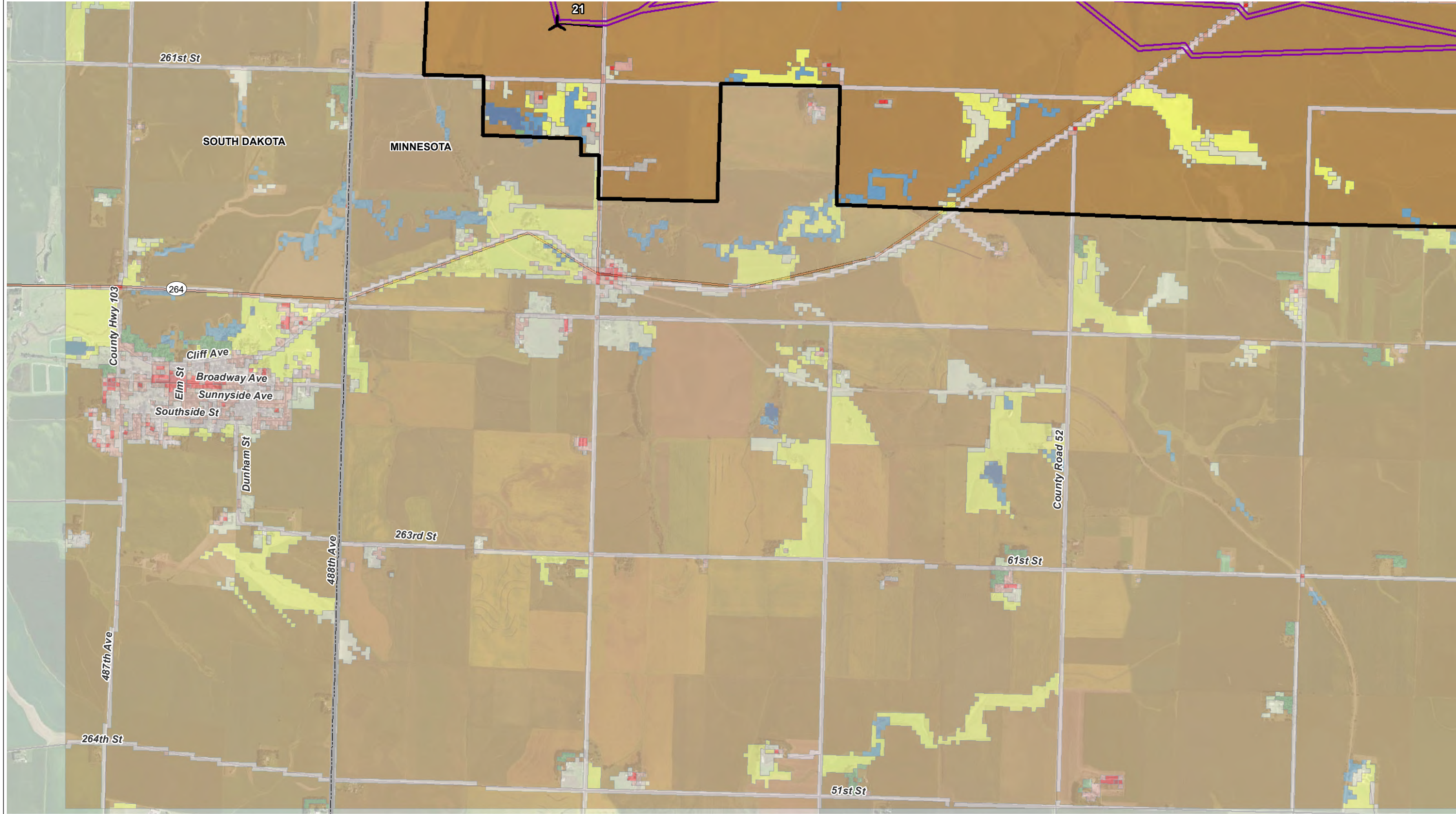


MAP 6 - LAND COVER - PAGE 4 OF 6

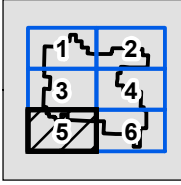
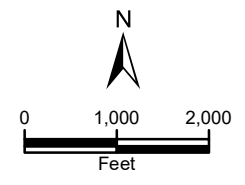


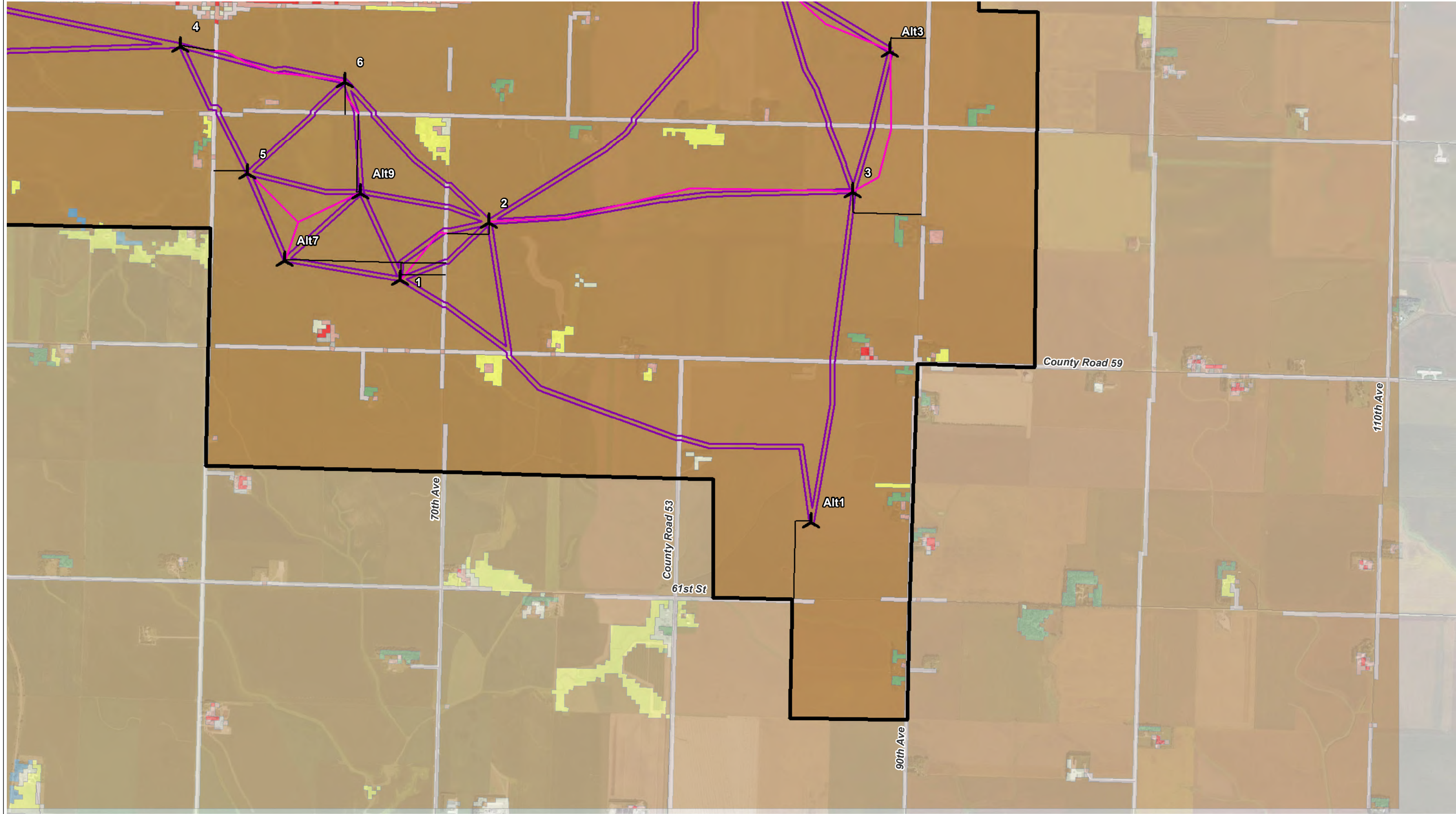


MAP 6 - LAND COVER - PAGE 5 OF 6
