On March 31, 2014, CenterPoint Energy ("the Company") submitted its Gas Affordability Program 2013 Annual Compliance Report ("2013 Report"). On May 30, 2014, the Minnesota Department of Commerce ("Department") filed Comments on the 2013 Report and recommended that the Minnesota Public Utilities Commission ("Commission") accept the Company's 2013 Report. On June 13, 2014, The Company submitted Reply Comments requesting that the Commission accept the 2013 Report.

The Company has identified a transcription error in the Department's Comments. Attachment A of the Department's Comments lists the "GAP tracker balance as of yr-end" as \$217,175 for CenterPoint. As listed in the 2013 Report, Schedule A, line 10, the Company's year-end GAP tracker balance was \$2,372,429. After finding the error, the Company notified the Department and is now submitting this supplement to the Commission.
