Dear Dr. Haar,

I am writing to provide you with an update on the Department of Commerce (Department) Energy Environmental Review and Analysis (EERA) staff efforts, per Commission Order dated July 2, 2014, concerning the establishment of an advisory task force (ATF) for the Great Northern Transmission Line (GNTL) project. Responses to EERA's solicitations of interest in ATF membership have been light and insufficient to meet the ATF statutory requirements. Therefore, EERA is requesting that the Commission reconsider the question of establishing an ATF.

A brief summary of milestones and events leading up to this recommendation is provided below.

Minnesota Power filed a petition for a route permit for its GNTL project in northern Minnesota on April 15, 2014. The proposed project is a 500 kilovolt (kV) transmission line to be located between the province of Manitoba in Canada and the Blackberry Substation in Itasca County (approximately 225 to 300 miles). The transmission line is intended to provide delivery of and access to power generated by Manitoba Hydro's hydroelectric stations in Manitoba.

On April 18, 2014, the Commission issued a notice seeking comments on whether Minnesota Power's application was complete and whether an advisory task force should be appointed for the project. In response, the Department EERA staff filed comments recommending that the Commission accept the route-permit application as substantially complete and authorize the Department to establish three advisory task forces (that is a task force each for the western, central and eastern one third of the proposed 300 mile route).

On July 2, 2014, the Commission released its Order on the completeness of the Minnesota Power GNTL route permit application. In that Order, the Commission authorized the Department to establish three advisory task forces (ATF).

Minnesota Statute 216E.08 states that task forces appointed to evaluate sites or routes considered for designation shall be comprised of at least one representative from each of the following: regional development commissions, counties and municipal corporations and one town board member from each county in which a site or route is proposed to be located.

In order to meet that statutory requirement and assure that conflicts with, or issues relative to, regional and local planning are identified for consideration, EERA solicited ATF membership from the following entities:

The charge and anticipated schedule for the ATF was detailed in the solicitation letters (see Attachment A – Example ATF solicitation letter/forms). The solicitation letters also included a candidate information form (to be returned to EERA) and a map of the proposed routes and ATF break points.

On June 19, 2014, 33 solicitation letters were sent out by EERA staff to the entities identified above. The solicitation letters requested that the candidate forms be returned by end of business on July 3, 2014; by July 11, 2014, four candidate forms had been returned to EERA.

Beginning on July 11, 2014, EERA staff starting telephoning each entity on the above list; this generated five additional members for a total of nine (3 for the western ATF, 5 for the central ATF, and 1 for the eastern ATF). Attachment B contains the completed candidate forms received and a table of EERA's follow-up activities.

Through the years, the Department has found that the optimal task force membership size ranges from 10 to 20 members; even though there is no magic number, an ATF's must be large enough to encompass a range of knowledge and experience, and not so large that it loses its focus and effectiveness (meetings can be difficult to arrange and conduct).

The low response to the ATF solicitation was mirrored in the low attendance at the public information and scoping meeting held for the project. During the weeks of July 14 and July 21, EERA held eight EIS scoping meetings across the approximately 300-mile project area; a total of 104 people attended those meetings – Roseau (22), Baudette (8), Little Fork (8), International Falls (4), Kelliher (10), Big Fork (15), and Grand Rapids (20 morning/17 evening).

The lack of response from the local units of government in the solicitation for the ATFs and the modest turn out for public information/scoping meetings may be a result of the extensive outreach conducted by Minnesota Power preceding the submittal of the route permit application. From August 2012 to November 2013, the Applicant organized more than 75 agency and public meetings in its effort to identify the local community needs and preferences. These efforts are laid out in Section 4 – *Development and Screening of Alternatives* and Section 9 – *Public Participation and Agency Coordination* of the route permit application.

Given the information described above, EERA staff concludes that establishment of ATFs for the GNTL should not be further pursued. Pending Commission consideration of this conclusion, EERA staff will continue to work with the nine interested persons directly to assure that their concerns are recorded and considered, and assist them in developing potential alternative route segments should they so desire.

Greetings. The Minnesota Department of Commerce (Department) is soliciting nominations for members of three advisory task forces (ATF) for the Great Northern Transmission Line project, which has been proposed by Minnesota Power (MP) and is before the Minnesota Public Utilities Commission (Commission) for a high voltage transmission line (HVTL) route permit. I ask that you please read through this information concerning the task force and respond to me by **Thursday, July 3, 2014**.

The ATF will assist the Department's Energy Environmental Review and Analysis (EERA) staff in developing the scope of the environmental impact statement (EIS) that will be prepared for the proposed project. The structure and charge of the ATF is attached, along with a map showing the geographical extent of the three ATFs. The ATF is charged with:

- (1) Assisting in identifying specific impacts and issues of local concern that should be analyzed in the EIS, and

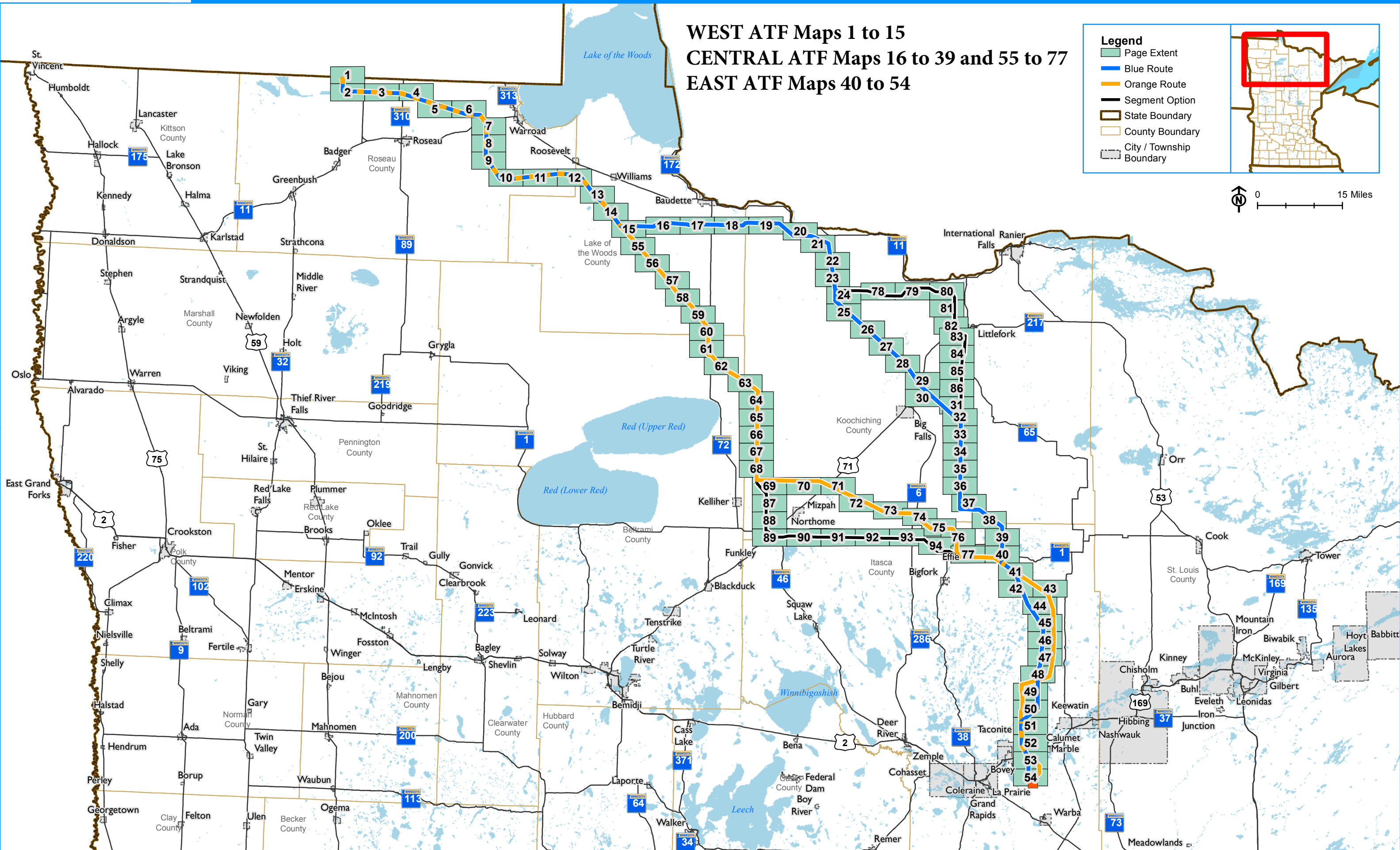
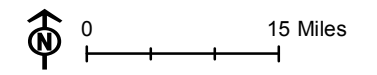
