Greater Minnesota Gas, Inc. filed its Petition for Approval of a Change in Contract Demand Entitlement on July 31, 2014. GMG indicated that it would provide a supplemental filing if changes were necessary as the heating season approached. Now that the actual number of new customers is final, GMG has determined that it will not seek to increase its contract demand entitlement level from that previously requested. GMG's Petition for Approval was based on a projected addition of 595 firm meters. GMG actually added 582 firm meters this year. Accordingly, GMG does not believe that an increased level of contract demand entitlement is warranted; and, GMG respectfully requests that the Commission approve its previously submitted Petition.
