**RESPONSE**

**INTRODUCTION**

Northern States Power Company, doing business as Xcel Energy, submits this Response as requested by the Minnesota Public Utilities Commission in their Notice of Comment Period in the above referenced dockets on April 4, 2025.

The Commission's Notice was in response to the Company's December 19, 2024 Petition to increase the participation fee, prorated by project size, assessed to community solar garden (CSG) Subscriber organizations (or developers) for the Legacy CSG program and the Low-to-Moderate Income (LMI) Accessible CSG program from \$500 per MW to \$800 per MW, to be applied beginning in February 2026, to recover administrative costs. The Company provides updated details, including 2024 actuals and an updated forecast of administrative costs as Attachment A to this response. We continue to believe that an adjustment to \$800 per MW is appropriate as set forth in the Petition, and as supported by the information provided in Attachment A.

The Notice of Comment Period also specifically requests that the Company provide information relevant to the Company's assessment of the current \$4,125 per MW application fee for the LMI Accessible CSG program, including but not limited to:

- Total revenues received through the fee;
- Total actual costs incurred by Xcel Energy to upgrade its computer systems to accommodate the LMI Accessible CSG program;

- A modified fee amount based on current and projected costs if the current fee amount is unreasonable, and
- If warranted, potential refunds to participants as contemplated in the Commission’s December 28, 2023 Order.

The Commission’s December 28, 2023 Order (December Order) approved the current application fee amount of \$4,125 per MWac. The Company began to assess this fee in late 2024 and continues to do so to recover the additional costs for the functionality built specifically for LMI CSG Subscriber organizations to allow bill credits to be issued for LMI CSGs, including the use of consolidated billing. The Company does not recommend adjusting this fee at this time and responds specifically to the Notice below.

## **RESPONSE**

### **I. BACKGROUND**

The Commission’s December Order approved the current amounts for the application fee and the participation fee now reflected in the Company’s tariff. The participation fee is in both the Legacy and LMI CSG tariff, and the application fee at issue here is only in the LMI CSG tariff. Specifically at Ordering Points 3 and 4 the Commission approved a \$500 participation fee (per MW) and a \$4,125 application fee (per MW), as described below:

3. *Xcel may assess an annual participation fee of \$500 per megawatt for CSGs in the Legacy and LMI-Accessible CSG Programs.*
4. *To recover actual costs related to implementing the LMI-Accessible CSG Program, Xcel may assess an application fee at a rate of \$4,125 per MW for CSGs in the LMI-Accessible Program, with the opportunity for a refund following the comment period. The Commission delegates authority to its Executive Secretary to open a comment period on the application fee.*

The Company opened its portal for consolidated billing to LMI Subscriber organizations beginning in December 2024. The implementation process has taken several months as Subscriber organizations began to learn the system and provide details necessary to utilize consolidated billing. The first consolidated bill went to customers in March of 2025 and Subscriber organizations began receiving direct payments in April of 2025. Currently, there are over 500 customers opting into consolidated billing for ten active CSGs. Six Subscriber organizations are choosing

this option. It is our understanding that some Subscriber organizations will suggest consolidated billing to future subscribers as the process is refined.

## II. LMI CSG APPLICATION FEE

The Company is currently administering an application fee of \$4,125 per MW to LMI CSGs per the December Order. The purpose of this fee is to ensure the cost causer is responsible for the costs associated with the functionality built specifically for LMI CSG Subscriber organizations – the functionality that allows bill credits to be issued for LMI CSGs including the use of consolidated billing.

This fee must be paid by the LMI CSG project within 10 Business Days after the Department approves the project into the LMI CSG program. See, tariff sheet 9-99.09.

### A. Total Revenue Received

The total revenue paid by Subscriber organizations in application fees is shown in Table 1 below; this information includes both 2024 and 2025 through April 10, 2025. We have also included in the table the amount of application fee charges assessed but not yet paid by the Subscriber organizations.

The Department of Commerce approved 81.35 MW of community solar gardens in 2024.<sup>1</sup> However, the Company has not yet received the payment of the application fee for 53.5 MW of these projects. The “Assessed, Not Yet Paid” portion for projects approved in 2024 totals \$220,753. The Company has not actively enforced the 10 Business Days as we began to approve these projects, we are working with those Subscriber organizations in this category to finalize payment.

## B. IT Costs for LMI CSG Bill Credits, Including Consolidated Billing

Tables 2 and 3 provide the IT costs to support the bill credit and consolidated billing functions for the LMI Accessible CSG program.

Our actual cost of \$3.8 million is more than the \$3.2 million estimated in our August 28, 2023, filing.<sup>3</sup> This difference is mainly due to accelerating the timeframe for consolidated billing implementation from our requested January 2026 date to January 2025, which required additional resources and staff to conduct the expedited work necessary for implementation. In addition, cost allocation was adjusted overall consistent with work completed.

Ongoing costs of IT system maintenance will become part of the full CSG budget and are anticipated to be recovered through the ongoing CSG participation fee.

## C. Modification of Application Fee

The Company acknowledges that the full IT cost associated with consolidated billing

was included as part of our 2025 Multiyear Rate Plan<sup>4</sup> as a capital project. These costs can be found in the Direct Testimony of Company witness Megan N. Scheller in Exhibit\_\_\_\_(MNS-1), Schedule 2, pg. 20 (ITC-Solar Garden Portal SW MN) as part of Enhanced Capabilities.

The Company will update the other revenue forecast in Rebuttal Testimony to align with the latest approved fee structure. This accounting treatment ensures that the Company recovers the cost of this project, but also ensures the cost is paid (over time) by the cost-causers. This treatment is consistent with pole attachment revenue.

Table 4 below shows the total incurred cost compared to the revenue. The Company is not suggesting a change in the application fee. If the LMI Accessible CSG program continues to grow as allowed by statute, we can anticipate an additional 520 MW of projects (if the program continues through 2033). At this pace, we would receive an additional \$2,887,500<sup>5</sup> over the total 10-year period used to estimate cost recovery through the application fee.

### **C. Refund**

The Company has not recovered the costs associated with the IT costs to enable Bill Credits for the LMI CSG program, including the consolidated billing system costs. The Company therefore does not anticipate a refund of the application fee in 2025, nor do we anticipate that a refund will be needed in the future.

## **III. PARTICIPATION FEE**

In our Petition, the Company proposed to increase the participation fee from \$500 to \$800 per MW prorated by size. To provide additional information for parties to

prepare their Initial Comments, we have updated the Allocation Tracker to provide actual costs. This information is provided in Attachment A.

In this update, we have added actual 2024 costs (including the participation fee paid in 2025), a decrease in future SalesForce costs as we anticipate a reduction in 2025, and an update to more accurately forecast project completions to the best of our ability. Based on these changes, we show a cumulative shortfall of \$161,369 in 2029. However, given we are estimating the completion of projects and costs, we believe this is an acceptable margin and as such continue to support ongoing modifications of the fee to account for actual costs and changing forecasts.

## **CONCLUSION**

The Company appreciates the opportunity to provide additional information on the LMI Accessible CSG application fees, and the participation fee applicable to both the Legacy CSG and LMI Accessible CSG programs. We look forward to further discussion as part of this comment cycle.
