Project Description

Enbridge (Plummer) Solar, LLC (Plummer Solar) is proposing to construct an up to 130 MW solar energy generating system located in Emardville Township in Red Lake County, Minnesota. The proposed nameplate capacity for the Project is 130 MW AC. The Project will be located on an approximately 855-acre Land Control Area, of which approximately 796.9 acres are located within the Project fence (the Project Site). The Project will interconnect to an existing OTP 115 kV transmission line immediately adjacent to the Project Site, via a short (<1,500 ft) aboveground 115 kV transmission line.

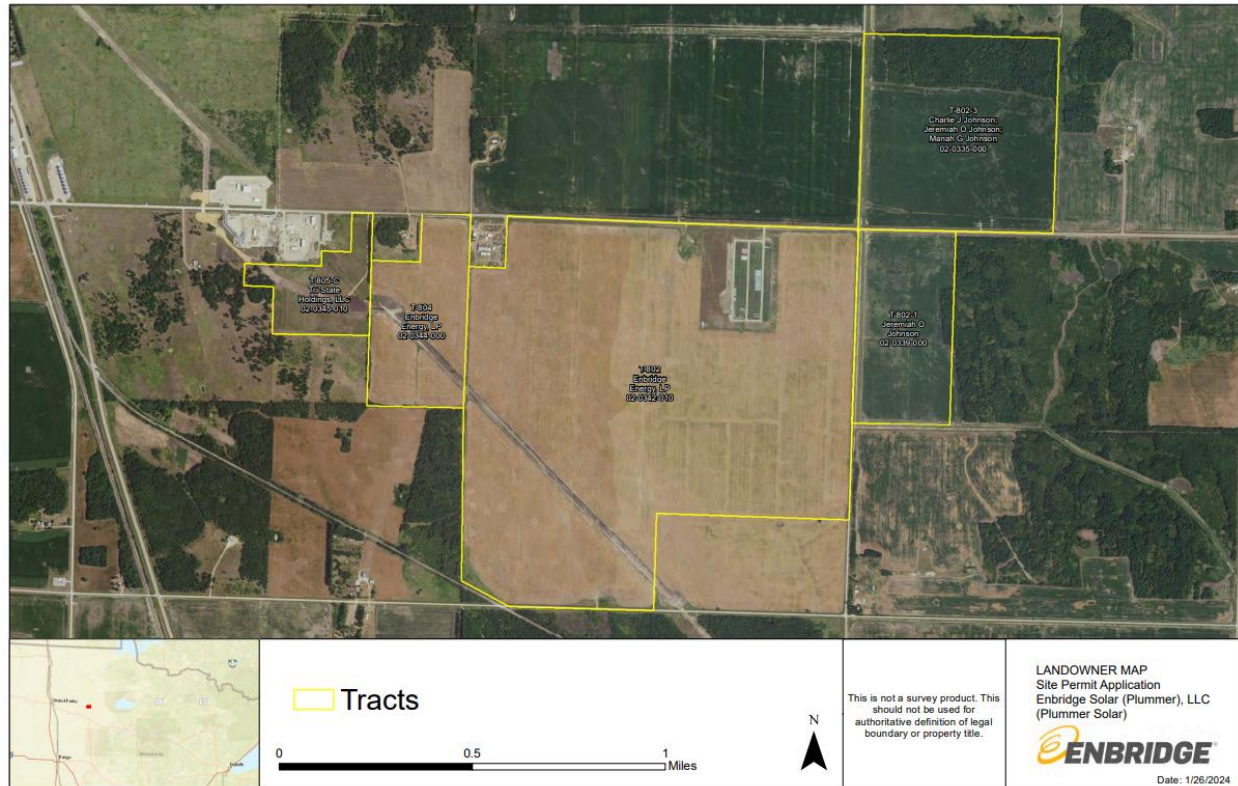
