Topic(s) Open for Comment:

- Should the Commission grant or deny the petition for rulemaking?

Background

On April 14, 2026, the Commission received a petition for rulemaking, under Minn. R. 1400.2040, from Carol Overland requesting that the Commission initiate a rulemaking proceeding under the Administrative Procedure Act, Minn. Ch. 14, to amend Minnesota Rules, Chapters 7849 and 7850 in light of adoption of the Energy Infrastructure Permitting Act, enacted by the Legislature in 2024. As part of the legislative changes, environmental review staff at the Department of Commerce were transferred to the Commission, along with environmental review responsibilities.

Filing Requirements: Utilities, telecommunications carriers, official parties, and state agencies are **required** to efile documents using the Commission's electronic filing system (eFiling). All parties, participants, and interested persons are encouraged to use eFiling at:
