- 2) Approve CenterPoint Energy's 2020 CIP Tracker account, as summarized in the *Comments*, Table 1, resulting in a December 31, 2020, balance of \$1,952,441;
- 3) Approve a 2021/2022 CCRA of \$0.0791 per Dth, effective October 1, 2021.
- 4) Approve the Company's bill message concerning its CCRA of \$0.0791 per Dth.<sup>3</sup>
