- Are there questions or concerns regarding the representations made in the Report?
- Should the Commission continue to grant the waiver to the public meeting and related notice requirements for the next Report cycle?
- Are there other issues or concerns related to this matter?

### Background:

On November 1, 2023 the Minnesota Transmission Owners filed the 2023 Minnesota Biennial Transmission Projects Report (Report) with the Minnesota Public Utilities Commission (Commission). The Report can be found via the Commission's eDockets system (instructions below) or at [www.minnelectrans.com](http://www.minnelectrans.com).

The Report is required under Minn. Stat. § 216B.2425 and is to identify current and foreseeable future transmission system inadequacies and to identify and discuss alternative means of addressing them. The rules governing the review process are in Minnesota Rules Chapter 7848. Petitions to intervene will be accepted through January 15, 2024 at 4:30pm, the deadline for initial comments on the merits of the Report. The Commission is required to accept, reject, or modify the report, or require further action, by June 1, 2024.

Beginning with the 2015 Biennial Report, Xcel Energy is required to file a biennial Grid Modernization Report and a Hosting Capacity Report. The Commission will solicit comments on

Xcel's 2023 Integrated Distribution Plan/Distribution Grid Modernization Report and Hosting Capacity Report separately in dockets; E002/M-23-452 and E002/M-23-466, respectively.
