**NOTICE OF JOINT WITHDRAWAL OF
PETITION REGARDING TAP REIMBURSEMENT AND VOIP SERVICE**

Midwest Cable, Inc. a/k/a GreatLand Connections, Inc., Midwest Cable Phone of Minnesota, LLC (jointly referred to as “Midwest Cable”), and the Minnesota Department of Commerce (“Department”) hereby withdraw their Joint Petition Regarding TAP Reimbursement and VoIP Service (the “Petition”) in the above-referenced docket.

Midwest Cable and the Department filed the Petition in accordance with the terms of the Settlement Agreement approved by the Minnesota Public Utilities Commission (the “Commission”) in the proceedings concerning Midwest Cable’s application for authority to operate as a competitive local exchange carrier and to transfer regulated customers and assets from Comcast Corporation (“Comcast”) to Midwest Cable.¹ Both the Settlement Agreement and

The Settlement Agreement was executed by Midwest Cable and the Department on February 19, 2015, and filed with the Commission on February 20, 2015. the Petition were contingent upon the consummation of transactions approved by the Commission in the Order, which in turn were contingent on consummation of an overarching transaction between Midwest Cable's parent company, Comcast, and Time Warner Cable. As reflected in separate filings submitted to the Commission in Dockets numbered 14-507 and 14-513, the planned transactions that were the predicate for the underlying application and transfer request have been terminated. Therefore, the transactions contemplated in the Settlement Agreement and the Order will not be consummated.

In light of these changed circumstances, Midwest Cable will not be providing service in Minnesota. Consequently, Midwest Cable and the Department withdraw the Petition and request that this proceeding be terminated forthwith.
