For background on the catalyst of this reroute, on April 28th, the Governors of Minnesota, North Dakota and South Dakota petitioned the Administrator of the Environmental Protection Agency to initiate a formal rulemaking that would mandate the availability of two special grades of gasoline, not currently available, for use in those three states as soon as the Spring of 2023. We understand that EPA is likely to initiate a formal rulemaking regarding this mandate within the next 30 days. We believe these changes could increase the likelihood of fuel shortages in the region, especially if this pipeline is not in continued service. Therefore, the reroute project is intended to ensure the continued adequate transportation service for the new boutique fuels in western Minnesota, as well as eastern South Dakota and eastern North Dakota.

The segment of the pipeline that is the subject of Magellan's reroute project presently runs through federal lands, including Pipestone National Monument. For reference, a map of the study area is enclosed. Magellan's plan is to place the reroute segment on private lands within the study area, but we have not yet determined our proposed route(s) for the reroute project. Our route evaluation process takes into account environmental, land use, cultural, and other potential routing constraints.

We are providing this project information as we begin the route identification process so that tribal communities that may be affected, or that may have input, have every opportunity to provide that input. It is important to us that all potentially affected parties have an opportunity to provide us with feedback and to participate in the project's regulatory processes as well.

Once a proposed reroute has been identified, we intend to apply to the Minnesota Public Utilities Commission (MPUC) for approval pursuant to Minn. Stat. Ch. 216G and Minn. R. Ch. 7852. We currently anticipate applying to the MPUC in the Fall of 2022. A copy of this letter will be

I am writing to provide you with a status update for the Magellan Pipeline Company, L.P. (Magellan) Pipestone Reroute Project (Project). Since we sent our last correspondence, dated August 18 and September 1, 2022, Magellan shut down the existing 8-inch refined products pipeline on October 1 at the request of the U.S. Department of Interior. Magellan developed a proposed 1.3-mile-long pipeline reroute located on private property to the west of Pipestone National Monument as depicted on the enclosed map. To minimize environmental impacts, Magellan plans to use the horizontal directional drill method to install the pipeline beneath Pipestone Creek and beneath the catlinite layer underlying the Sioux Quartzite bedrock.

Magellan has retained Environmental Resources Management, Inc, (ERM) to conduct an archaeological investigation for the Project. The fieldwork is scheduled to begin the week of November 14, 2022 pending any severe weather events. We anticipate that other field surveys (e.g., wetland and waterbody survey) will occur during next year's spring season.

On behalf of the Flandreau Santee Sioux Tribe, we are writing to express our strenous opposition to any additional routes/reroutes. This is a landscape with protected resources which include archaeological sites, the Pipestone Creek, remnant and restored tallgrass prairie, federally threatened and endangered plant and animal species, the Sundance grounds and the remains of the Pipestone Indian Boarding School. And very soon will be the site of a rebuilt burial mound to an area very close to the existing pipeline.

In 1835 a Dakota Chief and his family were camped around what is now Pipestone NPS park. While there his son took part in a young men's ceremony on the stone pillars now called leaping . He fell to his death on that day. His father had a mound of stone built to inter his son. So historic was this event that George Catlin painted the very scene as told to him by the grieving chief. This painting and its mass reproduction is known worldwide.

At the Pipe-Stone quarries "is a mound of a conical form, of ten feet height, which was erected over the body of a distinguished young man, son of a Sioux chief," who was killed there about 1835. — Catlin, Indians, II, 170, note

In 1904 a local pot hunter Mr destroyed the mound and took the Chiefs son. He later donated the human remains to an institution in Minnesota. In 2022 Minnesota State/Minnesota Indian Affairs Council admitted to the ownership of the remains and that the bones were to be reported to NAGPRA and allow the tribes to make a claim for the human remains.

It is our understanding that NPS and several Dakota Tribes are in agreement for the reinternment of the Dakota human remains to the Pipestone NPS grounds. The burial before destruction and after would have and is now eligible to be listed on the National register under more then one criteria.

Another concern of both the NPS and all tribes who quarry pipestone is the potential impact a spill could have on the quarries sitting near the pipeline. Elders like Bud Johnston who have quarried there tell us that the nature of the stone is what could make it susceptible to contamination.

"Pipestone is a clay that was under pressure for a couple of million years, so it's basically a porous material that absorbs. If anything else gets poured into it, it's going to be absorbed by the clay."

In 1985 my friend and I quarried for a whole year. Through a blizzard and then through the humid heat of summer the experience made it seem like such a blessing gathering pipestone. Just like everything in life there is good and bad. During that year we noticed the absence of turtles in the lake . We were told that they left because of farm chemicals that made the stream and lake toxic. Should any more routes do damage to the flora or fauna , water or ground, I'm not sure that we could repair any of it. I am strongly opposed to this.

As you are aware, Lower Sioux Indian Community is associated to the study area identified in the notification, as such, understands the area to actively and historically hold cultural importance and/or religious significance to the Mdewakanton Dakota.

After review of the above-mentioned notices, **Lower Sioux has determined concern and interest** with Magellan Pipeline Reroute project in Pipestone County, MN. It is Lower Sioux's understanding the existing pipeline has aged over time creating a high-risk situation for further impacts or contamination to the natural environment, including the known archaeology site and resources contained within the study area. Our tribal review and research determined this area as a place of historical and traditional habitation, the archaeology reports also support the historical presence of Indigenous people at this location. Our office has been informed of recent tribal survey efforts at Pipestone National Monument, the report findings have yet to be circulated however, until we have a comprehensive understanding and consensus from Tribal partners on pathways forward our office will deter from further recommendations.

The purpose of Webex video call was to introduce Magellan's Pipestone Reroute Project (Project) and provide an opportunity for the Lower Sioux Indian Community's Tribal Historic Preservation Office (THPO) to ask questions about and provide input on the Project.

After introductions by the call participants, Mr. Haning provided an overview of Magellan's pipeline assets and the Project with a PowerPoint presentation:

- Magellan operates 9,800 miles of pipeline to transport refined fuels (diesel, jet fuel, gasoline, ethanol, biofuels) and 2,200 miles of crude oil pipelines; Magellan does not own the refined products.
- The pipeline crossing the Pipestone National Monument (Monument) has been in operation since 1947 and has not had any releases since it began operating.
- The pipeline right-of-way renewal coordination with the U.S. Fish & Wildlife Service/National Park Service has been ongoing since 2012, but recently the federal agencies confirmed that the right-of-way renewal will not be granted.
- On October 1, 2022, Magellan shut down the pipeline and is currently coordinating with the federal agencies regarding abandonment of the pipeline on federal lands.
- Magellan is planning a reroute west of the Monument that will likely pass between the two cemeteries (St. Leo and Woodlawn), will avoid state and federal lands, and will generally be in agricultural lands.
- Horizontal directional drilling (HDD) will be used to cross below Pipestone Creek and the Sioux quartzite formation. The HDDs will be about 1,500 feet (ft) to 1,600 ft long to depths of 50 to 60 ft; heavy-walled pipe will be used for the HDDs. In agricultural lands where the pipeline will be installed in an open trench, the pipeline will be at a depth of 54 inches.
- The Pipestone Creek crossing will be permitted by the Minnesota Department of Natural Resources under a stream crossing permit. A permit from the U.S. Army Corps of Engineers (USACE) is not anticipated; but if a permit is required from the USACE it would likely be under the Nationwide Permit program.
- Magellan will circulate a copy of the Minnesota Public Utilities Commission (MPUC) application to the tribe prior to its submittal in mid-December.
- Based on the MPUC process, pipeline construction would likely begin in Summer 2023 and would be anticipated to be in-service at about this time next year.

The THPO provided the following comments:

• Magellan should review who is buried in the St. Leo and Woodlawn cemeteries.

- Magellan should review the depth of aquifers in the area.
- The water quality in Pipestone Creek has changed significantly in the past decade; the National Park Service often posts signage regarding the safety of the water (e.g., no swimming).
- Thirty-six tribes gathered with the National Park Service last year and were invited to participate in a survey; the tribe thought Magellan sponsored the survey and her office would like to receive a copy of the report.
- Ms. St. John would be interested in providing tribal monitors during project construction; however, they are already getting booked for next spring.
- The tribe's contracting process is lengthy and coordination with the tribe should begin in January 2023 to ensure that the monitors are available next summer.
- The THPO prefers a 30- to 60-day notice (2 weeks as a worst-case) prior to the start of construction for internal coordination.
- Ms. St. John requested a copy of the PowerPoint presentation which she will share with tribal leadership; she indicated that Magellan should anticipate feedback from the leadership in about 30 days.

Magellan action items:

- Provide the THPO with a copy of the PowerPoint presentation.
- Provide clarification on the 2021 survey in the Monument.
- Provide the THPO a copy of the MPUC permit application.



# PIPESTONE LINE HISTORY

- U.S. Department of Interior notified Magellan in 2021 that the renewal would not be granted, thus forcing the line to be shut down if a re-route is not approved and constructed.
- To mitigate the significant fuel impact the line shut down will have on the community, Magellan has begun developing re-route alternatives and engaging stakeholders in order to avoid the federal land.





## **EPA Waiver Elimination**

- Recently, 8-Midwest governors petitioned the EPA for a boutique fuel to increase potential ethanol blending.
- The petition will limit the range of fuels the area can receive and compound supply challenges.
- The Pipestone pipeline segment flows north and south and is critical for supply of petroleum products to Minnesota, North Dakota and South Dakota.
- Shortages in fuel supply may occur if the impacted line segment shuts down, and gasoline and diesel prices will increase for consumers in the surrounding area.
- A pipeline re-route will keep communities connected to the larger fuel supply and help to mitigate these problems.




Blue ovals represent geographical areas potentially impacted by potential fuel shortages





# Pipestone Re-Route



- Magellan is pursuing a re-route for a short segment of the pipeline in order to avoid Federal Lands. Magellan has already begun the processes that will include planning, engineering and permitting to accomplish what we call the Federal Avoidance Re-Route or "FARR".

Magellan Pipeline Company, L.P. has decided to pursue a reroute of a short segment of our existing 8-inch (8") refined products pipeline in Pipestone County, Minnesota and we are beginning the process to consider options for a new route.

For background on the catalyst of this reroute, on April 28th, the Governors of Minnesota, North Dakota and South Dakota petitioned the Administrator of the Environmental Protection Agency to initiate a formal rulemaking that would mandate the availability of two special grades of gasoline, not currently available, for use in those three states as soon as the Spring of 2023. We understand that EPA is likely to initiate a formal rulemaking regarding this mandate within the next 30 days. We believe these changes could increase the likelihood of fuel shortages in the region, especially if this pipeline is not in continued service. Therefore, the reroute project is intended to ensure the continued adequate transportation service for the new boutique fuels in western Minnesota, as well as eastern South Dakota and eastern North Dakota.

The segment of the pipeline that is the subject of Magellan's reroute project presently runs through federal lands, including Pipestone National Monument. Thank you for the opportunity to comment on the above project. It has been reviewed pursuant given to the Tribal Historic Preservation Officer (THPO) by the National Historic Preservation Act of 1966, as amended in 1992 and the Procedures of the Advisory Council on Historic Preservation (38CFR800). After review of the pipeline reroute project for Magellan Midstream Partners LP (Magellan) in Pipestone, MN, we are in agreement that the current existing pipeline route is a direct hazard to a very valuable natural resource. Consequently, we feel it is necessary to reroute the existing pipeline to mitigate its potential direct hazard. We have several concerns and recommendations we had shared with Magellan during our consultation meeting held in Pipestone, MN, on December 6, 2022, which we would like to reiterate today. Additionally, after reviewing the new pipeline reroute plans shared with us on February 24, 2023, we have additional concerns we would like to share with you.

Announcement of the pipeline reroute project without the appropriate breadth of Tribal consultation and dialogue with the Tribes is inexcusable. Magellan has done a good job consulting with the local regional Tribes regarding this project. However, due to the culturally sensitive nature of the Pipestone Quarry to many Tribal nations, regionally and beyond, we insist Magellan to start this project over, consult with Tribes in a meaningful and substantive manner to determine the scope of reroute, the extent of the reroute study area, and the design of the rerouted pipeline segment, and only then to proceed with the pipeline reroute project. As the original stewards of this land, we expect nothing less, to preserve our past and to safeguard our future, for the next seven generations and beyond.

Franklin Avenue • Minneapolis, MN 55404 (612) 872-1424 • Fax (612) 872-1257 Due to the importance of the Pipestone Quarry to many Tribal Nations, regionally and beyond, the probability of impacting culturally significant sites around the Pipestone National Monument is extremely high, even within the proposed expanded study area discussed back in December. Consequently, we believe the expanded proposed study area for the reroute was insufficient to address mitigation, and now with the new proposed reroute, this only heightens our concerns. We urge Magellan to further expand the proposed pipeline reroute study area, as we cannot recommend further disruption to this area without detailed archaeology surveying along a route that is agreed upon, if such an agreed route is reached. We recommend that Magellan significantly broaden their pipeline reroute study area to avoid the catlinite formations, the stone we use as our pipestone. Since the catlinite outcrops are well documented in the original Public Land Surveys of the area conducted in 1870, Sections 1, 12, and 13 of Sweet Township (T106N R46W) and Sections 26, 27, 35, and 36 of Troy Township (T107N R46W) must be avoided at all costs.

The currently proposed pipeline reroute is said to go 5.5-feet below the surface to avoid impacts from frost. Additionally, 30-feet below any water crossings, but will this hit any catlinite formations? Extensive geological surveys are needed once a suitable reroute study area has been identified to determine a pipeline reroute that will avoid the catlinite formations. If the suitable pipeline reroute must go deeper than 30-feet to avoid the catlinite formations, how will Magellan determine the appropriate depth? Avoiding catlinite formations is of utmost importance due to its highly porous properties of pipestone that can easily be damaged and contaminated with petroleum products. If avoiding the catlinite formations to safeguard our sacred pipestone is not possible, we would like to have sufficient time to consult with our elders first.

In the new proposed reroute plan, the proposed route hugs the National Monument area and a significant amount of its routing is located at the very edge of the flood plain of Pipestone Creek. We understand that crossing the Pipestone Creek is unavoidable. However, having approximately 2,400 feet of piping either in or very close proximity to the Pipestone Creek flood plain concerns us, for the potential damage to the creek that can occur in a spill event. Additionally, because the new proposed reroute is still within the historical Pipestone Indian Reservation, and still cuts through the catlinite formations, we strongly recommend Magellan to expand the reroute study area to avoid both the former Indian Reservation and the catlinite formations, and find the shortest crossing point possible across Pipestone Creek, and otherwise staying clear of the creek entirely.

The Band is pleased with the Plan for the Unanticipated Discovery of Cultural Resources and/or Human Remains. It appears to address many other concerns that we had, aside from the issue we still have regarding the need to safeguard the catlinite formations.

Again, let us reiterate to Magellan that the region around the Pipestone National Monument is extremely important to many Tribal Nations. Consequently, Magellan must halt its current pipeline reroute project, and start over by consulting with Tribes first to determine the scope of reroute, the extent of the reroute study area, and the design of the rerouted pipeline segment in such a way to safeguard the sacred sites, cultural properties, and the cultural landscape of our Magellan Midstream Partners LP Pipestone Reroute Project Mille Lacs Band of Ojibwe

sacred pipestone and its quarry. Once these are properly identified through robust consultation, only then Magellan should proceed with its reroute project.

Thank you for providing comments on Magellan Pipeline Company, L.P.'s (Magellan) draft Application for a Pipeline Route Permit and Partial Exemption for the Pipestone Reroute Project (Project). The Project will relocate approximately 0.74 mile of the existing 8-inch pipeline from federal lands managed by the U.S. Fish and Wildlife Service (USFWS) and National Park Service (NPS) within the Pipestone Creek Unit of the Northern Tallgrass Prairie National Wildlife Refuge (NWR) and the Pipestone National Monument, respectively. The reroute will be located on private lands west and north of the federal lands.

Coordination with tribal nations is an important part of Magellan's project development and management processes. In letter dated August 18, 2022, prior to the identification of a reroute, Magellan introduced the proposed study area to several tribes, including the 11 Minnesota tribes and tribes with cultural associations to the area as identified by NPS<sup>1</sup>. Magellan invited each of the tribes to provide comment and since then, has invited participation in conference calls to discuss the Project at key milestones.

During the route identification process, Magellan moved the pipeline outside of the boundaries of the former one-square-mile Pipestone Reservation and is planning several field investigations to assist in designing a route that avoids or minimizes impacts on sensitive resources (Figure 1, Attachment A). Additionally, Magellan has committed to implementing safety measures that meet or exceed federal requirements for pipeline design (see Section 6.3.3 of the draft Application).

Prior to construction, Magellan will undertake field investigations including geotechnical boring and archaeological and tribal survey. The results of these investigations will inform measures

that may be implemented to avoid or minimize impacts on sensitive natural and cultural resources.

The geotechnical boring method requires drilling a bore hole about 4-inches in diameter to collect core samples for evaluation of the subsurface geology. The results of the boring will help the project engineers identify the physical properties of the soil and geology in order to support a successful horizontal directional drill (HDD) design. Considerations for HDD design includes identifying the appropriate vertical separation between the pipeline and features crossed (e.g., catlinite). For a water body crossing, water depth and width (including floodplain width) are taken into account to identify the placement of HDD entry and exit locations as well as depth below the stream.

For the 2023 field season, Magellan has invited tribal participation in survey alongside the archaeological team to identify and document cultural resources, including resources of religious and cultural importance to tribes. Additionally, Magellan plans to work with interested tribes in implementing a tribal monitoring plan during construction. We welcome the Band's participation in these survey and monitoring efforts.



The purpose of this call was to follow up on the email from Susan Klapel dated March 31, 2023 regarding a map of the Pipestone Reroute Pipeline enclosed in a letter from Magellan dated March 21, 2023.

Susan Klapel confirmed that she expected to see a new pipeline reroute that avoids public land sections identified in a letter from the Tribe's Commissioner of Natural Resources dated March 7, 2023. Ms. Klapel stated that the pipeline route, as currently proposed, crosses a tribally important area. She requested another call with Magellan representatives on April 10, 2023 to discuss the Project in more detail.
