Dear Dr. Haar:

Interstate Power and Light Company (IPL) is filing this letter as a Reply to the Minnesota Department of Commerce, Division of Energy Resources' (Department), September 5, 2013 Comments in Docket No. E999/AA-11-792.

In its September 5 Comments, the Department recommends that the Commission should convene a meeting to discuss aspects of how the fuel clause adjustment (FCA) operates:

“the Department recommends that the Commission convene a meeting with all interested parties to discuss the benefits, difficulties, expectations and other matters pertaining to the operation of the FCA. It is critical to hear the views of all parties and the views of the Commissioners about how the FCA operates and how it should operate in the future. This meeting is intended to be a check-in where participants can share their views. If, at the end of that meeting, there is an agreement to proceed with the E999/AA-12-757 docket, that process could move forward.”

IPL is willing to participate in such a meeting, and agrees that this meeting would be a good venue for all interested parties to discuss the current and future operation of the FCA in Minnesota.
