

Coneflower Energy, LLC (Coneflower), an indirect subsidiary of Apex Clean Energy Holdings, LLC (Apex) has proposed the Coneflower Solar Project (Project), an up to 235-megatwatt solar project in Lyon County, Minnesota. The Project is situated on approximately 2,299 acres of privately owned land north of the town of Garvin and east of the town of Balaton (Project Area). As you may recall, we reached out to you in September of 2023 to introduce the Project and request comments as part of the Site Permit Application process for the Project to the Minnesota Public Utilities Commission (MPUC).

We received responses to our outreach from you, the Leech Lake Band of Ojibwe, Lower Sioux Indian Community, and Shakopee Mdewakanton Indian Community, as well as the Minnesota Indian Affairs Council (MIAC). We were delighted that you responded and joined us to take part in the field survey for the Project!

As you are aware, Coneflower hired an independent cultural consultant, Impact 7G, Inc. (Impact 7G), to coordinate with your tribal cultural specialists (TCSs) and perform the field surveys. Between November 2023 and January 2024, Impact 7G principal archeologist Kurt Lanno, archeologists Reuben Weston, Haidyn Weber, Adam Sax, and Victor Ponte and archaeological technician Laura Clark, with Upper Sioux Community tribal cultural specialists (TCS) Drew Brockman and Cameron Stennes, completed a Phase I cultural resource survey for the Project. Four areas of cultural interest in two discrete sites, identified as TIS 1 and TIS 2, were identified by your Upper Sioux Community TCSs.

We have notified the 10 Minnesota tribes that the survey occurred and that your TCSs identified two sites. Additionally, we shared more detailed information about the sites with the MIAC as follows:

In the outreach to the 10 tribes, we indicated that if they had questions regarding the sites to please reach out to the MIAC. We also asked the MIAC to reach out to you directly, should they have questions or need further information than what we provided to them. We asked the tribes to communicate directly with the MIAC as we understand these are sensitive resources and we are not at liberty to disclose site details. Please know that Coneflower will not share the details of these sites publicly and will direct any inquiries to the MIAC and to you directly. Thank you for participating in this process, we are sincerely grateful for your input and for the TCS folks who collaboratively worked with our contractor to complete the field work.

Coneflower Energy, LLC (Coneflower), an indirect subsidiary of Apex Clean Energy Holdings, LLC (Apex) has proposed the Coneflower Solar Project (Project), an up to 235-megawatt solar project in Lyon County, Minnesota. The Project is situated on approximately 2,299 acres of privately owned land north of the town of Garvin and east of the town of Balaton (Project Area). As you may recall, we reached out to you in September of 2023 to introduce the Project and request comments as part of the Site Permit Application process for the Project to the Minnesota Public Utilities Commission (MPUC).

In September 2023, and prior to the MIAC's recommendations in the October 17, 2023 email, consistent with Minn. Stat. §10.65, Coneflower also reached out (via email and the U.S. Postal Service) to 11 Minnesota Tribal Nation¹ Tribal Historic Preservation Offices (THPO) for their comments on the Project and to invite their respective communities to assist with the field survey of the Project area. We received responses from four of the tribes: Leech Lake Band of Ojibwe, Lower Sioux Indian Community, Shakopee Mdewakanton Indian Community, and Upper Sioux Community. We were delighted that the Upper Sioux Community responded that they would like to take part in the field survey for the Project.

Coneflower hired an independent cultural consultant, Impact 7G, Inc. (Impact 7G), to coordinate with the tribal cultural specialists (TCSs) and perform the field surveys. The
