Dear Judge Cochran:

Prior to the Parties filing their Initial Briefs in this matter, the Administrative Law Judge requested that the Parties address the issue of the Commission's authority to impose the Department of Commerce – Division of Energy Resources' ("DOC-DER") "neutral footprint" condition on Minnesota Pipe Line Company, LLC ("MPL"). MPL addressed the issue in its Initial Brief. DOC-DER did not, but set forth its position for the first time in its Reply Brief. In the course of doing so, DOC-DER mischaracterizes MPL's position. MPL files this brief response to clarify its position and to provide its reply to the DOC-DER.

DOC-DER implies in its Reply Brief that MPL disputes the Commission's authority to ever condition a Certificate of Need or to approve modifications to a project. MPL has said no such thing. As MPL stated in its Initial Brief: "[N]othing in Minnesota law provides authority for the Commission to require additional actions by an applicant once that applicant has already established that its project passes muster under the Commission's criteria for granting a CON." (Emphasis added.) MPL agrees that the Commission can approve a "suitable modification" to a project or condition a Certificate of Need as necessary to bring a proposed project into compliance with the Certificate of Need criteria set forth in Minnesota Rules. The issue is whether, when the record demonstrates and all parties agree that the criteria have been met, the Commission can nonetheless add requirements that go beyond the scope of the project.

MPL and DOC-DER (the only two parties in the proceeding) <u>agree</u> that MPL has met the criteria necessary for a Certificate of Need. The DOC-DER Initial Brief nonetheless argues that the Commission can approve "suitable modifications" to a project and should do so in this case by requiring MPL to implement a "neutral footprint" policy. However, the rules make clear that any such "suitable modifications" can be approved in order to bring that project into compliance with the Rule criteria. The rules provide no authority for the Commission to impose new requirements on an applicant when the criteria have already been met. Additionally, the "neutral footprint" policy recommended by DOC-DER does not "modify" the size, type or timing of the Project or any other aspect of the Project itself. Rather, it would add a new condition to the duly established rule criteria for the granting of a Certificate of Need. As MPL has discussed, such new requirements exceed the current rule requirements and, if intended to be applied to future projects, require either new legislation or amended Certificate of Need Rules.
