**PREHEARING ORDER**

On September 12, 2025, Administrative Law Judge Jim Mortenson convened a telephonic prehearing conference in this matter.

Haley Waller-Pitts, Fredrickson & Byron, P.A., appeared on behalf of Xcel Energy (Applicant), along with the following representatives for Applicant: Mike Aasen and Tyler Beemer.

Jean Coleman, General Counsel, Craig Janezich, Energy Facility Planner, and James E. Sullivan, Environmental Review Manager, appeared on behalf of the Public Utilities Commission (PUC) staff.

Interested persons are invited and encouraged to participate in this process and need not intervene as a party. Interested persons can subscribe to the case using the PUC Docket number in eDockets and monitor filings and attend one of the public hearings. At the public hearings, interested persons may make comments and ask questions of the Applicant and the PUC staff. Interested persons should address whether the proposed project meets criteria under Minn. Stat. ch. 216E, 216G (2024) and Minn. R. ch. 7849, 7850, 7852 (2025).

Based upon the record and the discussion among the participants at the prehearing conference,

2. At the hearing, the Judge will open the hearing. The PUC staff will then give brief presentations about the permitting process and the EA. During the first hearing, Applicant will offer any pre-filed testimony and exhibits to be entered into the record. At both hearings Applicant will provide an oral summary of the application. The presentations may be supplemented with visuals.

3. Following Applicant's presentation, the Judge will permit members of the public to make oral presentations, present documentary evidence, and ask questions of Applicant and PUC staff. Questions from the public will be entertained by the Applicant and PUC staff as appropriate. Questions which cannot be answered at the hearing must be answered in writing in accordance with the schedule above. The individuals who testified in writing on behalf of Applicant must be present and prepared to answer questions about their testimony.


