Invenergy Renewables LLC (Invenergy) respectfully submits this letter in response to the Minnesota Public Utilities Commission (Commission) Notice of Comment Period, issued November 17, 2025, in the above-referenced dockets. On November 10, 2025, Invenergy filed a Response and Request for Action, in accordance with Order Point 18 of the Commission's April 21, 2025 Order Approving Settlement Agreement with Modifications, requesting that the Commission require Xcel Energy (Xcel) to resume power purchase agreement (PPA) negotiations in good faith with Invenergy and requesting expedited treatment. These comments expand on the need for an expedited resolution.

As discussed in Invenergy's Response and Request for Action, Lake Wilson is in the advanced stage of development and cannot proceed any further without a finalized PPA. If a finalized PPA cannot be reached by December 31, 2025, the project faces significant risks of moving forward because many variables will be introduced that could thwart the project.

The following are three examples of added risk to the project if a PPA is not finalized by 2026. First, Invenergy's preferred Engineering, Procurement and Construction (EPC) contractor may no longer be available if the EPC contract is not executed soon. Second, if Lake Wilson cannot reach commercial operations by December 31, 2027, Invenergy will have to seek a waiver from FERC to avoid termination of its Generator Interconnection Agreement. Third, local farmers who have leased land to Invenergy for Lake Wilson will likely be harmed, which is further explained below.

Lake Wilson was selected by the Commission to meet Xcel's firm dispatchable need and farmers expected a PPA to be finalized by now. Instead, farmers are forced to pivot and purchase inputs and prepare the ground for planting next season. Farmers who rent their land to tenants face additional timing challenges. If a PPA is not finalized soon, farmers could have more at risk. Moreover, approving a PPA with Lake Wilson will provide these farmers with another source of income for years to come.

In conclusion, if a PPA is not finalized by the end of the year, the delay has a cascading effect to the project and the local community. Minnesota Rule 7829.1200 allows for an expedited proceeding when appropriate. Invenergy urges the Commission to take up its request as soon as possible so a PPA can be finalized, and the Commission can consider the Lake Wilson PPA alongside the other PPAs included in Xcel's September 26, 2025 Petition for Approval of PPAs.
