Lemon Hill Solar, LLC (Lemon Hill Solar), submits these comments in response to a public comment from Mr. Mike Keefe regarding a voicemail he received from a representative of Ranger Power, LLC (Ranger Power) regarding the Lemon Hill Solar project (Project). Lemon Hill Solar takes these concerns seriously and appreciates Mr. Keefe's engagement in the permitting process for the Project.

Lemon Hill Solar and its developer, Ranger Power, believe that community outreach is a vital part of the project development process and that outreach to community members must be conducted with the highest standards of professionalism, transparency, and respect. Lemon Hill Solar believes its outreach efforts align with the Minnesota Public Utilities Commission's (Commission) expectations for stakeholder engagement.

Lemon Hill Solar confirms it contacted individuals who submitted a public comment in this docket who included their contact info in their public comment. Lemon Hill Solar left voicemails for people whom the Project representative could not reach over the phone. On these phone calls and voicemails, as stated in Mr. Keefe's comment, the Project representative introduced themselves and provided their contact information in case the public commenter would like to learn more about the Project or discuss their concerns directly with the representative.² These contacts were brief, respectful, and nonconfrontational. Ranger Power has found that personal contacts are often the best way to foster long-term relationships and provide timely responses to individual concerns.
