Dear Ms. Bergman:

Xcel Energy appreciates the Energy CENTS Coalition's (ECC) continued engagement and constructive partnership in this proceeding, particularly its focus on advancing solutions that support customers facing affordability challenges.

The Company writes to confirm its general alignment with the core elements reflected in ECC's proposed and supported decision options. The Company notes that the ALJ's recommended return on equity of 9.8 percent reflects a thorough analysis of the evidentiary record. Regardless, the Company agrees that adoption of the Company's proposed capital structure and a decrease from the ALJ's recommendation to no lower than a 9.6 percent return on equity, consistent with Commissioner Sullivan's recently filed Decision Option 2021A—together with the Company's proposed affordability commitments—represents a balanced outcome that supports continued access to capital, maintains credit quality, and enables the Company to meet its obligations to serve customers reliably and safely.

The Company also appreciates ECC's recognition of the importance of the Residential Arrearage Management Program (RAMP) and the shared objective of ensuring that RAMP delivers meaningful benefits to customers while supporting the Company's long-term financial health. The Company remains committed to implementing RAMP consistent with the framework proposed in this proceeding, including the collaborative approach to identifying sustainable funding mechanisms over time. To that end, the Company agrees with ECC's proposal that we will provide

Company resources, supplementing the reduced late fee revenue, sufficient to ensure RAMP is funded to \$6 million per year in 2027 and 2028. We estimate this will result in a Company contribution of about \$4 million per year, or \$8 million in total, to the program. And to the extent RAMP continues to be needed after 2028, the Company will work with ECC and others to explore funding from the Affordability Credit Rider.

We appreciate ECC's acknowledgment that affordability and financial integrity are increasingly interrelated considerations, both for customers and for the Company. In that regard, the Company's commitment to contribute toward RAMP reflects a significant step to support customers while still enabling the continued investments necessary to serve the system reliably. We believe that ECC's proposed decision options, taken together, reinforce both customer affordability initiatives and the financial stability that underpins them. The Company also agrees that well-designed affordability programs can improve customer outcomes while also reducing arrearages and bad debt, ultimately benefiting all stakeholders.

Assuming no other adjustments to the ALJ's recommendation, this proposal would result in average annual rate increases of approximately 2.7 percent for 2025, and 3.6 percent for 2026, well below the current year-over-year rate of inflation in the overall economy of 4.2 percent, as measured by the consumer price index.

We appreciate the Commission's encouragement to find common ground on these important issues and respectfully request that you adopt this framework in your final order.
