PETITION FOR APPROVAL OF A NATURAL GAS CONSERVATION

IMPROVEMENT PROGRAM ADJUSTMENT FACTOR

Dear Mr. Bull:

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission this Letter updating the Proposed 2025/2026 Natural Gas CIP Adjustment Factor submitted on April 1, 2025 (April 2025 Proposal).

The Minnesota Department of Commerce, Division of Energy Resources (Department) recommended approval of our April 2025 Proposal of \$0.023370 per therm in their Comments submitted on August 14, 2025. At the time of initial filing, the Company had not yet updated the Conservation Cost Recovery Charge (CCRC) in accordance with the most recent natural gas rate case. After adjusting for actuals, and utilizing the updated CCRC, we are requesting to decrease the 2025/2026 Natural Gas CIP Adjustment Factor to \$0.014081 per therm to move the December 2026 balance as close to \$0 as possible.

Updated Natural Gas CIP Adjustment Factor

We provide as Attachment A, an update of the natural gas DSM Cost Recovery and Incentive Mechanism Tracker and Balance. The update includes two adjustments the Company historically makes for accuracy of our future trackers. We describe these below:

1) The 2025 Tracker has been updated with Actual Spend and CIP Adjustment Factor Recovery through July 2025.

2) The resulting CIP Tracker Rate has been updated beginning on October 1, 2025.

As a result of these adjustments, the resulting factor has decreased from our originally submitted filing from \$0.023370 per therm to \$0.014081 per therm.

Updated Customer Bill Message

The following bill message will alert our natural gas customers to the updated CIP Adjustment Factor:

Effective December 1, 2025, the Resource Adjustment line item on your bill has increased due to a change in the Conservation Improvement Program (CIP) factor. The natural gas CIP portion of the Resource Adjustment is \$0.014081 per therm.

In conclusion, we recommend the Commission approve the following:

- Approve a performance incentive of \$4,313,292 for 2024 ECO activities.
- Approve Xcel's 2024 ECO tracker account, resulting in a December 31, 2024 tracker balance of \$3,004,761.
- Approve a CIP Adjustment Factor of \$0.014081 per therm to be effective October 1, 2025, or the first month following the Commission's Order in this proceeding.
- Approve the Company's proposed bill message effective the first month the proposed CIP Adjustment Factor takes effect: Effective December 1, 2025, the Resource Adjustment line item on your bill has increased due to a change in the Conservation Improvement Program (CIP) factor. The natural gas CIP portion of the Resource Adjustment is \$0.014081 per therm.

Applicable to bills for gas and/or transportation service provided under the Company's retail rate schedules. Exemptions are as follows:

"Large Energy Facility," as defined in Minn. Stat. 216B.2421 customers shall receive a monthly exemption from conservation improvement program charges pursuant to Minn. Stat. 216B.16, subd. 6b Energy Conservation Improvement. Upon exemption from conservation program charges, the "Large Energy Facility" customers can no longer participate in any utility's Energy Conservation Improvement Program.

Upon exemption from conservation program charges, the "Commercial Gas Customers" can no longer participate in the Company's Energy Conservation Improvement Program. The Company has fewer than 600,000 natural gas customers in Minnesota, thus making the Company subject to this Minnesota Statute.

RIDER

There shall be included on each non-exempt customer's monthly bill a Conservation Improvement Program (CIP) Adjustment, which shall be calculated by multiplying the monthly applicable billing therms for gas service by the CIP Adjustment Factor.

DETERMINATION OF CONSERVATION IMPROVEMENT PROGRAM ADJUSTMENT FACTOR

The CIP Adjustment Factor shall be calculated for each customer class by dividing the Recoverable Conservation Improvement Program Expense by the Projected Retail Sales for a designated recovery period. The factor may be adjusted annually with approval of the Minnesota Public Utilities Commission. The CIP Adjustment Factor for all rate schedules is:

Recoverable Conservation Improvement Program Expense shall be the CIP expense not recovered through base rates as determined from the CIP Tracker account balance for a designated period. All costs appropriately charged to the CIP Tracker Account shall be eligible for recovery through this Rider. All revenues received from the CIP Adjustment Factor shall be credited to the CIP Tracker Account.

<u>Projected Retail Sales</u> shall be estimated therm sales to all non-exempt customers for the designated recovery period.
