ORDER ACCEPTING APPLICATIONS, SETTING REVIEW PROCEDURES, AUTHORIZING TASK FORCE, AND GRANTING VARIANCES

### PROCEDURAL HISTORY

On August 27, 2021, Byron Solar, LLC, filed an application for a certificate of need to construct a new photovoltaic solar energy generating facility of up to 200 megawatts (MW) and three miles of new 345-kilovolt (kV) high-voltage transmission line in Olmsted and Dodge Counties.

On August 30, 2021, Byron Solar filed a joint application for a site permit for the solar project and a route permit for the transmission line under the alternative review procedures set forth in Minn. Stat. § 216E.04 and Minn. R. 7850.2800 to 7850.3900.

On September 9, 2021, the Department of Commerce, Division of Energy Resources (the Department) filed comments recommending that the Commission find Byron Solar's certificate-of-need application substantially complete.

On September 24, 2021, the Department of Commerce, Energy Environmental Review and Analysis unit (EERA) filed comments recommending that the Commission accept the site- and route-permit application as complete and recommending joint review proceedings for the certificate-of-need and permit applications.

On September 24, 2021, the Dodge County Board (Dodge County) filed comments raising concerns about proposed locations and potential project impacts, requesting contested-case proceedings, requesting the appointment of an advisory task force, and recommending separate review of the certificate-of-need application before considering the permit application. Laborers International Union of North America Minnesota & North Dakota (LIUNA) filed comments supporting the proposed project as a source of local jobs and other economic benefits.

On October 1, 2021, EERA filed reply comments including a proposed advisory-task-force establishment, charge, and order. Byron Solar also filed reply comments.

On October 28, 2021, the matters came before the Commission.

#### FINDINGS AND CONCLUSIONS

# I. Summary of Commission Action

In this order, the Commission will (1) accept Byron Solar's certificate-of-need application and joint site- and route-permit application as complete; (2) establish joint informal and alternative review proceedings for the need, siting, and routing issues, including combined environmental review; (3) authorize a citizen advisory task force; (4) set additional requirements for the applicant; and (5) grant variances to certain timing rules.

## **II.** Application Completeness

# A. Legal Standard

No large energy facility may be sited or constructed in Minnesota without a certificate of need.<sup>1</sup> An electric power generating plant with a capacity of at least 50,000 kilowatts (kW) is a large energy facility, as is a high-voltage transmission line with a capacity of 200 kV or more that is greater than 1,500 feet in length.<sup>2</sup> Byron Solar's proposed solar project and transmission line are large energy facilities under these definitions and, therefore, require a certificate of need.

Minn. R. 7849.0240, 7849.0250, and 7849.0270 to 7849.0340 list the information an applicant must include in a certificate-of-need application. However, the Commission has exempted Byron Solar from certain application-content requirements in this case pursuant to Minn. R. 7849.0200, subp. 6, having found those items unnecessary to determine the need for this proposed project and having required Byron Solar to file alternative data where applicable.<sup>3</sup>

The construction of a large electric generating plant, defined as electric power generating equipment capable of operation at a capacity of 50,000 kW or more, also requires a site permit. Byron Solar's proposed solar project falls within this definition and, therefore, requires a site permit. Additionally, the construction of a high-voltage transmission line—a conductor of electric energy designed for and capable of operation at 100 kV or more and longer than 1,500 feet—requires a route permit from the Commission. Byron Solar's proposed transmission line falls within this definition and, therefore, requires a route permit.

Site- and route-permit applications must include information about the applicant, the project, proposed sites and landowners, environmental impacts and mitigation, and any federal, state, and local permits that may be required, as set forth in Minn. R. 7850.1900 and 7850.3100.

The Commission may either accept an application as complete or reject it, identify application deficiencies, and allow the applicant to correct the deficiencies and resubmit the application.<sup>6</sup>

#### B. Comments

The Department reviewed Byron Solar's certificate-of-need application and concluded that it contained all the information required under Minn. R. ch. 7849 except the items Byron Solar was exempted from providing. It therefore recommended that the Commission find the certificate-of-need application substantially complete.

EERA reviewed the site- and route-permit application and concluded that it contained complete information under Minn. R. 7850.1900 and 7850.3100. However, EERA requested that Byron Solar clarify which landowners have property affected by the proposed solar farm site and which have property affected by the proposed transmission-line route. With Byron Solar's agreement to provide this information, EERA recommended that the Commission accept the site- and route-permit application as complete.

LIUNA filed comments supporting the proposed project and asserting that the certificate-of-need application contains the complete required information.

Dodge County requested further information about the proposed project, site, and impacts, but it did not identify any specific required items that were missing from the applications.

### C. Commission Action

Based on a review of the application materials, applicable rules, and party comments, the Commission concludes that Byron Solar's certificate-of-need application and site- and route-permit application contain the information required under Minn. R. ch. 7849 and 7850, respectively. The Commission therefore will find the certificate-of-need application substantially complete and accept the site- and route-permit application as complete.

## III. Joint or Separate Review

## A. Legal Standard

The Commission will hold a joint hearing to consider both permitting and need issues for a project if joint proceedings are feasible, more efficient, or otherwise in the public interest.<sup>7</sup>

A certificate-of-need application for a high-voltage transmission line or a large electric generating plant ordinarily requires the preparation of an environmental report under Minn. R.

7849.1200, while the alternative review process for a site or route permit requires an environmental assessment under Minn. R. 7850.3700.

However, if an applicant for a certificate of need applies for a site or route permit for the same project before an environmental report has been completed for the certificate of need, the environmental-review requirements for both applications may be satisfied through a combined environmental assessment in lieu of an environmental report.<sup>8</sup>

#### B. Comments

Byron Solar asked the Commission to process the certificate-of-need and permit applications together and allow a combined environmental assessment for both in lieu of an environmental report. Byron Solar argued that processing the applications together would be more efficient and less confusing for members of the public because the applications relate to the same interconnected projects and reviewing both will involve overlapping issues.

The Department, EERA, and LIUNA supported Byron Solar's request for combined review.

Dodge County recommended that the Commission review the certificate-of-need application separately before reaching the permit application, arguing that there is no need to determine siting and routing details until it is first determined that there is a need for the project.

### C. Commission Action

The Commission will authorize joint public meetings, joint comment periods, joint public hearings, and a combined environmental assessment for the certificate-of-need and site- and route-permit applications. Because the certificate-of-need and permitting processes will involve overlapping issues and will concern many of the same parties and members of the public, the Commission concludes that reviewing the need, siting, and routing issues jointly is feasible, will be more efficient than separate proceedings, and will further the public interest by facilitating convenient public participation and comprehensive record development.

## IV. Review Procedures

### A. Legal Standard

Minn. Stat. § 216E.04 and Minn. R. 7850.2800 to 7850.3900 establish an alternative review process that an applicant for an eligible site or route permit may elect instead of the generally applicable permitting procedure. Projects eligible for alternative review include large electric generating plants powered by solar energy and high-voltage transmission lines with less than five miles of length in Minnesota. The proposed project meets these criteria and, therefore, Byron Solar's site- and route-permit application is eligible for alternative review procedures.

Minn. R. 7829.1200 also generally authorizes the Commission to use informal proceedings when contested-case proceedings are not required. Contested-case proceedings generally are required if a matter involves contested material facts and there is a right to a hearing.<sup>10</sup>

## **B.** Comments

Byron Solar requested that the Commission review the certificate-of-need application under the informal review process permitted in Minn. R. 7829.1200 and review the permit application under the alternative process defined in Minn. Stat. § 216E.04 and Minn. R. 7850.2800 to 7850.3900. Byron Solar also supported requesting that an administrative law judge (ALJ) preside over the public hearing and prepare a report with findings, conclusions, and recommendations. Byron Solar argued that there are no contested fact issues requiring contested-case proceedings.

The Department, EERA, and LIUNA agreed that contested-case proceedings did not appear necessary and that the Commission's informal notice-and-comment process, combined with the alternative permitting process, would be sufficient in this case.

Dodge County initially argued that public concerns with the project warrant referral to the Office of Administrative Hearings for contested-case proceedings. At the October 28, 2021 Commission meeting, however, Dodge County agreed that the procedures discussed at the meeting and adopted herein—including EERA's and Byron Solar's agreement to work with the county to identify a venue for a public hearing near the proposed project site, Byron Solar's commitment to respond to county and public requests for information throughout the process, and the authorization of a task force including local-government representatives—would provide adequate opportunities to voice and address local concerns without the need for a contested case.

## C. Commission Action

As requested by the applicant, the Commission will authorize these proceedings to follow the informal review process permitted in Minn. R. 7829.1200 and the alternative review process defined in Minn. Stat. § 216E.04 and Minn. R. 7850.2800 to 7850.3900, and will not refer the matter to the Office of Administrative Hearings for contested-case proceedings at this time.

Based on the comments submitted and the record developed to date, the Commission finds that Byron Solar's proposed solar farm and transmission line meet the eligibility requirements for informal and alternative review under the statutes and rules discussed above. Further, those processes are sufficient to allow robust public participation and record development, and no contested fact issues have been identified that would require a contested case on this matter.

To facilitate public participation and record development, the Commission will request that an ALJ serve as the hearing examiner and prepare a report including findings of fact, conclusions of law, and recommendations. The Commission will also ask the ALJ to set the schedule for any testimony and post-hearing briefing in consultation with interested parties as necessary. The public hearing and comment process and the ALJ's report will provide a thorough, efficient, and transparent method to develop a complete record and fully explore any issues that emerge.

To allow convenient public participation, EERA and Byron Solar have agreed to work with local-government representatives to select a venue for an in-person public hearing near the proposed project site. To help facilitate public participation, the Commission will appoint Cezar Panait to act as the public advisor for this project pursuant to Minn. R. 7850.3400.

The Commission requests that the Department and EERA continue to examine the issues that arise in these proceedings and provide comments or testimony on the need for the project and the reasonableness of the proposed permits. Byron Solar shall facilitate the continuing examination in every reasonable way as requested by the Department, EERA, and Commission staff, and is expected to work with impacted local units of government as agreed at the Commission meeting.

For purposes of these proceedings, the Commission will delegate administrative authority, including authority to resolve timing issues, to the Executive Secretary.

## V. Citizen Advisory Task Force

## A. Legal Standard

The Commission may choose to appoint a citizen advisory task force to serve a specified charge to aid in the permitting process.<sup>11</sup> A task force must include representatives of regional development commissions, counties and municipal corporations, and one town board member from each county in which a site or route is proposed to be located.<sup>12</sup>

### **B.** Comments

Dodge County requested that the Commission appoint a citizen advisory task force to allow representatives of varying perspectives an opportunity to consider how zoning, permitting, and other regulations can equitably address new solar development while protecting existing economic interests of local residents.

Byron Solar argued that a task force is not warranted because this type of project is exempt from requirements to propose alternative sites, which is a traditional focus of advisory task forces. Additionally, Byron Solar argued that involving a task force is complex and time-consuming and that Dodge County has not justified the need for one. It argued that the Commission's comment and public-participation processes allow adequate opportunities for stakeholder and public concerns to be heard without the need for a task force.

EERA initially argued that a task force was unnecessary; however, after consulting with Dodge County, EERA recommended that the Commission authorize the establishment of a task force to inform the scope of the environmental review by assisting EERA in identifying impacts and issues of local concern, mitigation measures, and site or route alternatives that should be analyzed in the environmental assessment.

EERA prepared a draft advisory-task-force establishment, charge, and order and proposed a revised application-review schedule that would allow time to solicit task-force members, hold task-force meetings, and prepare a report prior to issuance of an environmental scoping decision.

## C. Commission Action

The Commission finds that the authorization of an advisory task force is reasonable and in the public interest and will aid in the environmental-review scoping process for Byron Solar's proposed high-voltage transmission line and solar project. Accordingly, the Commission will authorize a task force for these matters under Minn. Stat. § 216E.08, subd. 1, and Minn. R. 7850.3600, and will approve the proposed establishment, charge, and order filed with EERA's October 1, 2021 reply comments, with the modifications noted below.

As EERA proposed, the task force shall solicit members from the governmental units of Dodge County, Olmsted County, the Minnesota Department of Transportation, the City of Kasson, and the townships of Canisteo, Mantorville, and Kalmar. The proposed project borders and may also be located partially within the City of Byron, so Byron shall also be solicited for task-force members.

In accordance with EERA's proposal, the task force shall be charged with: (1) assisting in identifying impacts and issues of local concern that should be analyzed in the environmental assessment, and (2) assisting in identifying mitigation measures, including site or route alternatives, which should be analyzed in the environmental assessment.

The charge adopted herein reflects the task force's minimum obligations; it shall not be interpreted to limit the scope or extent of participation available to the task force or its members. As EERA agreed at the Commission meeting, the task force will be free to examine and advise on concerns beyond the scope of its charge, and it may continue to participate after the official charge is completed at its option. Likewise, Byron Solar agreed to work with the task force beyond the charge if the task force so chooses.

# VI. Additional Requirements

To facilitate public awareness and participation, the Commission will require Byron Solar to place a copy of its applications in the Dodge County Environmental Services office in the Dodge County Government Services Building and in the planning and zoning departments in Kasson's and Byron's city halls. Additionally, Byron Solar must place a copy of the applications in at least one public library near the proposed project site. The applicant shall also offer a copy to the township boards of Kalmar, Canisteo, and Mantorville, and provide physical copies if requested.

Further, Byron Solar must work with EERA and Commission staff to arrange for the publication of notices of public information meetings and public hearings in newspapers of general circulation. The notices must be visible display ads and must adhere to the timelines prescribed by rule and statute. Byron Solar shall provide proof of publication of these notices.

Additionally, the Commission will require Byron Solar to file updates on the project's status in the Midcontinent Independent System Operator (MISO) interconnection process at the following times: (1) in January of 2022, (2) two weeks before the public information meeting, (3) two

weeks before the public hearing, and (4) two weeks before the Commission's agenda meeting on the final certificate-of-need and permit decisions.

#### VII. Rule Variances

Under Minn. R. 7829.3200, the Commission will grant a variance to its rules if it determines that (1) enforcement of the rule would impose an excessive burden upon the applicant or others affected by the rule, (2) granting the variance would not adversely affect the public interest, and (3) granting the variance would not conflict with standards imposed by law.

# A. Minn. R. 7849.0200, subp. 5

Minn. R. 7849.0200, subp. 5, requires the Commission to determine the substantial completeness of a certificate-of-need application within 30 days of receipt of the application.

Based on the totality of the circumstances, the Commission finds it appropriate to vary the 30-day timeframe of Minn. R. 7849.0200 in this case because (1) enforcing the rule would impose an excessive burden on the public, the Department, and the Commission by not allowing adequate time to review the application, solicit and consider comments, hold a meeting, and prepare a written order; (2) varying the rule would not adversely affect the public interest as it would allow more time for public participation and consideration of the application and comments; and (3) varying the 30-day rule would not conflict with standards imposed by law.

The Commission therefore will grant a variance to Minn. R. 7849.0200, subp. 5.

## B. Minn. R. 7850.3700, subp. 3

Minn. R. 7850.3700, subp. 3, requires the Department of Commerce to determine the scope of the environmental assessment within 10 days after the close of the public comment period.

To allow EERA sufficient time to consider comments and any site or route alternatives proposed in the scoping process, the Commission finds good cause under the Minn. R. 7829.3200 factors to vary the 10-day timeline of Minn. R. 7850.3700, subp. 3, and to request that EERA submit any draft site alternatives for Commission input before issuing a scoping decision. In this case, (1) enforcing the 10-day rule would excessively burden EERA by not allowing adequate time to consider comments and proposed alternatives and draft a scoping decision, (2) varying the rule would not adversely affect the public interest as it would allow more time for thorough consideration, and (3) varying the rule would not conflict with standards imposed by law.

The Commission therefore will grant a variance to Minn. R. 7850.3700, subp. 3.

### **ORDER**

- 1. The Commission accepts the certificate-of-need application as substantially complete.
- 2. The certificate-of-need application shall be reviewed using the informal review process under Minn. R. 7829.1200.

- 3. The Commission accepts the joint site- and route-permit application as complete and authorizes review under the alternative permitting process defined in Minn. Stat. § 216E.04 and Minn. R. 7850.2800 to 7850.3900.
- 4. The Commission approves joint public meetings, joint comment periods, joint public hearings, and combined environmental review of the certificate-of-need and site-permit and route applications to the extent practical.
- 5. The Commission requests that the Department of Commerce, Energy Environmental Review and Analysis unit (EERA) prepare an environmental assessment in lieu of an environmental report pursuant to Minn. R. 7849.1900.
- 6. The Commission authorizes the establishment of an advisory task force and approves EERA's proposed structure and charge based on the charge and order filed by EERA, with the addition of also soliciting the City of Byron for possible members.
- 7. The Commission will appoint an ALJ to serve as the hearing examiner for a summary proceeding, and will request preparation of findings of fact, conclusions of law, and recommendation of a preferred site and permit conditions. The Commission requests that the ALJ determine the schedule for any testimony and post-hearing briefing in consultation with interested parties, as necessary.
- 8. The Commission delegates administrative authority, including timing issues, to the Executive Secretary.
- 9. The Commission appoints Cezar Panait as the Commission's public advisor who will facilitate citizen participation in the process.
- 10. The Commission requests that the Department of Commerce, Division of Energy Resources (the Department) and EERA continue to study the issues and indicate during the hearing process, through testimony or comment, their positions on the reasonableness of granting a site permit.
- 11. The applicant shall facilitate in every reasonable way the continued examination of the issues requested by the Department, EERA, and Commission staff.
- 12. The applicant shall place a copy of the certificate-of-need and site-permit applications in the Dodge County Environmental Services Office in the Dodge County Government Services Building, in the planning and zoning departments in the respective city halls of Kasson and Byron, and in a public library located close to the proposed project site. The applicant shall also offer and provide a physical copy, if requested, to the township boards of Kalmar, Canisteo, and Mantorville Townships.
- 13. The applicant shall work with Commission staff and Department of Commerce staff to arrange for publication of the notices related to public information meetings and public hearings in newspapers of general circulation under the timelines prescribed in rule and statute. Such notice shall be in the form of visible display ads, and proof of publication shall be obtained and provided to Commission staff.

- 14. In January 2022, two weeks before the public information meeting, two weeks before the public hearing, and two weeks before the Commission meeting, the applicant shall eFile a written update on the project's status in the MISO interconnection process.
- 15. The Commission grants a variance to Minn. R. 7849.0200, subp. 5, and extends the 30-day timeline.
- 16. The Commission grants a variance to Minn. R. 7850.3700, subp. 3, extends the 10-day timeline, and requests that EERA present draft site alternatives to the Commission for its input prior to the issuance of the final scoping decision.
- 17. This order shall become effective immediately.
