# Appleton to Benson 115-kV transmission line

Great River Energy, Otter Tail Power Company, Missouri River Energy Services, Benson Municipal Utilities and Agralite Electric Cooperative are proposing to construct an approximately 28-mile, 115-kilovolt (kV) transmission line between Appleton and Benson, Minn. A Certificate of Need and Route Permit will be required from the Minnesota Public Utilities Commission (MPUC) before the line can be built. ## Need

The project will address low voltage concerns and enhance transmission reliability in the project area.

## Overview

The map on the back shows the proposed 115-kV transmission line route. Approximately 20 miles of the proposed route will overtake and replace an existing 41.6-kV transmission line with the new 115-kV transmission line.

The new transmission line will be constructed primarily with wood poles, 60 to 90 feet above ground, generally 300 to 400 feet apart. Line angles and changes in direction might require the support of guy wires and anchors or steel poles on concrete foundations. A final design will determine the structure heights, span distances, and need for specialty poles.

## Permitting and public involvement

The MPUC is the permitting authority for this project. The MPUC and the Department of Commerce – Energy Environmental Review and Analysis (DOC-EERA) will hold public meetings to receive comments and suggestions. Additional opportunities to provide input will be available throughout the permitting and analysis process. DOC-EERA will prepare an environmental assessment for the project.

## Easements

New or amended easements may be requested to provide adequate land rights for construction, operation, and maintenance of the new line. Property owners will be contacted by a project representative during the MPUC permitting process to begin the easement acquisition process. Easement negotiations will include a copy of the route permit, proposed pole locations, and review of the easement and compensation arrangements, along with information on tree removal, construction access, crop damage payments, and restoration of the right of way.





The new transmission line will be constructed primarily with wood poles that will be 70 to 90 feet above ground, and generally 350 to 400 feet apart, the power companies say.

Property owners will be contacted by a project representative during the Minnesota Public Utilities Commission (MPUC) permitting process to begin the easement acquisition process.

New or amended easements may be requested to provide adequate land rights for construction, operation, and maintenance of the new line, they say.

Easement negotiations will include a copy of the route permit, proposed pole locations, and review of the easement and compensation arrangements, along with information on tree removal,

construction access, crop damage payments, and restoration of the right of way, according to the utilities.

Interested property owners and community members are welcome to attend an open house Wednesday, Nov. 1, or Thursday, Nov. 2, to learn more about the project.

Approximately 20 miles of the proposed route will replace an existing 41.6-kV transmission line with the new 115-kV line.

"The open house is an opportunity for property owners and community members to get information about the project and ask any questions they have," Strohfus said.

This is a different project from the one for which there was an open house in Benson last Tuesday.

That project involves a proposal to build a 345-kV transmission line from Big Stone, S.D., to Alexandria. A segment of the transmission line is likely to pass through Swift County's western half and may come close to the City of Benson.

Otter Tail Power Company and Missouri River Energy Services have been conducting the public meetings about the project.

It is a much bigger transmission line than the 115-kV line that will

run from Appleton to Benson. To get an idea of what the 345-kV line will look like, picture the power poles that run along Interstate Highway 94. The new transmission line going to the Alexandria area will connect to those towers, adding a second line for power to the Twin Cities.

Each single pole will have a concrete foundation and average of 150 feet in height. There will be four to six structures per mile and, for now, just one line is proposed for the poles. A second line could be added while the first phase of the project is underway as demand for power in the Twin Cities metropolitan area continues to increase.

While the towers along I-94 are silver galvanized steel, the ones going from Big Stone to Alexandria will be weathering steel,

which has a rust-colored look. Langston said the utility thought they would "go a little better in rural communities."

It is expected to take nearly seven years for additional planning and construction before the lines are finally energized in mid-2030.

Construction of the power will also serve the expanding wind and solar renewable energy projects in place and planned in western Minnesota.

Otter Tail and Missouri River say the new power line will allow more low-cost renewable energy to flow from the generation resources to customers and reduce congestion on the existing transmission system created by an increasing amount of renewable trying to access the power grid.





# Residents seek common ground on nitrate pollution...From 10

they're closely connected to groundwater, they're at risk of pollution.

In Minnesota, several state agencies regulate different aspects of water. The petitioners argue that's led to an ineffective response to the nitrate issue.

"It is so easy for agencies to say, 'Well, I'm just dealing with drinking water. I'm just dealing with surface water. I'm just dealing with water quantity,'" Wotzka said. "Somebody needs to put the big picture together."

In a joint statement, the Minnesota Pollution Control Agency and state health and agriculture departments acknowledged southeastern Minnesota's porous landscape is uniquely susceptible to groundwater contamination, exacerbated by climate change and more extreme rainfalls.

"State agencies, counties,

cities and community members have been working to protect drinking water from nitrate contamination produced by faulty septic systems, agricultural runoffs, landfills and wastewater," they stated.

The agencies mentioned Minnesota's groundwater protection rule, which restricts the use of nitrogen fertilizer in the fall and on frozen soil in vulnerable areas, as well as a nitrogen fertilizer management plan that promotes best practices.

"While progress has been made, more work is required by state agencies, local governments, industry, farmers and homeowners to protect our waters, especially as we continue to adapt to our changing climate," they stated.

## Major source: Cropland farming

Officials from the state Pollution Control Agency say 89 percent of nitrate in southeast Minnesota water comes from commercial fertilizer and manure spread on cropland. That's higher than the statewide average.

The petitioners say state agencies have relied mainly on voluntary approaches to get farmers to reduce nitrogen pollution, which they say haven't worked.

They want the EPA to investigate the sources of nitrate, require those responsible to provide free well testing and, if needed, an alternative source of water.

"It can cost up to \$30,000 to dig a deeper well for a private well owner," Griffith said. "So in lower income rural communities, that can be an unachievable cost to meet."

The petitioners are also calling for a moratorium

on new or expanded large livestock farms until nitrate levels in contaminated wells reach safe levels.

The groups say CAFOs, or concentrated animal feeding operations where animals are raised in confinement, produce too much manure that's applied to farm fields in the region.

Aaron and Amy Bishop live in Harmony Township in Fillmore County, about a mile from the Iowa border. Water from their well, which is more than 600 feet deep, is safe to drink. But many of their neighbors' water isn't, they said.

The Bishops are members of Responsible Ag in Karst Country, a grassroots organization that formed in 2018 in opposition to a proposed hog expansion.

"Obviously, agriculture is a huge contributor to the problem. But these farmers are also our neighbors, and

they drink this water too," Amy Bishop said. "So hopefully, if more information comes out, they'll also recognize that this is the water they drink. And maybe there's some way to start to reduce that."

Some farmers say it's unfair to blame the nitrate problem solely on them.

"As a farm guy, it's hard to read the petition and not view it as an attack," said Warren Formo, executive director of the Minnesota Agricultural Water Resource Center, formed in 2008 by the state's major farm organizations. "It's the tone and the tenor of it, and then singling agriculture out (for) what we see as some pretty drastic requirements."

Many farmers in the region have substantially changed how they handle fertilizer and manure over the last two decades, Formo said. That includes following the state rule restricting the use of commercial fertilizer in sensitive areas in the fall, when it's more likely to leach into the groundwater.

"We haven't seen analysis, specifically in some of these areas, to see if it is making a difference," Formo said.

One farmer voicing concern about the petition is state Rep. Steve Jacob, R-Altura, a former Winona County commissioner serving his first term in the Legislature.

Jacob said he cares about water quality and practices conservation measures on the land where he grows corn and beans, including no-till farming and cover crops. But he doesn't support additional federal involvement.

"There's two approaches: the carrot approach and the stick approach," he said. "They're saying [use] the stick approach. And not only is state and local government not enough, we need to have the federal government come in and bring the stick approach."

Jacob said he's counted more than 30 groups and dozens of programs already addressing water quality in southeast Minnesota.

"We know what best management practices are. And we need to implement those," he said. "We should be streamlining things into less organizations, putting more of those dollars into actual programs on the ground, rather than all these expanded government programs."

Even if the EPA doesn't respond to the petition, environmental groups hope it's raising awareness about the nitrate issue.

They're hosting a series of public forums around the region, including one in Lanesboro on Nov. 16.

"There's just so many people who aren't aware that it's an issue," Amy Bishop said. "So just hopefully getting the conversation started, so that more people start to think about this, and maybe start to be vocal about it."

They're also urging well owners to get their water tested to find out the nitrate level.

The Minnesota Department of Health recommends having your well tested for nitrate every other year, through an accredited lab or your county environmental or public health service.







Capital Investment committee were given an information hand-out on the status of current funding efforts and projected budgets for the next phases in the overall program.

While all these discussion points were briefly addressed, Rep. Anderson stressed an equally important aspect of this site visit. "I know a lot of the members personally ... it comes down to who you know," says Anderson, and adds, "They see a lot of options, they've done four trips around the state." He stressed that "it's critical that the committee remembers Appleton and the importance of the area."

Anderson further explained that when bonding bills come up for a vote in the House, they require a 'super' majority; both parties must endorse it in order to pass. "Bonding bills can become political," he acknowledged. "I don't look for it to come early in the session," he explained, "... but probably later, and that session ends towards the end of May next year."



Minnesota's House State Funding Committee regional tour included a stop at the Appleton Heritage Center.

The total budget currently for all phases for the AHC projects is \$2.4 million. Andersons says that since the PAH is a 501(c)(3) non-profit, that the funding has to be a cash awarding process - sometimes harder to get as there is a lot of competition for that."



Again? Already? That's probably what many people think when hearing that on November 7, LQPV schools are asking voters to approve a \$6.5 million referendum for updating school facilities.

We just had a \$40 million referendum in 2019, and \$13 million was authorized earlier this year for air handling equipment. When you add it up, that's a lot of millions! Do we really need this? Can we afford it? The answers are yes to both, but understanding why and how requires some digging. This letter is about making good financial decisions with public tax dollars, so that we can meet our school facility needs AND best manage the funding burden on our citizens.

This 2023 referendum is the next step into a "new normal." Just like owning a house, you can't just write a big check at the beginning and think you're done. Buildings are a collection of parts, and when worn out they must be replaced.

We've seen the wrong way: ignoring the need for necessary repairs and im-

provements for years simply gives us the illusion of saving money; eventually the bill comes due.

The right way is to take advantage of opportunities. The Ag2School credit means that 56.5 percent of the bill is paid by the state.

The right way is to make consistent but manageable investments over time. If our 2023 referendum is approved, the school will issue 10-year bonds. Then in 2033 we should do it again. We will have a new list of needs, and when one bond issue expires, we'll start paying for a new one. Then repeat in 2043, 2053, and so on.

The right way for taxpayers is boring and predictable. Our school board, administration, and voters must commit to a disciplined long-term plan, so we don't get hit with another \$40 million earthquake followed by aftershocks of \$13 million and \$6.5 million. The next step toward boring and predictable is up to us. Vote Yes on November 7!


