Response to Late Filed Comments

Dear Judge Middendorf:

Minnesota Power and Great River Energy (“Applicants”) provide these comments to clarify the record in response to the comments filed on October 2, 2024, on behalf of Mr. Erickson and Mr. Loehr. Because the comments were untimely filed, the Applicants did not have the opportunity to respond to the comments in the Applicants’ September 19, 2024, filing, which addressed other comments filed by members of the public on the merits of the Northland Reliability Project (“Project”).

Mr. Erickson and Mr. Loehr rely upon a faulty application of the Minnesota Environmental Policy Act (“MEPA”)¹ to assert that one of their preferred route alternatives (H1, H2, or H3) should be selected instead of another route. However, the statute Mr. Erickson and Mr. Loehr quote does not require that the route avoid their particular properties. Rather, both MEPA (Minn. Stat. Ch. 116D) and the Power Plant Siting Act (Minn. Stat. Ch. 216E) reflect that the Commission considers a broader range of criteria. In other words, contrary to Mr. Erickson’s and Mr. Loehr’s assertions, Minnesota law does not require the route to avoid, for example, “School Trust Fund lands,” particularly where the route alternatives preferred by Mr. Erickson and Mr. Loehr in this area would increase proximity to residences.² The route alternatives preferred by Mr. Erickson and Mr. Loehr would increase impacts on different landowners, none of whom expressed support for any of these route alternatives.³ Although Mr. Erickson and Mr. Loehr ignore these and

other factors, the Commission is required to consider them. MEPA does not necessitate a different outcome.⁴

Mr. Erickson and Mr. Loehr also contend, using comments filed by the Minnesota Department of Natural Resources (“MnDNR”) in 2023 as support, that an alternative form of analysis should be used to evaluate segments of the Project where the route does not follow existing high-voltage transmission lines.⁵ Additionally, the commenters allege that the environmental review for the Project “did not acknowledge the existence of Wolverter’s [Aquatic Management Area (“AMA”)] or consider impacts to lands managed by the MnDNR.”⁶ The comments inaccurately represent the record and Minnesota Law.⁷

As to the type of environmental review required for the Project, this issue is settled. Minnesota Statutes and Rules do not outline separate types of review based on what portions of a proposed project do or do not follow existing transmission lines; instead, the type of environmental review is based on the applicable statute under which a project qualifies.⁸ The required environmental review for the Project is the environmental assessment (“EA”) process proscribed by Minn. R. 7849.1000 to 7849.2100 and 7850.1000-7850.5600.⁹ The Department of Commerce – Energy Environmental Review and Analysis (“EERA”) and the MnDNR all concur.¹⁰ There is nothing in the governing law that allows for, let alone requires, segmented review as Mr. Erickson and Mr. Loehr assert. For the Project, the Applicants submitted the Combined Certificate of Need and Route Permit Application under Minn. Stat. § 216E.04, which requires that an EA be completed for the Project in its entirety, and EERA met this requirement.

As to the concerns about the exclusion of the Wolverter’s AMA and discussions related to potential impacts to MnDNR-managed lands, the EA addresses both of these items in the EA. Specifically, EERA revised the EA to add the Wolverter’s AMA on EA maps.¹¹ Finally, the potential impacts of the Project on MnDNR-managed lands were discussed extensively in the record.¹²

The evaluation performed by the Minnesota Public Utilities Commission in selecting a final route for the Project shall include a determination of “whether the [EA] and record created at the public hearing” sufficiently address the issues identified in the

scoping decision. Minn. R. 7850.3900. The EA and record created satisfy the requirements set forth in Minnesota Statutes and Rules.

The comments submitted by Mr. Erickson and Mr. Loehr do not accurately reflect the legal standards that apply to the Commission's review of the Project, nor do they acknowledge the many criteria that must be considered in assessing a route. Thus, even setting aside their untimeliness and procedural irregularity, Mr. Erickson's and Mr. Loehr's proposed findings should not be incorporated.
