Dear Dr. Haar:

Getty Wind Company, LLC provides this notice to the Minnesota Public Utilities Commission ("Commission") that it has closed an acquisition concerning Getty Wind Company, LLC. Effective November 11, 2014, Black Oak Wind, LLC, a wholly-owned subsidiary of Geronimo Wind Energy, LLC d/b/a Geronimo Energy, LLC ("Geronimo"), has replaced Getty Wind, LLC as the owner of Getty Wind Company, LLC.

The Permittee, Getty Wind Company, LLC, has not changed as a result of the acquisition. Thus, the Permittee is not seeking recertification or transfer under Minnesota Rules, parts 7849.0400, subp. 2c; 7854.1400 or 7850.5000. This notice is being provided pursuant to Section 11.5 of the Site Permit issued to Getty Wind Company, LLC, as amended by the Commission on October 30, 2014, and to ensure that the Commission is aware of the change in upstream ownership. Attached is an organizational chart detailing the new ownership structure of Getty Wind Company, LLC.

Geronimo is a utility-scale renewable energy developer based in Edina, Minnesota. In addition to Geronimo's current joint development of the Black Oak and Getty Wind Projects, Geronimo

has developed three operating wind energy projects in southern Minnesota. Geronimo's 200 MW Prairie Rose Project in Rock County, Minnesota was placed in service in December 2012; its 18.9 MW Marshall Wind Farm near Marshall was placed in service in 2009; and its neighboring 20 MW Odin Wind Farm, near Odin, was placed in service in 2007.


