### ORDER ACCEPTING APPLICATIONS AS COMPLETE AND ESTABLISHING PROCEDURAL REQUIREMENTS

### **PROCEDURAL HISTORY**

On September 29, 2023, Northern States Power Company doing business as Xcel Energy, Great River Energy, Minnesota Power, Otter Tail Power Company, and Missouri River Energy Services on behalf of Western Minnesota Municipal Power Agency (Applicants) filed an application for a certificate of need for the Minnesota portion of the Big Stone South—Alexandria—Big Oaks Transmission Project (the Project). The Project consists of a 345 kilovolt (kV) transmission line with new transmission facilities between Big Stone City, South Dakota and Sherburne County, Minnesota. The Project includes two segments, a Western Segment and an Eastern Segment, and the Applicants also filed a route permit application for the Eastern Segment. The Project would include modifications to four substations and construction of a new substation.

By October 18, 2023, the Commission received comments on the applications from:

- the Minnesota Department of Agriculture (MDA);
- the Minnesota Department of Commerce, Division of Energy Resources (the Department);
- the Minnesota Department of Commerce, Energy Environmental Review and Analysis unit (EERA);
- LIUNA Minnesota and North Dakota (LIUNA);
- Legalectric, Inc. (Legalectric);
- International Union of Operating Engineers Local 49 and North Central States Regional Council of Carpenters (IUOE Local 49 and Carpenters); and
- the Citizens Utility Board (CUB).

By October 25, 2023, the Commission received reply comments from the Applicants and the Clean Energy Organizations.<sup>1</sup>

The Commission did not receive any supplemental comments.

On November 16, 2023, the applications came before the Commission.

# FINDINGS AND CONCLUSIONS

# I. The Proposed Project

The Project includes a new 345 kV high-voltage transmission line with two segments. The Western Segment involves construction of a new single-circuit 345 kV transmission line placed on new double-circuit capable transmission towers from the existing Big Stone South Substation near Big Stone City, South Dakota, to the existing Alexandria Substation near Alexandria, Minnesota. The Eastern Segment involves construction of 105 to 108 miles of 345 kV transmission line on existing double-circuit capable transmission towers from the existing Alexandria Substation to a new Big Oaks Substation, including four deviations from existing infrastructure that would require the installation of new transmission rights-of-way.

The Project includes modifications to the Big Stone South, Alexandria, Riverview, and Quarry Substations, and would also involve construction of the new Big Oaks Substation.

According to the Applicants, the Project is needed to provide reliable, resilient, and costeffective energy related to the state's transition from coal-fired generation to more renewable and variable energy sources. More specifically, the Applicants stated that the Project is needed to address reliability issues identified by the Midcontinent Independent System Operator (MISO). These issues stem from excessive loading on the current system, which is at capacity and therefore experiences thermal overloads. The additional capacity from the Project would also help accommodate more renewable energy resources in the future.

The Applicants further state that the project will relieve transmission congestion, increase market access to lower cost renewable generation, and provide economic benefits in the form of reduced wholesale energy costs.

# II. Application Completeness

The Applicants filed their applications under Minn. Stat. § 216B.243 (the certificate of need statute) and Minn. Stat. § 216E.04 (the route permitting statute).

Under the certificate of need statute, any entity seeking to construct a large energy facility must first obtain a certificate of need from the Commission. Minn. Stat. § 216B.2421, subd. 2(2),

defines a large energy facility as any high-voltage transmission line with a capacity of 200 kV or more and a length greater than 1,500 feet.

Under Minn. Stat. § 216E.01, subd. 4, a high-voltage transmission line includes a conductor of electric energy and associated facilities exceeding 1,500 feet in length that are designed for and capable of operation at a nominal voltage of 100 kV or more. Under Minn. Stat. § 216E.02, subd. 2, construction of a high-voltage transmission line requires a routing permit from the Commission.

The Applicants state that since at least 80% of the distance of the proposed lines would be located along existing high-voltage transmission line rights-of-way and the lines exceed 200 kV in capacity, the proposed lines qualify under Minn. Stat. § 216E.04, subd. 2(5), for the alternative review process set forth in Minn. Stat. § 216E.04. In accordance with Minn. R. 7849.1900, the Applicants request joint review of the certificate of need and route permit applications under this alternative process.

The Department, EERA, IUOE Local 49 and NCSRC of Carpenters, LIUNA, and the CEOs all recommend that the Commission find the applications complete under Minn. R. 7849.0200, subp. 5, and 7850.2000.

The Commission concurs with the Applicants and parties that the applications are complete and will accept them as such.

## III. Record Development

EERA, LIUNA, IUOE Local 49 and NCSRC of Carpenters, CUB, and the Clean Energy Organizations recommended that the Commission apply the alternative review permitting process under Minn. Stat. § 216E.04 and Minn. R. 7850.2800, as requested by the Applicants. These entities concurred that at least 80 percent of the distance of the lines in Minnesota would be located along existing high-voltage transmission line rights-of-way, allowing for the alternative review process under Minn. Stat. § 216E.04, subd. 2(5). Under this alternative process, the statute directs the Department of Commerce to prepare an environmental assessment consistent with Minn. Stat. § 216E.04, subd. 5, including the following requirements:

> The environmental assessment shall contain information on the human and environmental impacts of the proposed project and other sites or routes identified by the commission and shall address mitigating measures for all of the sites or routes considered. The environmental assessment shall be the only state environmental review document required to be prepared on the project.

These entities also support the Applicants' request that the Commission hold joint proceedings on the applications, including joint hearings and environmental review. Additionally, the entities support use of the Commission's informal review process under Minn. R. 7829.1200 for developing the record on certificate of need issues raised throughout the duration of the proceeding.

EERA further recommends that the Commission make two requests to the Office of Administrative Hearings (OAH), including that: (1) the OAH assign an administrative law judge (ALJ) to act as the hearing examiner for the public hearing, consistent with Minn. R. 7850.3800, and (2) the assigned ALJ prepare a full report – including findings of fact, conclusions of law, and recommendations – in lieu of a contested case process, since the contested case process is not required under the alternative review process.

In contrast, Legalectric recommends that the Commission apply the full permit review process, which requires a contested case process and an environmental impact statement, as set forth under Minn. Stat. § 216E.03, subds. 5 and 6.

## IV. Commission Action

The Commission concurs with the Applicants that the certificate of need application is eligible for review using the Commission's informal review process under Minn. R. 7829.1200, and the route permit application is eligible for the alternative review process under Minn. Stat. § 216E.04 and Minn. R. 7850.2800 to 7850.3900. Therefore, the Commission will examine the applications under these procedures, which will entail joint hearings and joint environmental review, development of the record using the Commission's informal record development process for the certificate of need application, and preparation of an environmental assessment.

The Commission will further request, as recommended by EERA, that: (1) the Office of Administrative Hearings assign an administrative law judge to act as the hearing examiner for the public hearing, as outlined in Minn. R. 7850.3800, and (2) the ALJ prepare a report on the proposed projects that includes findings of fact, conclusions of law, and recommendations.

Upon acceptance of an application for a route permit, the Commission is required to designate a staff person to act as the public advisor on the project, pursuant to Minn. R. 7850.2200. The public advisor must be available to answer questions from the public about the permitting process. In this role, the public advisor may not act as an advocate on behalf of any person. The Commission will authorize its Executive Secretary to name a public advisor.

The Commission is persuaded that these procedures will ensure full and comprehensive record development of all issues raised – including potential environmental impacts and mitigation measures – and will provide opportunities for maximum public participation.

To facilitate timely and full record development, the Commission will take the additional actions set forth in the ordering paragraphs below:

### ORDER

- 1. The Commission hereby accepts both the certificate of need and route permit applications as complete.
- 2. The certificate of need application shall be reviewed using the Commission's informal review process.
- 3. The route permit application shall be reviewed under the alternative permitting process outlined in Minn. Stat. § 216E.04 and Minn. R. 7850.2800 to 7850.3900.
- 4. The Commission authorizes joint hearings and combined environmental review of the certificate of need and route proceedings.
- 5. The Commission requests that the Minnesota Department of Commerce, Energy Environmental Review and Analysis unit (EERA), prepare an environmental assessment under Minn. R. 7849.1900, subp. 1, in lieu of an environmental report.
- 6. The Commission requests that the Office of Administrative Hearings assign an administrative law judge (ALJ) to act as the hearing examiner for the public hearing, consistent with Minn. R. 7850.3800.
- 7. The Commission requests that the ALJ establish the types of filings necessary to facilitate proper record development and a schedule for submitting those filings through a prehearing conference in accordance with Minn. R. 1405.1100, and also that the ALJ prepare a full report including findings of fact, conclusions of law, and recommendations by July 19, 2024.
- 8. The Commission delegates authority to the Executive Secretary to do the following:
  - a. Provide the name, telephone number, and email address of the staff person designated as the public advisor to facilitate citizen participation in the process.
  - b. Request that the Department continue to study issues and indicate during the hearing process its position on the reasonableness of granting a certificate of need.
  - c. Require the Applicants to facilitate in every reasonable way the continued examination of the issues by the Department and Commission staff.
  - d. Require the Applicants to place a copy of the applications (print and/or electronic) for review in at least one government center or public library in each county where the proposed transmission line project is located.
  - e. Request that Commission staff work with the Administrative Law Judge and the Department in selecting a suitable location for the public hearings on the application.
- 9. The Commission hereby requires the Applicants to file before the public hearing (1) a formal Natural Heritage Review with DNR concurrence, and (2) a compliance filing

informing the Commission of the status of consultation with the State Historic Preservation Office, including the Office's formal response to the Applicants' database request.

10. This order shall become effective immediately.
