PROCEDURAL HISTORY

On March 15, 2024, Northern States Power Co. d/b/a Xcel Energy (Xcel) filed an Initial Petition; On April 2, 2024, Department of Commerce (DOC) filed an Extension Request; On April 2, 2024, Public Utilities Commission (PUC) issued Notice of Extended Comment Period; On May 16, 2024, DOC filed a Second Extension Request, On May 16, 2024, PUC issued a Second Notice of Extended Comment Period; On June 14, 2024, DOC filed Comments; On June 24, 2024, Xcel filed Reply Comments; On August 2, 2024, Xcel filed a Request for Partial Withdrawal of Petition; On August 16, 2024, DOC filed a Letter Regarding Xcel's Request for Partial Withdrawal.

PLEASE TAKE NOTICE that under Minn. Rules, Part 7829.0430, subp. 1, the Minnesota Public Utilities Commission has delegated to its Executive Secretary the authority to approve the withdrawal of a filing if the following conditions are met:

- 1. The party that submitted the filing has requested that the filing be withdrawn and has served notice on the persons listed on the official service list;
- 2. No person has expressed opposition to the withdrawal of the filing within 14 days of service of the notice; and
- 3. No commissioner or commission staff person has identified a reason that the matter should not be withdrawn.

Based on the review by the Executive Secretary and assigned Commission staff, the above named petitioner's request for withdrawal of its filing under this docket satisfies the above noted criteria. Therefore, this request for withdrawal of the filing is hereby approved.
