**I. INTRODUCTION**

Minnesota Power (“Minnesota Power” or “the Company”) hereby electronically submits its comments in response to the Minnesota Public Utilities Commission (“MPUC” or “the Commission”) Notice of Comment Period issued on September 18, 2023, In the Matter of the Implementation of the New Distributed Solar Energy Standard Pursuant to 2023 Amendments to Minnesota Statutes, Section 216B.1691 in Docket No. E002, E015, E017/CI-23-403. The Commission requested utility responses from Minnesota Power, Otter Tail Power, and Xcel Energy by October 13, 2023, before accepting public comments related to the following issue:

*What clarifications must the Commission make to operationalize the state’s distributed solar energy standard (DSES)?*

On October 10, 2023, pursuant to Minnesota Rule 7829.1275, Minnesota Power filed an extension request of 30 days to submit utility responses. Xcel Energy and Otter Tail Power supported this request. Representatives from the three utilities have been in discussions to evaluate the topics open for comment and develop recommendations. Given the importance and complexity of the new DSES, the additional time allowed the utilities to continue working together and with interested parties to develop thoughtful proposals that meet the spirit of the legislation and help the Commission operationalize the DSES. On October 11, 2023, the Commission extended the deadline for filing utility responses until November 13, 2023. The deadline for filing initial comments was extended until January 8, 2024, and the deadline for filing reply comments was extended until January 23, 2024.

## II. BACKGROUND

In 2001, the Minnesota Legislature first enacted the Minnesota Renewable Energy Objective (“REO”) contained in Minnesota Statute §216B.1691. As originally enacted, the REO Statute required electric utilities to “make a good faith effort” to obtain 10 percent of their Minnesota retail energy sales from eligible energy sources by 2015, and to obtain 0.5 percent of their renewable energy from biomass technologies.

During the 2007 Legislative session, Minnesota Statute §216B.1691 was amended to:

1. Establish a Renewable Energy Standard (“RES”) with specified mandated renewable energy goals beginning in 2010;
2. Amend the definition of an eligible energy technology;
3. Require the Minnesota Public Utilities Commission (Commission) to establish a trading system for renewable credits; and
4. Establish criteria under which the Commission may waive or extend the deadline for meeting the RES targets.

Notably, the RES Statute added Minnesota Statute §216B.1691, subd. 2(a), which requires an electric utility that does not own a nuclear generating facility to generate 25 percent of the electric utility’s total retail electric sales to retail customers in Minnesota by eligible energy technologies<sup>1</sup> by the end of 2025.

In 2013, the Minnesota Legislature adopted Minnesota Statute §216B.1691, subd. 2(f), establishing a Solar Energy Standard (“SES”) requiring public utilities to obtain at least 1.5 percent of their total Minnesota retail sales from solar energy by the end of 2020, with a goal of obtaining 10 percent of Minnesota retail sales from solar energy by 2030. This definition of an eligible energy technology reflects a number of changes made by the Legislature since eligible technologies were originally defined under the Renewable Energy Objective Statute.

SES also contained a small solar carve-out that requires at least 10 percent of the 1.5 percent SES come from small solar facilities. Under the small solar carve-out, public utilities with between 50,000 and 200,000 retail electric customers may apply individual customers subscriptions of 40 kW or less to a commission approved community solar garden program toward the 10 percent Small Solar Carve-out goal.

Three companies are subject to the SES: Minnesota Power, Otter Tail Power Company, and Xcel Energy. In addition to excluding cooperative and municipal utilities from the SES requirements, the SES statute excludes retail sales to customers that are iron mining extraction and processing facilities, or paper mills, wood products manufacturers, sawmills, or oriented strand board manufacturers from the calculation of 1.5 percent of retail sales.

On May 24, 2023, Governor Walz signed into law House File 2310 (“H.F. No.2310”), which included amendments to Minnesota’s Renewable Energy Objectives (Minn. Stat. §216B.1691).<sup>2</sup> Specifically, H.F. No.2310 added a distributed solar energy standard (“DSES”). The DSES is intended to function alongside the other standard objectives under Minn. Stat. §216B.1691, including the renewable energy standard (“RES”), the solar energy standard (“SES”), and the carbon free standard (“CFS”). The DSES requires public utilities to have a proportion of their total retail electric sales in Minnesota (either 3 percent or 1 percent depending on the number of customers served by the utility) be generated by solar energy generating systems by 2030. To count toward DSES compliance, the solar generating facilities must:

1. Have a capacity of 10 MW or less;
2. Be connected to the public utility’s distribution system;
3. Be located in the Minnesota service territory of the public utility; and
4. Be constructed or procured after August 1, 2023.

In addition to these requirements, the DSES specifies that solar energy generating systems with a capacity of 100 kW or more will not count toward DSES compliance unless

certain wage and apprenticeship requirements are met, requires utilities to select projects to satisfy DSES compliance through a competitive bidding process approved by the Commission, and exempts retail electric sales to industrial customers for utilities with fewer than 200,000 retail electric customers from the utility's total retail electric sales for the purpose of calculating total retail electric sales in Minnesota.

### **III. INITIAL COMMENTS**

Minnesota Power submits its responses to the information requested by the Commission below.

**1. Confirm your utility is subject to Minn. Stat. §216B.1691, Subd.2h.(b).**

Minnesota Power supplies retail electric service to 150,000 retail customers. As a public utility with at least 100,000 but fewer than 200,000 retail electric customers in Minnesota, the Company is subject to Minn. Stat. §216B.1691, Subd.2h.(b).

**2. A proposal for how the Commission should approve the competitive bid process required by Minn. Stat. §216B.1691, Subd.2h.(e).**

Minn. Stat. §216B.1691, Subd.2h.(e) states, “A public utility shall select projects to satisfy the standard established under this subdivision through a competitive bidding process approved by the commission.” Recognizing there is no “one-size-fits-all” solar generation mix for utilities, Minnesota Power requests the Commission allow utilities flexibility in establishing a competitive bidding process that appropriately matches the size of the projects and allows individual utilities to work with their customers and communities to identify opportunities to locate their distributed solar projects to meet their local renewable goals along with meeting the DSES.

The competitive bidding processes for solar resources will be determined separately by the individual utility based on their need and plan. Minnesota Power proposes that once the Company determines the plan for procuring the solar generating resources needed to meet the DSES, a compliance filing detailing the competitive process will be filed with the commission at least 30 days prior to the Company soliciting bids. Additionally, the

Company proposes the Commission use a negative check-off procedure for such compliance filings. If no party objects to the proposed competitive process in the allotted time, Minnesota Power can then solicit bids. If parties do object to the proposed competitive process, concerns can be addressed through a public comment period. This approval process will give an opportunity for stakeholders and the Commission to comment on the proposed competitive bidding process while allowing customization to meet the individual utilities plan to comply with the DSES.

**3. A proposal for how public utilities will verify that the construction trade workers who constructed the solar energy generating systems were all paid no less than the prevailing wage rate, as defined in section 177.42, and whose employer participated in an apprenticeship program that is registered under chapter 178 or Code of Federal Regulations, title 29, part 29.**

Minn. Stat. §216B.1691, Subd.2h.(d) states, “A solar energy generating system with a capacity of 100 kilowatts or more does not count toward compliance with the standard established in paragraph (a) unless the public utility verifies that construction trades workers who constructed the solar energy generating system were all paid no less than the prevailing wage rate, as defined in section 177.42, and whose employer participated in an apprenticeship program that is registered under chapter 178 or Code of Federal Regulations, title 29, part 29.”

Minnesota Power’s Construction Services Agreement (“CSA”) includes a prevailing wage requirement, which requires contractors and subcontractors performing work at project sites to pay their workers the prevailing wage commensurate with the base labor rates and fringe benefits established and evidenced in collective bargaining agreements in effect and applicable for the locality. This requirement includes a statement that “Contractors and Subcontractors shall, at Owner’s request, submit to Owner certified payroll records and other documentation as required to confirm compliance with this requirement.” This language will be adapted to address projects developed by third parties if selected to meet the new DSES, such as in the case of a Power Purchase Agreement (“PPA”).

The Company acknowledges that under the new DSES, utilities will be required to verify compliance with the prevailing wage requirement, both for projects the Company develops and those selected as part of the DSES process that are developed by others. The Company proposes that for all projects constructed or procured to meet the new DSES, Minnesota Power will request labor rates be provided in all bids as part of the competitive bidding process to verify developers, contractors, and subcontractors are able to meet the Company's prevailing wage requirements outlined in its CSAs. Once a bid is selected, the Company will require bidders to submit a signed "Statement of Compliance" certifying that each employee on the contract was paid no less than the proper prevailing wage for the work performed. If the Company has reason to believe that developers, contractors, or subcontractors are not paying the proper prevailing wage, it reserves the right to request certified payroll per the contractual terms. Minnesota Power will also require developers, contractors, and subcontractors to provide proof of registration under Chapter 178 or Code of Federal Regulations, title 29, part 29 when submitting bids for solar projects that will help meet the new DSES.

Minnesota Power proposes that documentation related to the prevailing wage and apprenticeship program requirements under Minn. Stat. §216B.1691, Subd.2h.(d) be supplied to the Commission for verification when utilities seek approval and/or cost recovery for the solar energy generating system projects constructed to meet the DSES.

**4. Provide the following information:**

- a. A description of how customers who would be exempt from the calculation of "total retail electric sales" under the DSES, and their associated retail sales, will be identified, and the statutory reason for their exclusion from the DSES.**

Minn. Stat. §216B.1691, Subd.2h.(b). states that "for a public utility with at least 100,000 but fewer than 200,000 retail electric customers in Minnesota...sales to industrial customers in Minnesota must be subtracted from the utility's total retail electric sales for the purpose of calculating total retail electric sales in Minnesota."

Minn. Stat. §216B.1691, Subd.2h.(a). defines “industrial customers” as “a retail electricity customer:

- (i) whose numerical classification under the North American Industry Classification System begins with the numbers 31, 32, or 33;
- (ii) that is a pipeline, as defined in section 216G.01, subdivision 3; or
- (iii) that is an iron mining extraction and processing facility, including a scram mining facility, as defined in Minnesota Rules, part 6130.0100, subpart 16.”

Accordingly, retail sales from customers who meet at least one of the above criteria will be excluded from the total retail electric sales calculated under the DSES.

Pursuant to Order Points 1 and 2 of the Commission’s January 29, 2021 Order (“January 29 Order”) in Docket Nos. E-999/M-20-464 and E-999/M-13-542, Minnesota Power submits to the Commission its “Solar Energy Standard (“SES”) - Exempt Customer Annual Report” specific to on-going compliance with Minnesota’s SES. Minnesota Power proposes that excluded retail sales from industrial customers under the DSES be identified through a similar reporting process.

Minnesota Power acknowledges that the criteria for excluded retail sales under the new DSES is different than the exclusion requirements under the SES. Although the Company believes its excluded retail sales will be similar under the new DSES as under the SES, at this time Minnesota Power is working internally to update its excluded retail sales data. Therefore, the data reported below under points (b), (c), and (d) has been estimated utilizing the Company’s most recent SES exclusion list, as reported in the 2022 “SES-Exempt Customer Annual Report.”<sup>3</sup>

**b. Total retail electric sales in kWh for 2022 with and without exclusions.**

- Total electric sales in 2022: 8,866,928,412 KWhs

- Total electric sales minus SES exempt sales in 2022: 2,936,132,000 KWhs.

**c. Calculate 3% or 1% (based on requirements under Subd. 2h.(b)) of retail electric sales for 2022 with and without exclusions.**

Minn. Stat. §216B.1691, Subd.2h.(b) requires public utilities with at least 100,000 but fewer than 200,000 retail electric customers in Minnesota to generate 3 percent of their total retail electric sales in Minnesota, minus exclusions, by solar energy generating systems by 2030.

- 3% of total retail electric sales in 2022: 266,007,852 KWhs (266,008 MWhs)
- 3% of retail electric sales minus SES exempt sales in 2022: 88,083,960 KWhs (88,084 MWhs; 50-70 MW nameplate capacity value).

**d. Estimate 3% or 1% (based on requirements under Subd. 2h.(b)) of retail electric sales for 2030 with and without exclusions.**

- 3% of estimated retail electric sales for 2030: 246,948,563 KWhs (246,949 MWhs)
- 3% of estimated retail electric sales minus SES exempt sales in 2030: 98,121,105 KWhs (98,121 MWhs; 55-75 MW nameplate capacity value).

#### IV. CONCLUSION

Minnesota Power appreciates the opportunity to respond to the Commission's information request regarding the operationalization of the State's new DSES. As a final consideration, Minnesota Power proposes streamlining reporting requirements for the DSES as much as possible. The Company suggests including any new DSES reporting requirements – aside from those discussed in the responses above regarding Minn. Stat. §216B.1691, Subd.2h(d) and (e) – with the annual and biennial reporting requirements for the SES established in the Commission's January 29, 2021 Order accepting reports on progress in achieving the SES and modifying SES reporting requirements.<sup>4</sup>

Minnesota Power looks forward to hearing from other stakeholders and the opportunity to submit additional comments on how to operationalize the DSES during the initial and reply comment periods in this docket.
