COMMENTS OF THE MINNESOTA DEPARTMENT OF COMMERCE DIVISION OF ENERGY RESOURCES

DOCKET NO. G008/GR-13-316

I. OVERVIEW

On August 5, 2013, the Minnesota Public Utilities Commission (Commission) issued a notice requesting that potential parties submit comments on whether the general rate case petition (Petition) filed on August 2, 2013 by CenterPoint Energy Resources Corporation d/b/a CenterPoint Energy Minnesota Gas (CPE or the Company) complies with the filing requirements of Minnesota Statutes §216B.16, Minnesota Rules parts 7825.3100 to 7825.4400, and Commission Orders. The Commission also stated that comments are appropriate on whether this matter should be sent to the Office of Administrative Hearings for an evidentiary hearing on the propriety of the proposed rate change. The Minnesota Department of Commerce, Division of Energy Resources (DOC) submits the following Comments, pursuant to the Commission's August 5, 2013 notice.

II. DOC ANALYSIS

The DOC conducted a review of the contents of the Petition to verify the Company's compliance with:

- statutory requirements (Minnesota Statutes §216B.16);
- Commission's rules governing filing requirements for rate changes (Minnesota Rules parts 7825.3100 to 7825.4400);
- Commission Orders pursuant to CenterPoint's most recent general rate case in Docket No.G008/GR-08-1075; and

• Commission Orders in various dockets prior to or subsequent to CenterPoint's most recent general rate case.

Company Witness Joseph J. Vortherms provided a matrix of regulatory requirements for the Company's filing in his JJV-D, Schedule 4, contained in Volume 2 of 2 of CPE's General Rate Petition. This table lists and identifies where in the Petition the Company has addressed the applicable Statutes and Rules, and prior Commission Orders.

Based on our review, the DOC concludes that CPE's filing complies with the filing requirements. The DOC emphasizes that its review at this stage of the proceeding pertains to whether the Company's Petition discussed the issues in the list noted above, not as to whether the Company has met its burden of proof to show that its proposals are reasonable. Such analysis is the focus of the investigatory period in the initial stage of the proceeding, based on the merits of the Petition. As such, issues can be and will be further developed through information requests. The quality of the record that will be developed for the Commission's decisions depend in large part on the Company providing timely and complete responses to information requests. The Department appreciates the efforts by CPE to date in keeping the Department informed and responding to questions.

Accordingly, the DOC recommends that the Commission accept the Petition and refer this matter to the Office of Administrative Hearings for a contested case proceeding.

III. DOC RECOMMENDATIONS

The DOC recommends that the Commission:

- 1. accept CPE's rate case filing in the present docket as complete; and
- 2. refer this matter to the Office of Administrative Hearings.
