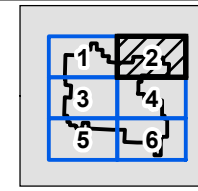
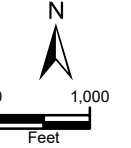


MAP 11 - SURFACE WATERS - PAGE 2 OF 6

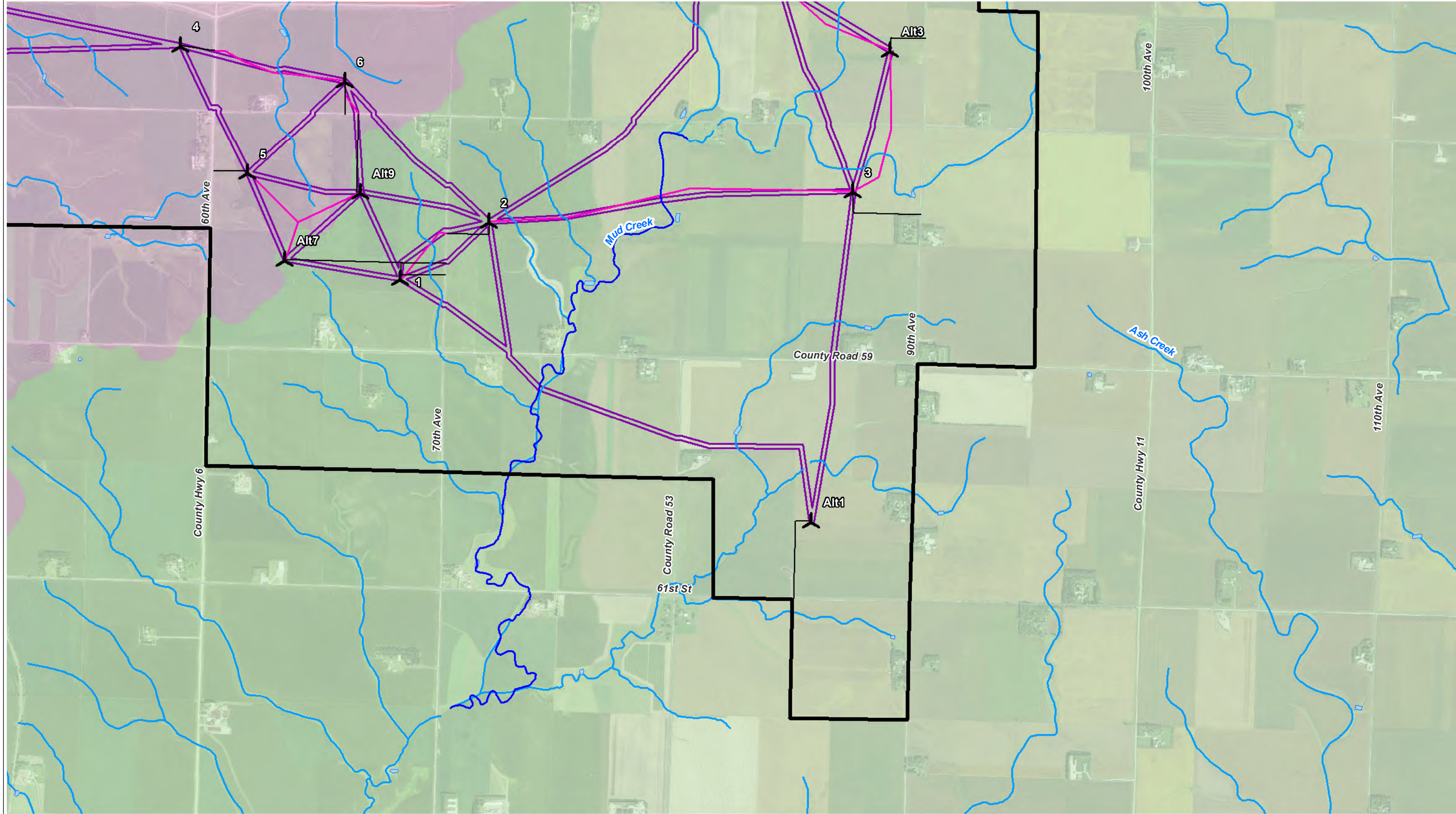


MAP 11 - SURFACE WATERS - PAGE 5 OF 6
