Background:

Minnesota Power, Otter Tail Power, and Xcel Energy submit annual Safety, Reliability, and Service Quality (SRSQ) Reports. Standards and reporting requirements are set under Minnesota Rules chapter 7826 and in Commission Orders.

In its March 2, 2022 Order Accepting Reports and Setting 2021 Reliability Standards, the Commission set utility reliability standards that benchmark to the IEEE working group results.² The Commission required utilities make a supplemental filing to their reports within 30 days of the IEEE results being available, with an explanation addressing any standards the utility did not meet.

Filing Requirements: Utilities, telecommunications carriers, official parties, and state agencies are **required** to eFile documents using the Commission’s electronic filing system (eFiling). All parties, participants, and interested persons are encouraged to use eFiling at: <https://www.edockets.state.mn.us/EFiling>.
