## REPLY TO EXCEPTIONS TO THE FINDINGS OF FACT, CONCLUSIONS OF LAW, AND RECOMMENDATIONS OF THE ADMINISTRATIVE LAW JUDGE SUBMITTED BY THE XCEL LARGE INDUSTRIALS

Lee 33 South Sixth Street, Suite 4200 Minneapolis, MN 55402 Tele: (612) 373-8800 Fax: (612) 373-8881 Xcel Large Industrials ("XLI") submits this Reply to Exceptions pursuant to the Minnesota Public Utilities Commission ("Commission") Notice issued in this matter on May 20, 2024. XLI replies to three issues that were raised by parties in Exceptions filed on June 6, 2024.

# 1. Xcel Must Refund the Totality of the Replacement Power Costs Incurred as a Result of Its Imprudence.

First, XLI supports the Exceptions filed by the Minnesota Department of Commerce ("Department") and the Office of the Attorney General – Residential Utilities Division ("OAG"), requesting the Commission reject the Administrative Law Judge's ("ALJ's") recommendation to reduce the ratepayer refund based on General Electric's ("GE's") negligence. As the Department correctly notes, tort law concepts are not relevant to the Commission's prudency review, and it would be patently unfair to require Xcel Energy's customers to bear more than half of the costs resulting from Xcel Energy's negligence.<sup>1</sup> As the OAG points out, Minnesota ratepayers had no control over Sherco 3 and they should not bear the cost of Xcel's imprudent operation and maintenance thereof, or its decision to settle its litigation with GE.<sup>2</sup> XLI supports these Exceptions and, as for the reasons included in XLI's Exceptions, the Commission should reject the ALJ's recommendation to reduce the refund due customers.

#### 2. The Commission Should Require Xcel Energy to Refund the Amount of Replacement Power Costs Ratepayers Actually Paid as a Result of the Event.

Second, XLI continues to support the ALJ's recommendation that ratepayers should be refunded the amount of replacement power Xcel Energy recovered through the fuel clause. Xcel disputes this and asserts instead that its litigation estimate of the replacement power should be used to determine the amount of the refund to be returned to ratepayers.<sup>3</sup> Instead of using the actual costs Xcel Energy submitted in the Fuel Clause Adjustment ("FCA") to recover its costs, \$55.5 million, Xcel states that its litigation estimate of \$45.4 million is "more robust" and "more sound and defensible" than the estimate it used to recover the costs from ratepayers in the FCA.<sup>4</sup>

Xcel's arguments on this issue are somewhat alarming, especially because the Company has recovered replacement power costs in its current FCA proceeding, using cost estimates, just like it used in the FCA process that approved recovery of the costs at issue in this contested case. In its current FCA proceeding, the Department has evaluated the Company's recovery of replacement fuel costs resulting from outages at its nuclear facilities. Based on cost estimate information provided by Xcel,<sup>5</sup> the Department is recommending refund of approximately \$17 million in replacement power costs related to an outage at Prairie Island Unit 1,<sup>6</sup> and approximately \$4 million in replacement power costs related to an outage at Prairie Island Unit 2.<sup>7</sup> In other words, Xcel Energy continues to use the same methodology to recover its replacement fuel costs in its FCA, and that process uses Xcel's estimated costs to determine the amount of recoveries and refunds.

Xcel asserts it is "not possible to *precisely* determine replacement power costs incurred as a result of any particular outage."<sup>8</sup> Xcel is correct, in that "precise" costs may not be available, but this is exactly the point. Parties do not use "precise" costs in determining the replacement costs that are recovered through the FCA; they use cost estimates, the estimates provided by the utility. It makes no sense to use cost estimates to determine recoveries, but "more robust" methodologies to determine refunds.

If the cost estimates are not sufficient to determine the amount of refund, they should not be sufficient to determine the amount of initial recovery in the first place. Xcel seems appalled that the ALJ correctly determined the methodologies for recovery and refund should be the same, and that "the amount of replacement power costs '*ratepayers actually paid* as a result of the Event" should be refunded, stating "as though replacement power costs associated with the Event were somehow separately accounted for and charged to customers."<sup>9</sup> The utility bears the minimum burden of identifying and separately accounting for the replacement power costs that flow through the FCA, just like it identified the replacement power costs it recovered in its current

FCA. At no point in the FCA process are costs determined using the "more robust" methodology Xcel seeks to use to determine the refund in this proceeding.

Moreover, if the methodology Xcel used to recover the costs at issue here is insufficient to determine the refunds due ratepayers, it is patently insufficient to determine the amounts that should be initially recovered in any FCA proceeding. The Commission should investigate whether Xcel's methodology of quantifying replacement costs has been sufficient to allow recovery of those costs, and whether it is sufficient going forward. Here, Xcel's "more defensible" estimate is \$10.1 million less than the amount it recovered from ratepayers. This significant difference is concerning and the Commission should investigate whether Xcel has over-recovered replacement power costs in other FCA dockets.

Finally, Xcel's preferred methodology cannot be used because it isolates and refines only one portion of the \$2.65 billion in costs Xcel recovered in the three FCA years at issue. Xcel claims the portion of those costs attributable to the Sherco 3 outage is overstated and should be something less than the costs Xcel sought and recovered. But if that it is true, Xcel over-recovered costs that were not attributable to Sherco 3, and those amounts should still be recovered from ratepayers. Even if the Commission were to adopt Xcel's "more robust" methodology ratepayers would be due the same amount calculated by the ALJ.

In sum, XLI supports the ALJ's determination of the refund due for the following reasons:

- 1. The same methodology to determine recovery should be used to determine refunds;
- 2. Xcel is using cost estimates to recover replacement costs in its current FCA proceeding, just as it did in the FCA proceedings at issue;
- 3. If there is doubt whether the methodology is insufficient to determine refunds, it is by definition insufficient to determine recoveries, and the Commission should investigate whether Xcel's methodology is being used to over-recover replacement power costs in other FCA dockets; and
- 4. Even if the Commission were to adopt Xcel's preferred methodology, Xcel would still need to refund the difference between the two amounts (\$10.1 million) because it over-recovered those costs initially in the 2012-2014 FCA proceedings.

Xcel states that the ALJ "Report reveals a lack of understanding of the regulatory process by which utilities recover their costs of energy," but the ALJ was correct in how the FCA process works, and therefore what amount should be refunded. For these reasons, as well as those discussed in Initial and Reply Briefs, XLI requests the Commission adopt the ALJ's Report and Recommendations on this issue.

#### 3. Interest Should Accrue Until the Refunds Are Issued.

Finally, XLI agrees with the OAG that interest needs to be accrued until the refund to customers is made. The Department witness calculated interest assuming a ratepayer refund would be issued by January 2025.<sup>10</sup> If the refund occurs after that date the Commission should require the calculation of interest be updated to include additional months the refund is delayed in a compliance filing before the refund is issued.<sup>11</sup>

XLI thanks the Commission for the opportunity to submit this Reply to Exceptions and we look forward to the Commission's resolution of this long-lasting proceeding.
