In the Matter of the Application of Birch Coulee Solar LLC for a Site Permit for the up to 125 MW Birch Coulee Solar Project in Renville County, Minnesota

PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) is accepting comments on the completeness of Birch Coulee Solar LLC's (Birch Coulee Solar) site permit application for the construction and operation of the Birch Coulee Solar Project, an up to 125-megawatt alternating current (MWac) photovoltaic solar energy generating facility (Project). The application was filed with the Commission on July 29, 2024.

The project would be located on approximately 768 acres within a 1,042 acre site in the city of Franklin and Bandon, Birch Cooley, and Camp townships in Renville County, Minnesota. The project would include: solar panels and tracking racking systems; inverters; an electrical collection system; an operations and maintenance facility; step-up transformers; gravel access roads; weather stations; a stormwater management system; fencing and gates; a substation and interconnection facilities; a short (<1,500 ft) aboveground 115-kilovolt transmission line; and other infrastructure typical of a solar facility.

Supplemental comment period closes September 3, 2024 at 4:30 p.m.

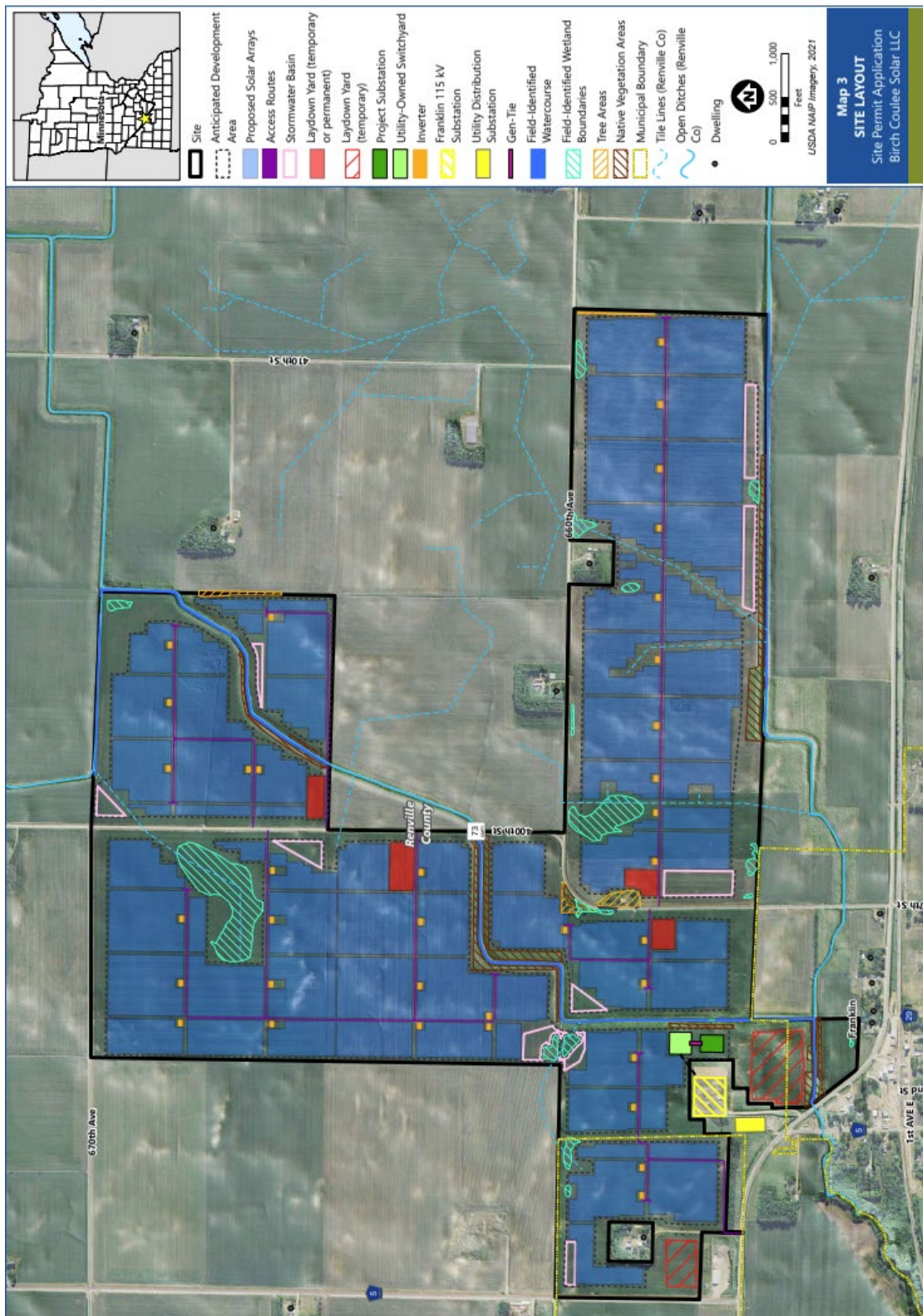
