I am writing regarding an initial filing made by Greater Minnesota Transmission, Inc. on July 2, 2014. This morning, an analyst at the Minnesota Department of Commerce notified our office that the initial filing, Submission Number 20147-101183, was incorrectly filed in Docket No. 14-342 rather than being assigned its own docket number. A review of our records indicates that it was, in fact, filed correctly out of our office and treated as an initial filing without any docket number. I have attached a copy of the filing confirmation obtained at the time of filing as well as the service confirmation received via e-mail, both of which show that no docket number was assigned.

Apparently, someone from internal staff incorrectly assigned this filing to an existing docket. I just spoke with Linda Chavez at the Department and she corrected the error, assigned this docket number to the matter and transferred the filing to the correct docket. A copy of her confirming e-mail is also attached. This letter is simply to document what happened with respect to the filing.
