I. BACKGROUND

On November 18, 2011, the Federal Communications Commission (FCC) released its Universal Service Fund-Intercarrier Compensation Report and Order and Further Notice of Proposed Rulemaking, WC Docket No. 10-90, GN Docket No. 09-51, WC Docket No. 07-135, WC Docket No. 05-337, CC Docket No. 01-92, CC Docket No. 96-45, WC Docket No. 03-109, and WT Docket No. 10-208 (USF-ICC Order).

On May 10, 2012 in Docket No. P999/M-12-356, the Minnesota Public Utilities Commission (Commission) held a hearing on this matter and issued its order on May 24, 2012, requiring carriers that charge access rates in Minnesota to file revised intrastate access rates and supporting information as required by the FCC's USF-ICC Order. Carriers were to file their rates to be effective July 3, 2012. On March 18, 2013, the Commission issued its order declaring that the requirements placed upon carriers had been fulfilled and closing the docket.

On May 17, 2013 in Docket No. P999/PR-13-137, the Commission issued its order requiring carriers to file revised intrastate access rates for 2013 by July 2, 2013 as required by the FCC's USF-ICC Order. On August 23, 2013, the Minnesota Department of Commerce (Department) filed comments reporting compliance with the requirement to file intrastate access rates by July 2, 2013.

On April 2, 2014, the Department filed comments in Docket No. P999/PR-14-15 recommending procedures for the 2014 access rate changes, and on May 7, 2014 the Commission issued its order requiring carriers to file revised intrastate access rates for 2014 by July 1, 2014 as required by the FCC's USF-ICC Order.¹

II. DEPARTMENT COMMENTS

In 2012 in Docket No. P999/M-12-356, the Department identified 213 carriers that were potentially required to reduce intrastate terminating switched end office and transport rates that were above the carrier's interstate rate by 50 percent of the differential between intra- and interstate terminating access rates (see Attachment 1). Sixty of those carriers were determined not to be required to file access reduction data because they did not provide access services, primary jurisdiction was in a neighboring state, or they had no Minnesota operations. The remaining 153 carriers were determined to have complied with the FCC's USF-ICC Order requiring carriers that charge access rates in Minnesota to file revised intrastate access rates.

The Department identified 216 potential carriers that were potentially required to submit filings in 2013 to reduce terminating intrastate access rates to parity with interstate rates in compliance with the Commission's May 17, 2013 Order in Docket No. P999/PR-13-137. Of the 216 potential carriers identified in 2013, 151 carriers filed tariffs/links to their interstate tariffs indicating they had reduced their intrastate terminating access tariffs to a level at or below their interstate rates (see Attachment 1). Sixty-five of those carriers were determined not to be required to file access reduction data because they did not provide access services, primary jurisdiction was in a neighboring state, or they had no Minnesota operations.

The Department identified 222 carriers that were potentially required to submit filings in 2014 in compliance with the Commission's May 7, 2014 Order in Docket No. P999/PR-14-15.

- Priced Cap Carriers were required to reduce their 2014 Target Composite Terminating End Office Access Rate to \$0.007 per minute plus two-thirds of any difference between the 2011 Baseline Composite Terminating End Office Access Rate and \$0.0007 per minute.
- Rate of Return Carriers were required to reduce their 2014 Target Composite Terminating End Office Access Rate to \$0.005 per minute plus two-thirds of any difference between the 2011 Baseline Composite Terminating End Office Access Rate and \$0.005 per minute.

One-hundred sixty-five carriers filed tariffs and/or links to their interstate tariffs indicating they had reduced their intrastate terminating access tariffs to the required level. The remaining fifty-seven carriers were determined not to be required to file access reduction data because they did not provide access services, primary jurisdiction was in a neighboring state, or they had no Minnesota operations (see Attachment 1). The following companies reported local revenues but no access revenues: AEX Communications, Inc., New Edge Network, Inc. dba EarthLink Business, Nextlink Wireless LLC, South Dakota Network, LLC, and Zayo Group, LLC. The following companies reported local revenues and did not respond to Department inquiries, but have no access tariffs and are not authorized to charge for access services: Access Point, Inc., BEVCOM, Inc. d/b/a BEVCOM, FTTH Communications, LLC and LH Telecom, Inc.
