Reply Comments of the Minnesota Department of Commerce Division of Energy Resources

Docket Nos. E002/M-13-867 and E999/M-14-65

I. BACKGROUND INFORMATION

On April 1, 2014, the Commission approved the Department's proposed methodology to calculate the Value of Solar (VOS). The VOS methodology is intended to meet the requirements of Minn. Stat. § 216B.164, Subd, 10 and reflect the value of distributed solar generation to the "utility, its customers and society."

On September 6, 2016, the Commission issued an Order approving the use of the VOS methodology as the basis for the bill credit in Xcel Energy's (Xcel or the Company) Solar*Rewards Community (CSG) Program. In addition, the Commission directed Xcel to calculate a location-specific avoided distribution cost starting with its 2018 VOS rate filing.

In its March 22, 2019 *Order Approving Xcel's Update to the 2019 System-wide Value-of-Solar Tariff Rate with Modifications*, the Commission directed Xcel to file a more fully developed alternative method for calculating the avoided distribution cost component of the VOS by May 1, 2019.

On May 1, 2019, Xcel submitted their proposed avoided distribution cost calculation methodology.

On May 20, 2019, the Commission issued a *Notice of Comment Period* seeking comment on Xcel's proposed avoided distribution cost calculation methodology, seeking responses to these questions:

- Does Xcel's proposal comply with Commission Order?
- Is the proposal sufficiently developed for Commission consideration?
- Does it yield accurate results that are fair and reasonable for all VOS stakeholders?

On August 2, Northern States Power Company d/b/a Xcel Energy (Xcel or the Company) filed a petition requesting approval to use its proposed VOS methodology for its 2020 VOS rate.

II. SUMMARY OF INITIAL COMMENT

Comments were filed by the Minnesota Solar Energy Industries Association (MNSEIA), IPS Solar, Fresh Energy, and the Department. Parties appear to recognize that the existing methodology for calculating the avoided distribution capacity cost results in significant volatility, and may warrant revision, but remain concerned that the methodology proposed by Xcel is appropriate. All commenters noted various degrees of concern with Xcel's proposal to reduce the estimated per-kW cost of distribution capacity additions by 50 percent, although the Department recommended that the Commission approve Xcel's method, and require the Company to report annually on its planned and actual distribution spending, along with the placement of CSGs to assist with evaluating the continued reasonableness of Xcel's avoided distribution cost calculation methodology.

MNSEIA's comments largely reflected the concerns of IPS Solar and Fresh Energy, and included additional concerns and specific recommendations. Therefore, the following reply comments focus on MNSEIA's comments.

MNSEIA argued that Xcel's proposal does not capture the full value of avoided distribution costs, and should be modified as follows:

- Add a longer data period;
- Remove the 50 percent discount factor;
- Include a broader set of distribution projects;
- Include more "capacity related projects;" and
- Include avoided investments in distribution plant.

The Department offers its reply comments to MN SEIAs recommendations, below.

III. SUMMARY OF XCEL'S PETITION

In its August 2, 2019 to modify the methodology for calculating the VOS and to use that new methodology in establishing 2020 VOS rates, Xcel provided a calculation of the 2020 VOS rates under the current methodology to support its contention that the methodology for calculating the avoided distribution cost requires modification. Under the current methodology, Xcel calculated the 2020 levelized VOS at \$0.2484 per kWh compared with the 2019 rate of \$0.1109 per kWh. In comparison, Xcel calculates the VOS under its proposed methodology to be \$0.1132 per kWh.

III. DEPARTMENT REPLY

Under Xcel's proposed methodology, the avoided distribution cost is calculated by dividing the distribution costs for capacity addition projects by the amount of capacity being added. The Company proposed to sum up distribution costs and capacity additions for two historical years and three forecast years for its calculation. MNSEIA recommended using more than five years of data for the calculation, and stated that "distributed solar generation will have an economic life of at least 25 years, and if a new solar installation does not defer a distribution investment immediately, it may contribute to doing so at some other point in its 25-year life."

The Department supported using a combination of historical and forecasted distribution costs and additions as a means of balancing actual and forecasted spending. Including a couple of years of historical spending serves as a check on the Company's forecasts. In addition, the longer the forecast period, the greater the uncertainty that the forecast would be realized.

In an integrated resource plan (IRP), Xcel provides forecasts for a 20-year timeframe, but recommendations and Commission decisions focus most closely on the five-year action plan. In its most recent distribution planning report (Docket No. E002/M-18-251), Xcel provided a five-year forecast of its distribution system. The Department does not object to including the five-year forecast along with the two years of historical data in determining the avoided cost of distribution per kW, but does not recommend extending the data beyond the five-year forecast.

Xcel proposed to reduce the avoided cost of distribution per kW by 50 percent as a means of spreading the risk that a given solar facility will not result in avoided distribution costs. MNSEIA recommended eliminating the 50 percent discount stating "distributed solar generation will have an economic life of at least 25 years, and if a new solar installation does not defer a distribution investment immediately, it may contribute to doing so at some other point in its 25-year life." The Department notes that the fact that a solar facility may not immediately contribute to avoided distribution costs supports some form of discount to reflect that the avoided cost will not occur in one or more years of the facility's economic life. For instance, the avoidance of some level of distribution costs in the 20th year of a facility with a 25-year life does not warrant being paid the avoided distribution cost for the full 25 years of its life. Xcel's proposal to discount the avoided distribution costs by 50 percent may or may not be ideal, but appears to be logical in that it reflects the assumption that some CSGs may enable Xcel to avoid some level of distribution costs in all years, some may result in no avoided distribution costs in all years, and others may result in avoided costs in some years and not in others.

Finally, MNSEIA indicated that it supports expanding the scope of projects considered as avoided. The Department understands MNSEIA's position to mean that distribution projects that replace existing distribution infrastructure at the end of its life or projects done for reliability purposes, but that secondarily result in increased system capacity, should be included in the calculation of avoided distribution costs. The Department notes that avoided distribution capacity costs are intended to capture avoided costs due to the solar facility existing on the distribution system. Therefore, if a distribution project will be done whether the solar project exists or not, the costs are not avoided

As reflected in Xcel's August 2, 2019 filing, the VOS rates would more than double in 2020 compared with 2019 under the current methodology. The wide swings in rates further demonstrate the need to revise the VOS methodology to ensure more stability in the rates. Unlike utility scale solar projects, CSGs are not required to demonstrate that they are least cost resources. The credits paid to CSG subscribers are paid for by all customers through the fuel clause adjustment, and as such continuing the existing methodology would further increase the cost of CSGs to non-participating customers who are not receiving credits.

The Department concludes that Xcel's proposed methodology for calculating its avoided distribution cost is reasonable and recommends approval and its use for calculating 2020 VOS rates.

IV. DEPARTMENT RECOMMENDATION

The Department recommends the Commission approve Xcel's proposed methodology for calculating the avoided distribution cost component of the Value of Solar calculation, and direct that it be used in the calculation of the 2020 VOS rates.
