PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) will hold remote-access public hearings on the certificate of need and site permit applications for the up to 109.2-megawatt large wind energy conversion system and the associated facilities proposed by Walleye Wind, LLC (Walleye Wind).

Project Description

Walleye Wind, LLC (a wholly owned subsidiary of Nextera Energy Resources, LLC) has proposed to construct and operate an up to 109.2-megawatt (MW) Large Wind Energy Conversion System (LWECS) in Rock County. The project would include construction of up to 40 wind turbines with nameplate capacities of between 2.32 and 2.82 MW each. Associated facilities would include collection lines, a collector substation, an operations and maintenance facility, a construction laydown yard, crane paths, gravel access roads, a meteorological tower, and a generation tie line of less than 500 feet connecting the collector substation to the existing Xcel Energy Rock County Substation.

The project area encompasses approximately 31,000 acres in Martin, Luverne, Beaver Creek and Springwater Townships. Within the project boundary, the LWECS and associated facilities will be located on lands for which Walleye Wind has obtained wind rights and/or property easements. Upon completion, the project components will occupy approximately 49 acres of land converted to wind turbines and associated facilities approved by this permit.

Hearing and Process Information

The purpose of the public hearings and comment period is to obtain public input on the proposed project and compile the record for the Commission to consider in making a final decision on the certificate of need and site permit applications. The Honorable James Mortenson, an Administrative Law Judge with the Office of Administrative Hearings, will administer the hearings and will provide the Commission with a Report including findings of fact, conclusions of law, and a recommendation.

The public hearings afford interested persons the opportunity to ask questions of the applicant and agency staff; and to offer oral and written comments on the merits of the proposed project and on possible conditions to be considered for inclusion in a site permit, if one is granted. Members of the public may participate without the necessity of intervening as a party. Representation by legal counsel is permitted but not required.

Minnesota Statutes and Rules: The certificate of need application is reviewed under Minnesota Statute 216B.243 and Minnesota Rules Chapter 7849. The LWECs site permit is reviewed under Minnesota Statute 216F and Minnesota Rules Chapter 7854. The hearings will be conducted by an ALJ in accordance with Minnesota Statutes, sections 14.57 to 14.62; Minnesota Rules, parts 1405.0200 to 1405.2800; Minnesota Rules, parts 1400.5100 to 1400.8400, where Chapter 1405 is silent; and, to the extent they are not superseded, Minnesota Rules, parts 7829.0100 to 7829.3200. - Should the Commission grant a site permit for the proposed large wind energy conversion system?
- If granted, what additional conditions or requirements should be included in a permit?

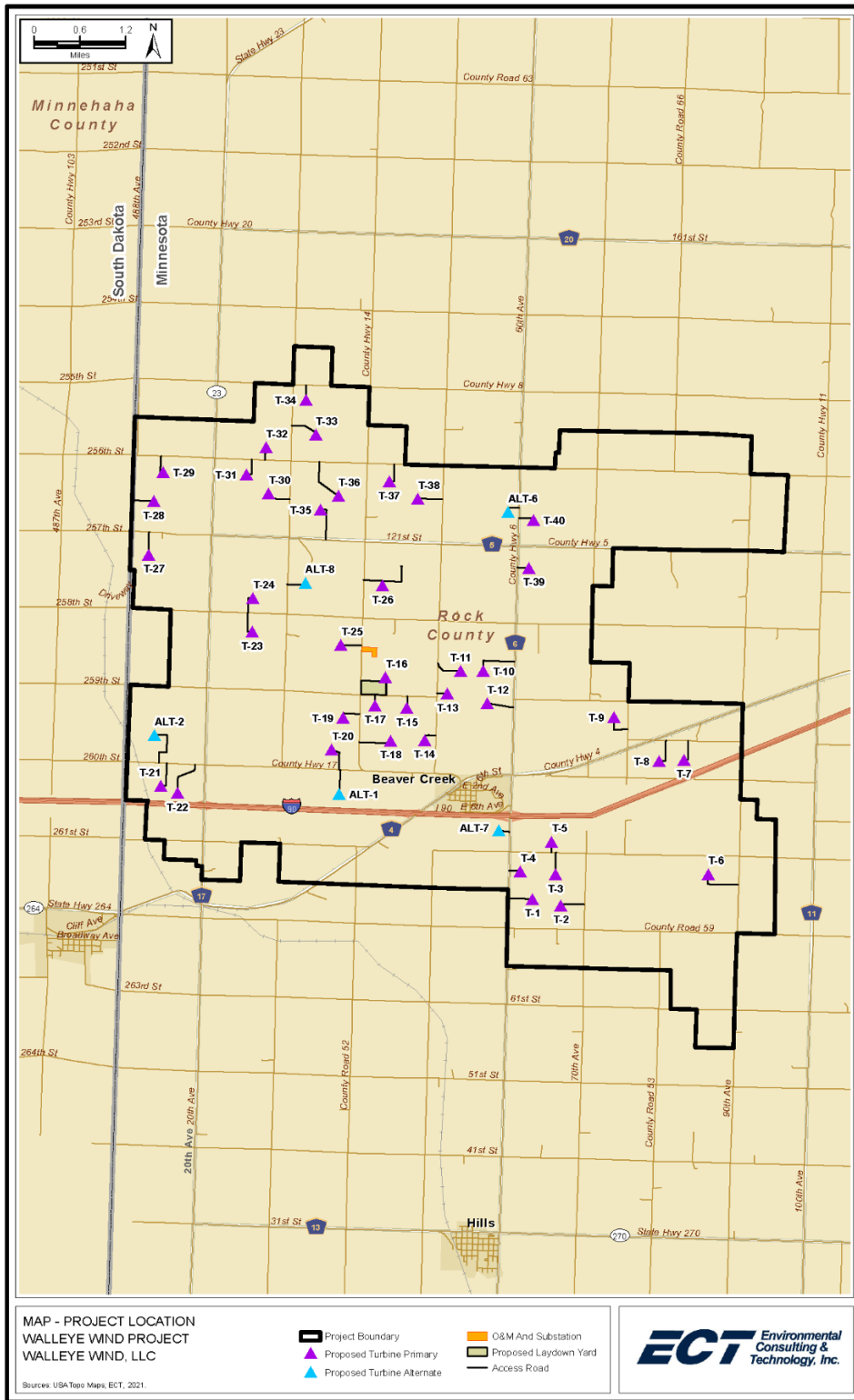
