On November 13, 2020, Byron Solar, LLC (“Byron”) submitted reply comments pertaining to its proposed notice plan in connection with its forthcoming application for a certificate of need for a new 345 kilovolt transmission line and associated facilities to be located in Olmsted and Dodge Counties, Minnesota. Byron submits this letter to supplement and update that filing.

At the time of filing, Byron estimated that placement of its Notice Plan ad in the *Star Tribune* would cost “at least \$4,000,” based upon pricing available on the *Star Tribune*’s website. Since that filing, a representative of the *Star Tribune*’s advertising department responded to an earlier request from Byron that such an ad would cost \$10,393.50 for one weekday.

Byron respectfully requests that the Public Utilities Commission take notice of the more specific pricing estimate provided by the *Star Tribune*.
