In the Matter of the Application of Northern States Power Company d/b/a Xcel Energy for a Certificate of Need for Additional Dry Cask Storage at the Monticello Nuclear Generating Plant Independent Spent Fuel Storage Installation in Wright County

PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) will hold an in-person public hearing and a remote-access public hearing on Xcel Energy's application for a certificate of need for the expansion of its Independent Spent Fuel Storage Installation (ISFSI) at the Monticello Nuclear Generating Plant (MNGP) in Wright County.

Xcel Energy is requesting additional storage of spent nuclear fuel in the ISFSI at the MNGP sufficient to extend its operating life by 10 years – from 2030 to 2040. This additional storage requires installation of a second concrete support pad within the existing ISFSI. A modular concrete storage system would be placed on the new concrete pad. Xcel Energy indicates that spent fuel would be stored in steel canisters, with the canisters then being placed in the concrete storage system. Xcel Energy estimates that approximately 14 additional spent fuel storage canisters will be needed for operations through 2040.

Before the project can be constructed, the Commission must determine that the project is necessary and in the best interest of the state. The certificate of need process includes an environmental impact statement, public hearings, and trial-type evidentiary hearings. The public hearings are the only opportunity for the public to appear in person to 1) provide their input on the necessity of the project, 2) provide input on the no-build alternatives, and 3) address alternatives for the Commission to consider. The public hearing will be conducted in accordance with the requirements of Minnesota Statute 216B.243, subd. 4. Members of the public may participate in the public hearing and public comment process without the necessity of intervening as a party to the contested case.

Representation by legal counsel is permitted but not required. The criteria that the Commission must address when rendering a final decision are found in Minnesota Statutes 216B.243, Subd. 3 & 3a, and Minnesota Rules 7849.0120.

There will be two public hearings in this matter: an In-Person Hearing and a Remote-Access Hearing. The information presented will be the same at both hearings.

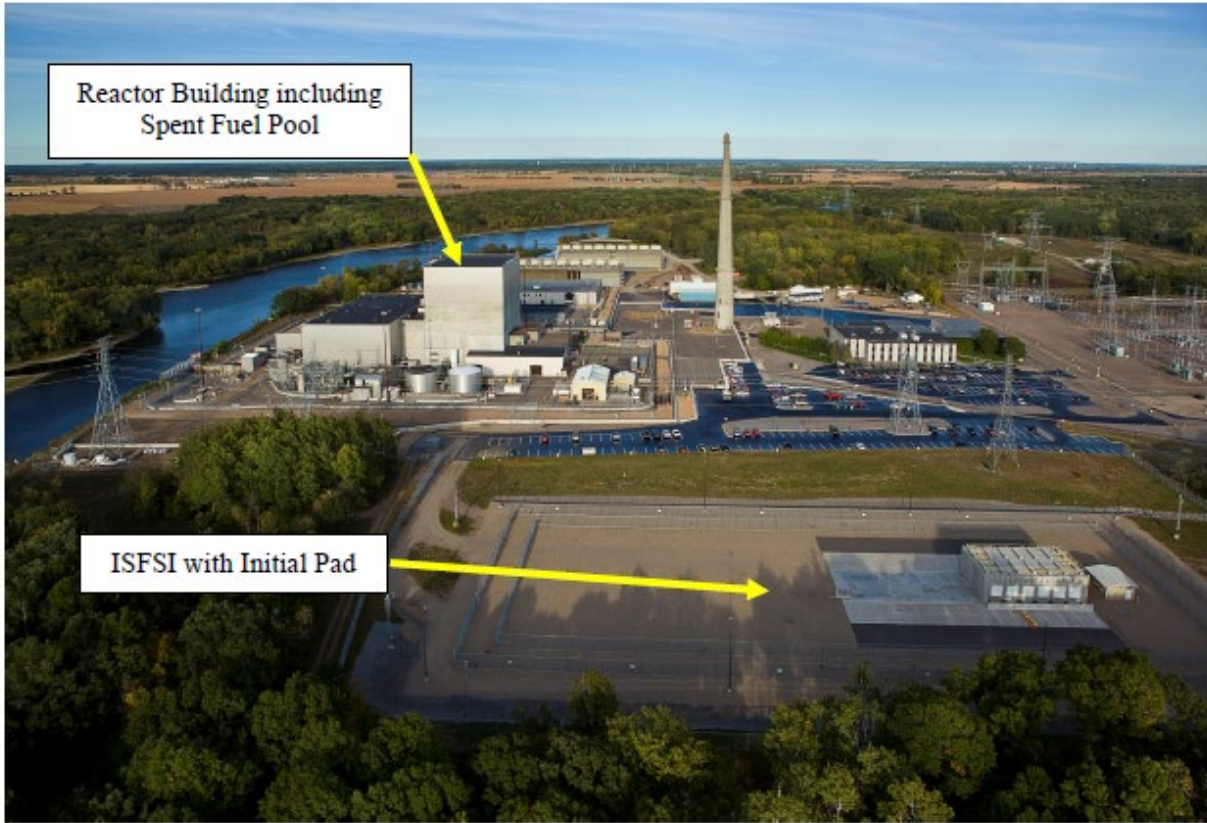
