**PROPOSED DECISION OPTIONS OF
DATA CENTER COALITION**

Pursuant to the Request for Final Decision Options issued by the Minnesota Public Utilities Commission (Commission) on March 23, 2026, the Data Center Coalition (DCC) respectfully files its Proposed Decision Options in the above-captioned proceeding.

DATA CENTER COALITION'S PROPOSED DECISION OPTIONS

DCC appreciates the opportunity to provide its Proposed Decision Options and provides them below pursuant to the template provided by Commission Staff.

Approve, Reject, or Modify

- **Large General Time of Day Service tariff:** Approve with modifications as described below.
- **Large Peak Controlled Time of Day Service tariff:** Approve with modifications as described below.
- **Rules for the Application of Peak Controlled Services tariff revisions:** Approve.
- **Tier 1 Energy Controlled Service rider tariff revisions:** Approve.
- **CIP Adjustment rider tariff revisions:** Approve.
- **Administrative revisions to the Company's Tariff Book:** Approve.
- **Retail Customer Form ESA:** Approve with modifications as described below.

Incremental Cost Test

- **Components of ICT and recommended modifications:** Reject Xcel's incremental cost test proposal in its entirety. The incremental cost test results in discriminatory rates that violate Minn. Stat. §§ 216B.03 and 216B.07 by imposing bespoke surcharges on similarly situated customers.
- **Clarifications to ICT:** N/A — DCC recommends rejecting the ICT.
- **Relationship to future rate cases:** Direct Xcel to demonstrate in all future rate cases that rates paid by the large customer class or subclass cover the full cost of service, including incremental costs, embedded system costs, and rider costs, and do not result in cross-subsidies between customer classes.
- **Future updates and reporting:** Require Xcel to conduct a class cost of service study (CCOSS) for the large customer class or subclass in each future general rate case.

Key Terms / Rate Design:

- **Size Threshold:** Approve Xcel’s proposal to apply the Large General Time of Day Service and Large Peak Controlled Time of Day Service to all new customers with demand over 100 MW, based on customer demand and not load factor or business type.
- **Term Length:** Establish a minimum ESA term of ten years, plus a separate load ramp period of up to five years (the “10+5 construct”). Reject calls to require ESA terms exceeding fifteen years.
- **Customer Charge, Demand Charge, Energy Charge:** Clarify that the minimum bill provisions in both tariffs apply only to demand charges and not to energy charges. Clarify that the minimum bill provision of the Large Peak Controlled Time of Day Service applies only after the load ramp period has concluded; bills during the load ramp period should be based on actual demand.
- **Changes in Contract Demand:** Allow large customers to assign their ESAs by right if the assignee (i) has an equal or better credit rating, (ii) has a guarantee from a parent with an appropriate credit rating, or (iii) is taking on the ESA through a merger or consolidation with an equal or better credit rating. Require Xcel to respond to a notice of assignment within 30 days. Direct Xcel to provide an optional 12-month bridge period after the 24-month notice period, during which a customer would continue to pay minimum bills before paying any remaining exit fee or capacity reduction fee.
- **Exit Fee:** Define the Termination Fee Period as the lesser of 36 months or the remaining months in the ESA. Reject calls to extend the exit fee period or capacity reduction fee period to the full remaining term of the ESA. Require Xcel to mitigate exit fees and capacity reduction fees for the entire duration of the fee period, not only for 24 months. Require Xcel to reimburse a customer for the value of successful mitigation efforts for the entire duration of the fee period. Reject calls to impose an exit fee or capacity reduction fee upon nonrenewal of an ESA at the end of its term.
- **Minimum Bill:** The minimum bill, exit fee, and capacity reduction fee should remain based on 75 percent of contract capacity. Reject calls to increase these fees to 85 percent of contract capacity or higher.

Class Cost of Service

- **Definition of a Class or Subclass:** Confirm that the large customer class or subclass is defined based on customer demand (over 100 MW), and not based on load factor or business type.
- **Cost Attribution:** Direct Xcel to directly assign the costs of dedicated facilities (e.g., interconnection facilities) to the customer that benefits from them. Direct Xcel to assign the costs of shared system resources to the large customer class or subclass through a CCOSS in a rate case, not through customer-specific surcharges.

- **Creation of a separate customer class:** DCC takes no position on whether large customers should be designated a separate class or a subclass. Regardless of designation, large customers should be treated as a collective group for cost allocation purposes, with costs assigned to the large customer class or subclass as a whole and not on a customer-by-customer basis.
- **Class cost allocators:** Direct Xcel to conduct a class cost of service study for the large customer class or subclass in each future general rate case to ensure that the rates paid by large customers cover the full cost of service. Reject Xcel’s proposal to aggregate multiple customer premises for the sole purpose of subjecting a customer to the incremental cost test. If the Commission approves any aggregation of customer premises, direct Xcel to aggregate the measured demand of all aggregated premises for purposes of determining whether the minimum bill applies.

Regulatory Compliance

- **IRP Order:** Find that Xcel’s incremental cost test proposal is inconsistent with the IRP Order, which directed Xcel to ensure that all incremental costs attributable to large customers are assigned to the large customer class or subclass — not on a customer-by-customer basis.
- **Minn. Stat. § 216B.1622:** Find that the best method for ensuring all costs attributable to large customers are assigned to the large customer class or subclass, as required by Minn. Stat. § 216B.1622, subd. 2(1), is through general rate cases using class cost of service studies.
- **Compliance with other relevant statutes:** Find that Xcel’s incremental cost test proposal is inconsistent with Minn. Stat. §§ 216B.03 and 216B.07 because it results in rates that are not consistent in application to the large customer class or subclass and subjects customers to unreasonable prejudice or disadvantage. Find that Minn. Stat. § 216B.72 already requires large data center customers to subsidize low-income energy programs through annual fees and, as a result, no additional cross-subsidy mechanism is warranted.

Clean Energy and Demand-Side Management

- **Behind the Meter Generation / Bring Your Own Generation:** Direct Xcel to clarify that, except for resources procured through a tariff under Minn. Stat. § 216B.1623, large customers will be served by system resources and not by specific, identifiable generation resources dedicated to individual customers.
- **Interconnection issues (e.g., fast lane, queue management):** Direct Xcel to explore reducing time to power for large customers that support clean energy and other flexibility arrangements, on a voluntary basis. Any prioritization benefits for flexible or clean energy customers should apply regardless of whether the supporting resources are located onsite, adjacent to the customer’s premises, or elsewhere in Xcel’s service territory.

- **CFE Procurement Program:** Direct Xcel to begin stakeholder discussions to develop the voluntary clean energy and capacity tariff required by Minn. Stat. § 216B.1623. Reject calls to establish a minimum load control threshold for the Large Peak Controlled Time of Day Service; load control events should be called based on cost and reliability needs.

Procedural Issues and Reporting Filings

- **Filings for future rate cases:** Direct Xcel to file a class cost of service study for the large customer class or subclass in each future general rate case.
- **Filings in this docket:** Direct Xcel to file each ESA with the Commission for approval and to include, as a separate document accompanying the ESA filing, information on the anticipated socioeconomic benefits of each new large customer, including estimated construction and permanent jobs. Clarify that such socioeconomic information is for informational purposes only and will not influence approval or denial of any particular ESA.
- **Other procedural issues:** Clarify that any determination by Xcel to aggregate multiple customer premises is subject to Commission review at the request of the affected customer(s). Clarify that Xcel must accept guarantees from qualified creditworthy third parties — including customers and tenants — not only from parent companies, to satisfy the ESA's collateral and security requirements.
