On July, 12 2019, Buffalo Ridge Wind, LLC (the “Applicant”) filed an Application for a Certificate of Need (“CON”) for a Large Energy Facility with the Minnesota Public Utilities Commission pursuant to Minnesota Statutes, Section 216B.243, subdivision 2. The Applicant is requesting a CON for the construction and operation of an up to 109.2 MW Large Wind Energy Conversion System to be located in Lincoln County, Minnesota. The Applicant and Great River Energy (“GRE”) have entered into a power purchase agreement pursuant to which GRE purchase the full output of the project for a 25-year term, serving as a significant renewable generation addition to assist GRE in meeting and exceeding its Renewable Energy Standard requirements and its own voluntary goals.
