PETITION

Minnesota Municipal Power Agency ("MMPA") respectfully petitions the Minnesota Public Utilities Commission (the "Commission") for approval of a variance to the Commission's Utility Resource Planning Rules.

Pursuant to Minn. R. 7829.3200, MMPA requests a variance to Minn.R. 7843.0300, Subp. 2 ("Filing Requirements and Procedures") to allow MMPA a one-year delay to August 1, 2018, to file its Integrated Resource Plan (IRP). MMPA requests additional time to submit its Integrated Resource Plan because several additional months are necessary to identify and plan MMPA's next energy resource in sufficient detail to include in its Integrated Resource Plan. That next resource will be a Large Energy Resource and is likely to be in service before MMPA files its subsequent IRP. When MMPA files its IRP on August 1, 2018, if the variance is granted, MMPA intends to combine the Certificate of Need for the planned Large Energy Resource with its IRP filing pursuant to M.S. 216B.2422, Subd. 6.

IV. DESCRIPTION AND PURPOSE OF FILING

A. Background

Minnesota Municipal Power Agency is required to file with the Commission an Integrated Resource Plan (IRP) every two years pursuant to Minn. R. 7843.0300. MMPA filed its third IRP on December 20, 2013, which covered the period 2014-2028 and was accepted by the Commission on February 10, 2015 in Docket No. ET-6133/RP-13-1165.

B. Applicable Law

Pursuant to Minn. R. 7843.300, MMPA's next IRP is due on August 1, 2017 (2017 IRP).

C. Requested Action

MMPA respectfully requests a variance of twelve months, until August 1, 2018, to file its next IRP. As discussed below, MMPA believes its request satisfies the requirements for granting a variance established under Minn. R. 7829.3200.

1. Enforcement of the Rule Would Impose Excessive Burden

MMPA has undertaken the planning of its next major Large Energy Resource. At this juncture, MMPA is still in the process of evaluating possible resource options. Once the potential resource is identified, numerous and detailed planning activities will be undertaken. MMPA reasonably believes that these evaluation and planning processes will take several months. Stopping those critical evaluation and planning processes to prepare an IRP by August 1, 2017, would be an excessive burden on MMPA's limited planning resources, possibly delaying MMPA's next resource. Given MMPA's staffing limitations, MMPA believes that the most prudent approach to both the IRP process and the planning of MMPA's next major resource would be granting a variance to MMPA until August 1, 2018, so MMPA can complete the planning of its next major resource and prepare a combined IRP and Certificate of Need application for filing on August 1, 2018.

2. Granting a Variance Will Not Adversely Affect the Public Interest

The public interest will not be adversely affected by granting MMPA a twelve-month variance to file its IRP. An IRP is only beneficial when its planning is accurate. MMPA's long range planning is changing significantly at the present time with the planning for the addition of a Large Energy Resource. MMPA is concerned that if required to submit its IRP by August 1, 2017, it could not provide the most thorough and accurate resource plan. MMPA believes its resource planning process and the public interest would be better served by allowing MMPA a twelve-month extension to allow sufficient time to plan the next resource and prepare a combined IRP and Certificate of Need application for filing on August 1, 2018.

3. Granting a Variance Will Not Conflict with Standards Imposed by Law

Granting the variance will not conflict with standards imposed by law. The two-year requirement is imposed by Commission Rule, Minn. R. 7843.0300. The Commission's rules permitting variances contemplate variances under circumstances such as those presented here. The Commission granted a one-year variance in 2010 stating that granting the variance would not conflict with the standards imposed by law. See Docket No. ET-6133/RP08-927, Order Accepting Resource Plan, Granting Variance, and Setting Further Requirements, at p.3 (June 28, 2013). MMPA submits that its changing resource mix warrants a twelve-month variance here.

V. CONCLUSION

For the reasons stated herein, MMPA respectfully requests that the Commission grant a twelve-month variance until August 1, 2018, to MMPA for the filing of its fourth IRP in a combined CON/IRP application.
