On behalf of Boise Paper (Boise), a Packaging Corporation of America (PCA) company, formerly known as Boise, Inc., I respectfully submit this letter in support of Minnesota Power's (MP) November 25, 2013, Petition for Approval of an Amendment to the Electric Service Agreement between Boise, Inc. and Minnesota Power in the above-referenced docket.

Boise strongly supports MP's petition in this docket and specifically, the request to have the 2013 Amendment to the Electric Service Agreement between Boise and Minnesota Power ("Amendment") effective January 1, 2014. In addition, we endorse the December 24, 2013 comments of the Minnesota Department of Commerce recommending approval of the Amendment and expedited processing of the Petition, so that the Amendment can become effective on January 1, 2014.

The International Falls, Minnesota, paper mill is an important and integrally linked economic asset for both the company and the International Falls Community. We provide more than 580 jobs and support hundreds of secondary jobs in Minnesota's timber harvesting and multiple supplier industries. As the largest employer in Koochiching County, the mill is vital to the economy of Northern Minnesota. Unfortunately, we down-sized our International Falls mill operation last year due to competitive pressures in the North American office paper market.

The Amendment adjusts Boise's energy purchases from MP to reflect the recent downsizing at the mill. The Amendment "right-sizes" the power supply from MP to fit the new operating characteristics at the mill.

Energy costs are a major driver of mill production costs and controlling these costs is critical to maintaining our competitive industry position. More importantly, the

Amendment assures a long-term, reliable, competitively priced energy supply to allow Boise to make a ten-year power purchase commitment to MP. This benefits MP's ratepayers and shareholders.

MP and Boise have worked diligently over the past year to craft an Amendment that meets our long-term power supply needs and the financial needs of MP and its ratepayers. Some of these attributes include:

- The Amendment assures MP and its ratepayers that Boise will purchase all of its energy needs from MP through December 31, 2023, without a right of early termination. Without this Amendment, Boise had a two-year right of termination.
- The Amendment requires Boise to make a firm purchase of capacity from MP, on a take-or-pay basis, for the ten-year period, subject to the ability of Boise to reduce demand based on cessation of #3 paper machine or a permanent mill shutdown.
- If Boise is able to further reduce demand through conservation and energy efficiency improvements at the mill, MP and Boise will, in good faith, discuss how this may require additional changes to the Amendment.
- Boise will now be making weekly pre-payments of their estimated bill to MP, with true-ups after the fact.

We urge the Commission to approve MP's Petition for Approval of Amendment and the request for expedited consideration, as this Amendment will have a significant and positive impact on our competitive position in national and international white paper markets, which also benefits MP and its ratepayers.

We are available to answer any questions or otherwise assist the Commission in processing the Petition, in order to timely approve the Amendment, and thank you for your consideration.
