Dear Customer:

This letter provides an update as to your electric service provider. As you may know, the Hawley Public Utilities Commission (“Hawley”) has reached an agreement with Wild Rice Electric Cooperative, Inc. (“Wild Rice”) in which Hawley will permanently provide electric service to certain customers. By agreement of the utilities, Hawley is currently providing your electric service.

In the meantime, the utilities are in the process of formally updating the electric service maps on file with the Minnesota Public Utilities Commission (MPUC) to reflect the change in assigned electric service territory. This letter provides information concerning that MPUC proceeding.

The MPUC is a state agency with jurisdiction over electric service territory boundaries. The MPUC requires that all customers located in an area involved in a change in the service territory maps be formally notified of the proceeding in which the service territory maps will be approved. This letter provides that formal notice.
