Snowshoe BESS, LLC (Snowshoe BESS) respectfully submits these reply comments regarding the completeness of its Application for a Site Permit (Application) for a battery energy storage system (BESS) with a nominal power rating of up to 150 megawatts alternating current with approximately 600 megawatt-hours of energy capacity known as the Snowshoe Energy Storage Project in Kalmar Township, Olmsted County, Minnesota (Project).

Specifically, Snowshoe BESS responds to initial comments filed by the Minnesota Department of Commerce, Energy Environmental Review and Analysis (DOC-EERA), International Union of Operating Engineers Local 49 and the North Central States Regional Council of Carpenters (IUOE and NCSRC of Carpenters), and the Minnesota Department of Agriculture (MDA).

DOC-EERA

Application Completeness.

DOC-EERA filed comments dated October 25, 2024. Snowshoe BESS appreciates DOC-EERA staff's thorough review of the Application and comments on this process going forward. DOC-EERA staff recommended the Minnesota Public Utilities Commission (Commission) accept the Application as substantially complete.

Advisory Task Force.

Snowshoe BESS agrees with DOC-EERA staff that an advisory task force is not warranted. Therefore, the Commission should decline to appoint an advisory task force.

Application Review Process.

Snowshoe BESS agrees with DOC-EERA staff's recommendation that the matter should be referred to the Office of Administrative Hearings (OAH) for a public hearing and preparation of a full administrative law judge report with recommendations.

IUOE and **NCSRC** of Carpenters

IUOE and NCSRC of Carpenters filed comments dated October 24, 2024 regarding its desire to maximize job benefits for local workers. Although the comments did not discuss Application completeness, Snowshoe BESS appreciates the comments of IUOE and NCSRC of Carpenters and looks forward to further discussions related to the Project and the use of local workers.

MDA

MDA filed comments dated October 24, 2024. Although the comments did not discuss Application completeness, MDA recognized that the Project is the first stand-alone BESS to come before the Commission and explained MDA's desire to collaborate with Snowshoe BESS to develop an appropriate plan to address potential impacts to agricultural land resulting from construction, operation, and decommissioning of the Project.

On October 29, 2024, Snowshoe BESS met with MDA to discuss the Project and its potential impacts to agricultural land that may need to be addressed by mitigation or management measures. During this meeting MDA clarified that its October 29, 2024 comments were not meant to indicate the Application is not complete. Rather, MDA indicated its comments were intended to convey that appropriate agricultural mitigation measures should be developed by Snowshoe BESS and MDA during the permitting process. Snowshoe BESS appreciates MDA's comments and commits to working with MDA, throughout the site permit process, to develop appropriate agricultural impact mitigation measures for the Project.

Conclusion.

Snowshoe BESS respectfully requests that the Commission find the following:

- 1. Accept the Application as substantially complete and authorize review of the Application under the alternative permitting process under Minn. Stat. § 216E.04 and Minn. R. 7850.2800 to 7850.3900;
- 2. Find that an advisory task force is not warranted; and
- 3. Refer the matter to the OAH for a public hearing and preparation of a full administrative law judge report with recommendations.

Given there has been no comment indicating Application is incomplete, this matter appears ready for consideration by the Commission and could be considered by consent calendar.
