1. 2015 Conservation Improvement Project ("CIP") tracker account, resulting in a December 31, 2015 tracker balance of \$4,333,061;
2. Financial incentive of \$4,257,105 for Otter Tail's 2015 CIP achievements;
3. Conservation Cost Recovery Adjustment of \$0.00275/kWh with an effective date of October 1, 2016;
4. Proposal to be granted a variance to Minnesota Rules part 7820.3500(K) and part 7825.2600 for one year after the issue date of the Commission's Order in the present docket.
